## 1. Clarification of Scope following walkthrough:

#### Evaluation:

Services are limited to the two stairwells, the approximate 3-story stairwell in the Residential Stairwell (West Tower) and the approximate 5-story stairwell in the Standpipe Stairwell (East Tower), specifically to address the structural condition of concreate filled steel stairs, stringers, and landings and update handrails and guardrails as required to meet current OSHA standards. Evaluation will investigate the existing conditions and provide recommendations for improvements with approximate construction costs and priorities associated with the recommendations.

### Design:

Based on the investigation and recommendations, the design effort will prepare plans and specifications for improvement items selected in coordination with the City of Fairbanks.

#### Construction:

- Review contractor construction submittals
- Answer contractor questions during construction.

- Provide up to (3) on-site progress inspections.
- Special Inspections will be contractor's responsibility.
- Attend (1) on-site Final inspection.

Due to the varying nature of providing construction support, provide a copy of hourly rates that will be used to establish a Time & Expense contract for those services.

- i. Submit a 65% design for review and comment by City, including the following
  - 1. Design Drawings
  - 2. Narratives
  - 3. Specifications
  - 4. Cost Estimate
- ii. Submit a 95% design for review and comment by City, including the following:
  - 1. Design Drawings
  - 2. Specifications
  - 3. Cost Estimate
- iii. Submit a Final design to the City for advertisement, including the following:
  - 1. Design Drawings
  - 2. Specifications
  - 3. Cost Estimate
- 3. Is the City able to provide the successful bidder as-built drawings of the building?
