FAIRBANKS CITY COUNCIL REGULAR MEETING MINUTES, DECEMBER 2, 2019 FAIRBANKS CITY COUNCIL CHAMBERS 800 CUSHMAN STREET, FAIRBANKS, ALASKA

The City Council convened at 6:30 p.m. on the above date, following a 5:30 p.m. Work Session with the Interior Delegation to discuss the City's Legislative Priorities, to conduct a Regular Meeting of the Fairbanks City Council at the City Council Chambers, 800 Cushman Street, Fairbanks, Alaska, with Mayor Jim Matherly presiding and with the following Council Members in attendance:

Ms. Therrien, seconded by Mr. Pruhs, moved to EXCUSE Mr. Gibson's absence.

Mayor Matherly called for objection, and hearing none, so ORDERED.

City Clerk Danyielle Snider read the Mission Statement of the City of Fairbanks.

INVOCATION

The Invocation was given by City Clerk Danyielle Snider.

FLAG SALUTATION

Mayor Matherly asked everyone to join him in the Pledge of Allegiance.

CEREMONIAL MATTERS

Mayor Matherly spoke to the sacrifices that police officers make when they decide to serve their community, and he thanked them for their service. He asked the three new police officers, Trevor

Norris, Ryan Gillogly, and Nicholas Flechsing, to come forward for their oaths of office. **Mayor Matherly** welcomed the officers to the City of Fairbanks and administered their oaths.

CITIZENS' COMMENTS

Alex McDonald, 1215 Lance Lane, Fairbanks – Mr. McDonald spoke to Ordinance No. 6119 relating to a tax on vaping products. He stated nicotine and caffeine are very similar chemically as they are both mild stimulants. He spoke against taxing vaping products and encouraged the Council to watch the video he provided for each member. Mr. McDonald stated if the tax passes it will likely put him out of business, and he requested that more research be done before a tax is passed. He stated when Governor Walker tried to tax the products, the legislature questioned the reasoning behind the tax, and they came up with no good reason other than a big money grab.

Ms. Kun asked Mr. McDonald whether anyone from the Council came to speak to him about the tax; Mr. McDonald stated nobody had. He asked whether non-nicotine products would be included in the tax.

Ms. Therrien asked Mr. McDonald whether all his products contained nicotine. Mr. McDonald stated many of his products contain no nicotine, and he spoke to the different products he sells in his shop.

Mr. Cleworth stated he was surprised his products were not included in the tax. Mr. McDonald explained that he does not sell big tobacco products. He explained the difference between his products and tobacco-derived products. He stated he supports local businesses, and the product he sells is healthier than tobacco products.

<u>Eric Vargason, 2360 Outside Boulevard, North Pole</u> – Mr. Vargason stated he is opposed to the tax because vaping saved his life. He spoke in support of the brick and mortar businesses and stated that vaping is healthier than tobacco.

Mr. Cleworth asked whether someone could purchase tobacco online from another country and avoid the tobacco tax. Mr. Vargason stated he did not know. He stated vapor allows him to get nicotine without the tar and toxins that come along with tobacco.

Roger Gurney, 1100 Hoselton Road, Fairbanks – Mr. Gurney stated he was a two-pack-a-day smoker, and his health has improved dramatically since he began vaping. He stated the vaping product is a lot like caffeine and asked if the Council was going to start taxing caffeine. He stated it seems like the Council is trying for a money grab, and it puts small businesses under economic strain.

Ms. Kun stated she loved the idea of taxing coffee and asked Mr. Gurney if he would go online to purchase coffee products if it was taxed locally. Mr. McDonald stated he would go online.

Greg Foster, P.O. Box 70935, Fairbanks – Mr. Foster stated he would like to address some misinformation that was given at the last City Council meeting. He asked all Council Members to do a ride-along with a police officer to better understand the work of an officer. He stated officers have to make split-second decisions, and they encounter many issues on a daily basis. He stated it is too easy to dismiss staffing issues by blaming a change in leadership or other things, instead of the large volume of work that officers deal with on a daily basis. Mr. Foster stated there are 38 employees at the Fairbanks Police Department (FPD), and he gave a breakdown of staff and ranks. He stated FPD

needs more funding and more officers as there is not enough staff to fill shifts every day. He stated he wears a bulletproof vest every day and carries a weapon because his job is that risky. Mr. Foster stated if an officer's verbal skills are not up to par, they will not be able to talk someone down who is in crisis; he stated that the new officers would be finding that out very soon. He stated it bothers him when people dismiss how dangerous a police officer's job is; he stated he has lost four good friends in the profession. He again encouraged the Council to go on a ride-along so they can make a more informed decision.

Mr. Cleworth asked Mr. Foster what it was that made him come forward with his testimony. Mr. Foster stated it was reported that FPD staff was at 45 employees, but it is only 38. He stated exit interviews prove that officers are tired of forced overtime, causing them to leave the department. He stated everyone works on their days off, and everyone is burning out. **Mr. Cleworth** stated it was his understanding that overtime was not forced. Mr. Foster stated it is not forced under Chief Reeder. He explained how short-staffed the department is and how far behind everyone is on case work. He stated officers are going from call to call, and there is no time to process paperwork. He stated that even supervisors take calls, and that is not how it should be.

<u>David van den Berg, 332 Slater Drive, Fairbanks</u> – Mr. van den Berg spoke to Ordinance No. 6119, specifically about putting money into the Capital Fund. He stated that people in his neighborhood shovel their driveways into City streets, which he understands is not allowed; he stated, however, that the rule is not enforced. He stated he was told that downtown streets would be cleared Wednesday or Thursday, which is just in time but too late for comfort. He stated City services should be delivered when needed. He stated the 2020 budget does not appear to fund City services on time but rather when absolutely necessary.

<u>Alyssa Keill, 641 Steele Creek Road, Fairbanks</u> – Ms. Keill spoke in support of taxing vaping products. She stated she is a swim coach, and vaping is not healthy for youth. She stated raising prices helps keep youth from accessing the products because they have limited funds.

<u>David Hayden</u>, 147 3rd Avenue, <u>Fairbanks</u> – Mr. Hayden echoed Mr. van den Berg's sentiment about the "just-in-time" City services. He stated that his road was just cleared earlier in the morning. He stated the roads are bad this year, and it would be nice if the City was more proactive with snow removal. He stated he spent the evening with a friend who was waiting for an officer to respond to a break-in call on 5th Avenue. He spoke of the public safety issues in the Clay Street Cemetery neighborhood and stated it feels like a lawless area.

Mr. Cleworth asked Mr. Hayden whether he was speaking about the dead-end area of 5th Avenue. Mr. Hayden replied affirmatively. He stated that he has even filed air quality complaints because his neighbor burns tires.

Ms. Kun thanked Mr. Hayden for attending and asked whether he turns statements in to the police when he witnesses things going on in his neighborhood. Mr. Hayden stated he has called the police many times. **Ms. Kun** stated he should grab a stack of incident reports from FPD to share with his neighbors. Mr. Hayden stated calling into Dispatch is sufficient and that filing a report would create even more paperwork for overworked police officers.

Ms. Rogers asked if the police always respond to calls in the neighborhood. Mr. Hayden stated he believes the police are very busy, and they cannot run every time a gunshot is reported. He stated the

abandoned home in the neighborhood attracts a criminal element that goes unchecked. **Ms. Rogers** stated she can understand the frustration with the property and asked whether there is a time when there is more activity at the property. Mr. Hayden stated there is no way to put a gauge on the time of the activity. He stated that if a home is reported on consistently, the property owner should be fined as an incentive to clean up the location.

<u>Victor Buberge, P.O. Box 58192, Fairbanks</u> – Mr. Buberge stated he got stuck in the snow on Noble Street off Gaffney Road because snow removal is so terrible this year. He stated the excuse last year for poor snow removal was equipment failure, and he asked whether that is the same reason for the problem this year. He stated the roundabouts behind Costco are dangerous and that vehicles slip and slide because there is no maintenance. Mr. Buberge stated the roundabouts on the Southside are a joke also because they have to figure out how to plow around them. He asked how the City could claim to be broke when so much money is spent on roundabouts. He asked if the Council's solution to snow was to wait for the summer sun to melt it; he stated that clearing snow once a year is not a good policy. He stated he expects someone on the Council to speak about why snow removal is so slow this year.

Mike Farrell, P.O. Box 71004, Fairbanks – Mr. Farrell stated he drives a compact car, and he never remembers hearing the sound of dragging around snow when driving downtown before. He stated he has a truck too, but he does not want to get it out. He stated that temporary employees should be getting the snow cleared. He stated the Mayor should make snow removal a top priority because the roads are not safe as they are. He asked for an update on the nuisance ordinance that was discussed at a prior City Council meeting.

Hearing no more requests for comment, Mayor Matherly declared Citizens' Comments closed.

Mayor Matherly called for objection to APPROVING the Agenda, as Amended, and, hearing none, so ORDERED.

City Clerk Snider read the Consent Agenda, as Amended, into the record.

Mr. Pruhs, seconded by **Ms. Therrien**, moved to WAIVE PROTEST on the Liquor License Applications for Renewal.

Mayor Matherly called for comment and, hearing none, declared Public Testimony closed.

Ms. Therrien stated The Spur has many calls, and she would like to hear more about them.

Mayor Matherly stated not much has changed since it was Kodiak Jacks; he asked Lieutenant Greg Foster to come forward for a staff report. Lt. Foster stated he has come in to work many Monday mornings and learned what happened at The Spur over the weekend. He stated that crimes often occur over the weekend at that bar. He stated that the time of the report could indicate the time a report was filed, not the time of the incident. He gave a brief explanation on the different types of incidents listed in the call-out report and stated that an "SI" is a self-initiated visit by an officer. Lt. Foster stated that the most concerning calls are the disturbance calls, and he spoke to the shortcomings of the data in call-out reports. He stated that some of the calls listed may have nothing to do with the liquor license. He explained that some of the incidents listed with a "RPT" means there was a report generated, and that could be for an event like an altercation.

Mayor Matherly asked if anyone from The Spur was in attendance and would like to speak.

Ms. Rogers expressed disappointment that no one from The Spur was present. She stated there is a disturbing number of calls made to the location, and it should be handled with swiftness. Lt. Foster stated he always knew there would be problems on weekend nights at The Spur so he would direct his officers to be in close proximity to readily mitigate potential crimes. He spoke at length about issues he viewed as potential problems with The Spur.

Ms. Kun asked what "SI – Flag Down" means. Lt. Foster stated it means someone waived an officer down.

Mayor Matherly stated that when he did a ride-along, they did a walk-through at the bar, and it was crazy inside. He expressed concern about issues between the location and the military base. Lt. Foster stated that military personnel deserve to blow off steam, and FPD would like to encourage them to do it in a safe and orderly manner. **Mayor Matherly** stated that whole intersection is a problem, and it has been dating back to when the Grey Hound Lounge was located there.

Mr. Cleworth asked how the "no protest" was determined by FPD; Lt. Foster stated that typically FPD administration makes a recommendation with input from command staff. Clerk Snider stated that Deputy Chief Welborn sent the "no protest" response to the Clerk's Office.

Mr. Pruhs, seconded by **Ms. Therrien**, moved to DIVIDE THE QUESTION by voting on the two Liquor License Applications for Renewal separately.

Mayor Matherly called for objection, and hearing none, so ORDERED.

A ROLL CALL VOTE WAS TAKEN ON THE MOTION TO WAIVE PROTEST ON THE FUSHIMI LIQUOR LICENSE APPLICATION FOR RENEWAL AS FOLLOWS:

Mayor Matherly declared the MOTION CARRIED.

Mr. Cleworth reminded everyone that the Council's vote on liquor license renewals is advisory-only, and the state has the final say.

Ms. Therrien stated she counted 25 reports made from the calls in the list for The Spur. She stated there are 17 self-initiated calls and 7 traffic stops.

Mr. Pruhs stated the ongoing, violent nature of incidents at The Spur have not been addressed in a satisfactory manner to the City Council.

Ms. Kun stated City resources are being exhausted when officers are repeatedly called to The Spur because a safe and responsible environment is not being promoted.

Mr. Pruhs, with the concurrence of the Second, WITHDREW the motion to WAIVE PROTEST on The Spur Liquor License Application for Renewal.

Mr. Pruhs, seconded by **Ms. Therrien**, moved to PROTEST The Spur Liquor License Application for Renewal due to a demonstrated inability to put citizens in a safe environment and due to law enforcement feedback that the establishment exhausts City resources.

Ms. Rogers thanked Mr. Mahi for attending and speaking. She asked him to share more. Mr. Mahi stated he has been in Fairbanks since the 1990s, and he and his partners purchased the Alaska stores.

Hearing no more requests for comment, **Mayor Matherly** declared Public Testimony closed.

MAYOR'S COMMENTS AND REPORT

a) Special Reports

<u>Scott McCrea</u>, <u>Fairbanks</u> – Mr. McCrea stated he works for Explore Fairbanks, and he spoke to destination marketing in the Asia travel market. He spoke to the tourism industry in Fairbanks and to partnerships in China and Europe. He thanked the City Council for reinvesting bed tax dollars into destination marketing.

Mayor Matherly stated he is paying attention to problem with nuisance properties in the downtown area, and he and his staff are working on it. He stated that folks should be aware that police cannot just barge into an occupied home. Mayor Matherly acknowledged the frustrations with snow removal. He stated that he takes an issue with what he thought he heard from the Downtown Association earlier that snow is not being cleared for political reasons. He stated the City is doing its best with snow removal, but there are some budget- and personnel-related challenges. Mayor Matherly stated there will be a tree lighting ceremony outside of City Hall on Friday, and there will be hot chocolate and coffee; he added that Santa Claus will be present. Mayor Matherly thanked those who attended to speak about the vaping ordinance.

COUNCIL MEMBERS' COMMENTS

Mr. Cleworth mentioned snow removal issues and stated he would address the issue more during the discussion on Ordinance No. 6117. He stated that neighbors have submitted video surveillance showing a high traffic volume at the problem property previously discussed. He spoke of similar issues that occurred at Fairview Manor many years back and to how charging them for calls for service helped solve the problem. **Mr.** Cleworth stated that something needs to be done with the ice build-up around manhole covers in the downtown area.

Mr. Pruhs congratulated the new officers who took their oaths of office earlier in the meeting and thanked Lt. Foster for speaking. He stated he sent Chief Reeder and the Mayor information about a ride-along because he is interested in what the police do. **Mr. Pruhs** asked the Council to look deeper into repeated issues when it comes to liquor licensing.

Ms. Therrien thanked Mr. McDonald for attending and speaking to the vaping issue; she stated she would try to stop by his store to gather more information. She congratulated the new police officers. She stated she is unsure whether Lt. Foster believes the Council does not support the FPD and expressed hope that nothing she said that makes him believe that.

Ms. Rogers thanked everyone for attending and thanked Lt. Foster for speaking about the liquor license. She stated it is disappointing to see that there have been no changes in behavior. She thanked everyone who testified and shared that she values what people have to say. She stated no good comes from getting angry with each other and that snow is a problem across the nation.

Ms. Kun stated she would be going on a ride-along with a police officer. She cautioned everyone to drive safely on Cushman Street due to poor road conditions.

Ms. Therrien, seconded by **Mr. Cleworth**, moved to APPROVE Resolution No. 4897.

Mr. Pruhs declared a conflict of interest. He stated he would not weigh in on Resolution No. 4897 because his brother, Dana Pruhs, is a member of the Alaska Industrial Development and Export Authority (AIDEA) Board. No members objected to Mr. Pruhs' request for abstention.

<u>Dan Britton, Fairbanks</u> – Mr. Britton stated he gives regular updates to the Borough Assembly, and he will try to include the City Council. He stated the resolution is exciting because it is a step in the right direction in completing the Interior Energy Project. He stated the tank being constructed will hold 5.25 million gallons of natural gas.

Mr. Cleworth stated he knows the administration has been working on snow removal issues and that he was hoping they could find \$50,000 somewhere in the budget to put toward snow removal. He asked Public Works Director Jeff Jacobson whether he could use extra snow removal funds.

Mr. Jacobson stated that after speaking with Mr. Cleworth earlier that morning, he spoke with Street Supervisor Eric Grant. He shared that they are looking into extending the work week through Fridays and Saturdays during December.

As is part of my usual process, I reached out to the FNSB Department of Community Planning in early January and requested buffer zone, GIS overlay, and other zoning permit information to include with this packet. I have received no response, so I've included a page from a report published by the FNSB showing that a conditional use permit was approved in 2019 for this marijuana product manufacturing facility.

Per the Council's request, the Police Department has included a call report for the license location.

The Building and Fire Departments are recommending protest of the license until a Certificate of Occupancy is issued. There are no other departmental objections to the issuance of this license.

Zoning

A "marijuana product manufacturing facility, unlimited" is a listed conditional use in the Light Industrial (LI) zoning district pursuant to FNSBC 18.72.020(B)(5). Conditional use permit #2019-006 was approved in February 2019 to use 1,184 square feet (SF) of an existing building for this use. The permit was updated in January 2020 to add 3,010 SF for a total of 4,194 SF.

This was based on a State Alcohol and Marijuana Control (AMCO) requirement for "contiguous premises." There was no change to the manufacturing processes, chemicals used, or production output proposed. The change in area designated for manufacturing is located within the original building envelope and has no exterior impacts.

The change in square footage was determined <u>not</u> to require an amendment to the conditional use permit [FNSBC 18.104.050(D)]. Please see the attached letter to the permittee.

Buffers

The proposed facility is not located within any known sensitive use buffers for commercial marijuana establishments listed in FNSBC 18.96.240(A)(3).

Dear Mr. Peters and Business Services of Alaska, LLC:

On January 13, 2020, you submitted a letter and floor plan to the Fairbanks North Star Borough (FNSB) Department of Community Planning, in association with an update to your state Marijuana Manufacturing License (#14874). The Department has reviewed these documents and has determined that the modification to the floor plan falls within the parameters of Condition #3 of your conditional use (CU2019-006), and an amendment to your Conditional Use is not required at this time.

Condition 3 states that "If any modifications are made to the site plan, floor plans, or other FNSB required documents or operational characteristics, the applicant or holder of this conditional use permits shall submit revised documents to the FNSB Community Planning Department. If modifications are made to the conditional use, an amendment to the Conditional Use Permit may be required pursuant to FNSBC 18.104.050(D)."

The decision by the Department was based on the following factors:

- 1. Business Services of Alaska, LLC submitted a signed letter (**Attachment 1**) and floor plan (**Attachment 2**) for the expansion of sq. footage for the existing "marijuana product manufacturing facility, unlimited", to add 3,010 sq. ft. to the existing 1,184 sq. ft., bringing the total square footage to 4,194 sq. ft.
- 2. The request to expand the square footage is due to a state (Alcohol and Marijuana Control Office) requirement that the floor space of the marijuana product manufacturing facility have "contiguous premises," and is not an expansion of actual used floor space, as described in your letter.

- 3. The applicant has stated that the manufacturing processes and chemicals utilized will not change, nor will the production output.
- 4. No material change to the production or utilized floor space will occur.

Dear Mr. Peters and Business Services of Alaska, LLC:

At its regular meeting of February 12, 2019, the Planning Commission of the Fairbanks North Star Borough considered your request for conditional use approval of a marijuana product manufacturing facility, unlimited in the Light Industrial (LI) zone on NE¼ and SE¼ of Block 17, Subdivision of E.M. Jones Homestead (located at 2604 Davis Road, on the north side of Davis Road, west of Peger Road).

The Commission voted six (6) in favor, zero (0) opposed, to **approve** your request and adopted the Staff Report, and the following Conditions and Findings of Fact in support of its decision:

CONDITIONS

- 1. Prior to the commencement of marijuana product manufacturing operation, the applicant or holder of this conditional use permit shall comply with all applicable land use related laws. Applicable permits and approvals may include but are not limited to:
 - a. As required by the FNSB and the Department of Commerce, Community, and Economic Development (Alcohol and Marijuana Control Office), the applicant or holder of this conditional use permit shall ensure the site and operation meets all licensing requirements for a commercial marijuana product manufacturing facility.

- b. The applicant or holder of this conditional use permit shall obtain a formal plan review by the City of Fairbanks Building and Fire Departments and shall comply with all recommendations and/or requirements resulting from the plan review(s).
- c. The applicant or holder of this conditional use permit shall obtain a formal plan review by the State of Alaska Department of Environmental Conservation for the proposed use of a septic system for non-domestic wastewater discharge; and shall comply with all recommendations and/or requirements resulting from the plan review.
- 2. Indoor product manufacturing rooms or portions of the building where marijuana or marijuana products will be prepared, processed, packaged or stored shall be equipped with appropriately sized odor filtration systems such that the marijuana odor shall not be detectable by the public from outside the product manufacturing facility.
- 3. If any modifications are made to the site plan, floor plans, or other FNSB required documents or operational characteristics, the applicant or holder of this conditional use permits shall submit revised documents to the FNSB Community Planning Department. If modifications are made to the conditional use, an amendment to the Conditional Use Permit may be required pursuant to FNSBC 18.104.050(D).

FINDINGS OF FACT

- 1. With the conditions imposed, the proposed conditional use will conform to the intent and purpose of Title 18 and of other ordinances and state statutes:
 - a. The purpose of Title 18 will be met because the proposed conditional use is consistent with 'Light Industrial Area' comprehensive plan land use designation. The Comprehensive Plan Land Use Goal 3 and Economic Development Goal 2 are enhanced by the conditional use.
 - b. The intent of Title 18 will be met because with the conditions imposed, the conditional use will both protect private property rights and promote public health, safety, and welfare.
 - c. 3AAC 306 governs the state licensing and operational standards for marijuana facilities. Title 18 requires that a borough-permitted commercial marijuana facility obtain a license pursuant to all state regulations including ADEC and State Fire Marshal requirements. The applicant has provided information sufficient to show that they intend to meet the state regulations and to apply for a state-issued license.
- 2. With the conditions imposed, there are adequate existing energy and transportation facilities serving the site and other public services are available to serve the proposed conditional use.

- a. The facility will have adequate water supply because the building has an existing 1000-gallon water tank.
- b. The facility has an existing septic system for the non-domestic wastewater. With the conditions imposed, the facility will have adequate wastewater/sewage capacity.
- c. With the conditions imposed obtain a formal plan review by the City of Fairbanks Building and Fire Departments, the facility has adequate fire services because the property is served by the City of Fairbanks Fire Department.
- d. The facility has adequate power supply because it is served by the GVEA grid.
- e. The facility is served by the City of Fairbanks Police Department for law enforcement.
- f. The property has access from Davis Road which is a major collector type roadway maintained by AKDOT&PF. Davis Road can accommodate the small number of trip ends generated by the proposed product manufacturing facility.
- g. The site plan shows 21 parking spaces and a loading area which are adequate for the proposed facility.
- 3. With the conditions imposed, the proposed conditional use will protect public health, safety, and welfare because the marijuana product manufacturing facility will comply with Title 18 standards for the LI zone (FNSBC 18.72) and Standards for Commercial Marijuana Establishments (FNSBC 18.96.240) as well as with other applicable land use related laws.
 - a. With the conditions imposed, security systems, alarms, cameras and lighting will meet state regulations required to obtain a commercial marijuana product manufacturing license.
 - b. With the conditions imposed, any solid or liquid waste including marijuana waste will be disposed of in accordance with state and local regulations.
 - c. With the conditions imposed, odor will be mitigated with appropriately sized odor filtration systems in the facility.
 - d. All marijuana and marijuana products will be secured inside the building to ensure the general public does not have access to them.
 - e. The noise generated from this product manufacturing facility would not negatively impact the neighboring property owners because the operation is completely indoors.

- f. The outdoor lighting will not negatively impact the neighboring property owners because it will point downward.
- g. The proposed hours of operation for the product manufacturing facility are from 8 am to 10 pm, daily. These hours of operation are the same as those for the existing cultivation facility and the retail store.

This decision may be appealed in writing to the Office of the Borough Clerk within fifteen (15) days from the date of the decision to the Fairbanks North Star Borough Board of Adjustment.

Public notice signs must be returned within 10 days. Upon receipt, in good condition, we will promptly initiate a refund of the sign deposit.





Section 2 - Control Plan for Persons Under the Age of 21

2.1. Describe how the marijuana establishment will prevent persons under the age of 21 from gaining access to any portion of the licensed premises and marijuana items:

GoodSinse will display a sign on the door entry that states no one under the age of twenty-one (21) is allowed per 3 AAC 306.325. GoodSinse will have locked doors with signs that read "Employees Only - Restricted Access Area - Visitors Must Be Escorted". No more than five visitors per escort will be permitted in the restricted access area. Escorts must have employee identification badges with photo. No one under twenty-one (21) years of age will be allowed on the premises.

Section 3 – Security

Restricted Access Areas (3 AAC 306.710):

3.1. Describe how you will prevent unescorted members of the public from entering restricted access areas:

GoodSinse restricted access areas are marked with signs that read "Restricted Access, Employees Only". All restricted access areas are equipped with lockable doors and entry codes for staff only. GoodSinse staff will first request valid photo identification to prove age of twenty-one (21) years or older. Visitors will record their name, date, and time onto a visitor log sheet. Visitors will obtain a VISITOR badge to be worn at all times while within the facility. A GoodSinse staff member will be with visitors at all times until the visitor has checked out on the visitor log and left the restricted area (s). No more than five (5) visitors per GoodSinse agent will be allowed in the restricted access area (s).

3.2. Describe your recordkeeping and processes for admitting visitors into and escorting them through restricted access areas:

Admission will require photo identification to prove age of twenty-one (21) years or older. Visitors will print their name, the date, and the time on the visitor log sheet when entering the facility. Visitors are required to wear a visitor identification badge and be escorted by a staff member at all times. Once the visitor has been escorted from the restricted areas and the Visitor badge has been returned, the visitor will sign out. All visitor log sheets will be kept on file as part of our normal record keeping for at least three years and six months on the premises.

3.4. Exterior lighting is required to facilitate surveillance. Describe how the exterior lighting will meet this requirement:

Exterior lighting has been installed along the outside of the whole building, including exterior doors. Video surveillance cameras are placed throughout the property, and all doorways are in view of the cameras.

3.5. An alarm system is required for all license types that must be activated on all exterior doors and windows when the licensed premises is closed for business. Describe the security alarm system for the proposed premises, explain how it will meet all regulatory requirements, and outline your policies and procedures regarding the actions to be taken by a licensee, employee, or agent when the alarm system alerts of an unauthorized breach:

Exterior doors have door contacts that will trip an alarm if there is an unauthorized breach. Glass break sensors are installed on all exterior windows and glass doors (retail). The interior of the building is equipped with motion sensors. Motion detectors are installed in hallways and entrances to ensure tracking of unwanted intruders. There is a keypad with a panic button in the retail area that will notify fire and police alarms. Alarms will be activated or deactivated with a keypad code, and all security systems, including cameras, will have battery backup. When GoodSinse is closed for business, the alarm system will be activated. It will be connected to all exterior doors and windows to alert the 24-hour alarm company of a breach. GoodSinse will be able to monitor and review surveillance remotely to coordinate with local law enforcement for apprehension and prosecution. Employees are trained to not open the door before opening of the store or after closing to ensure security while inventory is being transported from storage. GoodSinse uses high definition cameras for best quality video and to ensure all areas outside the premises are covered. After using a notification device, employees of GoodSinse will cooperate with intruders to de-escalate any potentially violent situation. The employees will allow the unauthorized person(s) to leave the premises as quickly as possible, with the intention of allowing law enforcement to handle apprehension and persecution. Authorized person(s) will review and copy any relevant video surveillance to aid in prosecution.

3.6. Describe your policies and procedures for preventing diversion of marijuana or marijuana product, including by employees:

METRC will be used diligently to track cannabis products between GoodSinse's cultivation, manufacturing, and retail facilities. This will ensure no appearance of diversion between licenses occurs. Each license will maintain record books to ensure tracking of all cannabis products while in the facility or when being transferred between them. Record books will supplement tracking data to the State's tracking system. To increase loss prevention, all employees shall have criminal background checks to ensure good moral character, and all employees must hold a Marijuana Handler Permit Card. Any missing product(s) or product found to be sold after purchasing it at the retail level will be reported to local law enforcement and AMCO.

3.7. Describe your policies and procedures for preventing loitering:

Signage will be placed along all outside areas of the building that read "No Loitering & No Trespassing". Video surveillance is noted as customers enter the parking lot. GoodSinse employees are trained to watch video surveillance for suspicious activity and to enforce our no loitering policy. Law enforcement will be contacted to handle any loiterers who will not vacate the premises.

Video cameras will be placed in a manner that will cover every entrance/exit, recording both interior and exterior views, and will cover the entire perimeter of the premises. The cameras will be monitored twenty-four (24) hours a day, seven (7) days a week, and will include high resolution and offer a variety of angles to ensure every area is monitored. Restricted access areas will also have coverage from strategically placed cameras. The parking lot will be covered by cameras for vehicle identification.

Describe the locked and secure area where video surveillance recording equipment and original copies of surveillance records will be housed and stored, and how you will ensure the area is accessible only to authorized personnel, law enforcement, or an agent of the Marijuana Control Board. Dedicated digital video recorders will record all surveillance video and will be stored in a locked office. An alert system for faulty equipment will also be installed.

4.2. A marijuana establishment is required to exercise due diligence in preserving and maintaining all required records. Describe how you will prevent records and data, including electronically maintained records, from being lost or destroyed:

All books and records used by GoodSinse shall be kept at the licensed premises for the current year. A monthly backup of financial records will be kept off site for a minimum of three (3) years. A current employee list will be maintained containing full name and Marijuana Handler Permit number. Any business contacts and marketing and advertising records will be maintained. A current diagram of premises noting any restricted access areas will be kept on site. A physical log of visitors will be maintained and kept on the premises in accordance with company record keeping for three and a half years. GoodSinse will utilize the METRC inventory tracking system adopted by the State as well as supplemental tracking of inventory to ensure no internal theft occurs. Any cannabis product that is transported off the premises will be recorded in METRC, will be securely stored, and will only be transported by someone with a Marijuana Handler Permit Card. All records will also be backed up on a cloud-based service to ensure files are secure if loss of equipment or building were to occur.

GoodSinse employees are required to have a valid Marijuana Handler Card to be employed or to continue employment (3 AAC 306.700) and a valid copy of the card will be kept on the premises at all times. Training consists of the new hire shadowing a senior employee. Employees will be trained regarding security measures and controls for prevention of diversion, theft, and loss of marijuana; emergency response procedures; and laws regarding confidentiality. Employees will be required to take all continuing education as required by the State. Employees will be trained to comply with all D.E.C. requirements; and State and local regulations, including but not limited to, safe kitchen practices, sanitary practices, how to recognize and handle impairment and underage customers, etc. Employees will also be trained to comply with 3 AAC 306.735 regarding health and safety standards. Each employee shall obtain a food worker card in compliance with 18 AAC 31.330 and keep that card in that person's possession at all times while on GoodSinse's licensed premises.






GOODSINSE DIAGRAM 2 IN REFERENCE TO IPRODUCTUMNUMENTING



RESOLUTION NO. 4902

A RESOLUTION REQUESTING THE ALASKA LEGISLATURE TO FUND THE RECAPITALIZATION OF THE COMMUNITY ASSISTANCE FUND

- **WHEREAS**, the FY20 budget approved by the Alaska State Legislature included recapitalization of the Community Assistance Fund; and
- **WHEREAS**, the Governor's veto of the \$30 million to recapitalize the Community Assistance Fund directly affects the operations of local governments; and
- **WHEREAS**, Community Assistance (formerly known as Community Revenue Sharing) represents a decades-long partnership between local governments and the State of Alaska; and
- **WHEREAS**, for 100 Alaska communities, Community Assistance represents more than 20% of their budget, and for some communities it represents as much as 80% of their budget budgets that deliver essential public services to Alaska residents; and
- **WHEREAS**, Community Assistance has seen continued reductions over the years; if measured against 1985, with adjustment for inflation, the value of Community Assistance would be 984% greater than it currently is; and
- **WHEREAS**, when Community Assistance was zeroed out in the early 2000s, 14 local governments ceased day-to-day operations; and
- **WHEREAS**, by not recapitalizing the fund, the payment to local governments will be reduced from \$30 million in FY20 to \$20 million in FY21; and
- **WHEREAS**, it is estimated that the Community Assistance payment to the City of Fairbanks would be reduced from \$688,552 in FY20 to \$79,684 in FY21.
- **NOW, THEREFORE, BE IT RESOLVED,** that the Fairbanks City Council encourages the Alaska Legislature to fully recapitalize the Community Assistance Fund.
- **BE IT FURTHER RESOLVED** that the City Clerk is directed to send a copy of this Resolution to the Interior Alaska Legislative Delegation.

LFD Informational Paper 20-2: Community Assistance Program

What is the Community Assistance program?

The Community Assistance program (AS 29.60.850-879) provides funding to municipalities, unincorporated communities, and Native village councils in Alaska to support local government activities. The program has existed in various forms since 1985.

How does the program work?

All incorporated communities that provide services such as fire protection, water and sewer, public road maintenance, and solid waste management are eligible for Community Assistance payments. In addition, the Department of Commerce, Community and Economic Development designates an incorporated nonprofit entity or Native village council in other communities that can receive and spend payments. Unincorporated communities must have at least 25 residents to qualify.

How much do communities receive?

Until 2017, the program was designed to distribute \$60 million total per year (although actual amounts varied). SB 210, passed in 2016, reduced the target distribution to \$30 million and amended the formula.

AS 29.60.855 provides a base amount for boroughs and unified municipalities, and other communities have a

base that is a fraction of that base. See the table to the right. A unified municipality receives both the borough base and the city base payments.

Example calculations

Anchorage: \$300,000 (borough base) + \$75,000 (city base) + 295,365 residents * \$14.16 per capita = \$4,557,777

Tok: \$25,000 (unincorporated outside borough base) + 1,234 residents * \$14.16 per capita = \$42,475 After paying out the base payments, the remaining distribution goes to all communities on a per-capita basis. The department calculates the amount remaining after paying the bases, and divides that by the total state population. In FY20, that amount is about \$14 per resident.

How is the Community Assistance program funded?

The total distribution each year equals one-third of the

balance of the Community Assistance Fund on June 30 of the previous fiscal year. Per AS 29.60.850, the annual deposit into the fund may not exceed \$30 million or the amount necessary to bring the fund balance to \$90 million, whichever is greater. So if the program is fully funded, the legislature would deposit \$30 million into the fund each year and the balance of the fund on June 30 would be \$90 million.

One-third of that balance would be \$30 million, so the distribution would be \$30 million. See the figure on the following page for an illustration of how this has worked in practice.

AS 42.45.085 provides that the Power Cost Equalization Endowment (PCE) Fund may be used as a funding source for this program if it has sufficient earnings. Per that statute, the legislature may appropriate 70% of the prior closed fiscal year's "excess" earnings above the cost of the PCE program (meaning that the legislature may appropriate 70% of excess FY19 earnings in the FY21 budget, since the legislature is making the appropriation in FY20). Up to \$30 million of the remainder may be appropriated to the Community Assistance Fund. For example, FY19 earnings totaled \$74.1 million. After subtracting the PCE program's cost (\$33.1 million) and administrative expenses (\$0.8 million), \$41.0 million remains. 70% of \$41 million is \$28.7 million, so \$28.7 million is available from the PCE fund for Community Assistance.

What will the distribution be in Fiscal Year 2021?

The Governor vetoed a \$30 million capitalization of the fund in FY20 that would have brought the balance of the fund to \$90 million. That appropriation would have resulted in a \$30 million distribution in FY21. Unless the veto is overridden or a supplemental capitalization is made to the fund before June 30, 2020, the distribution in FY21 will be \$20 million.

What is in the Governor's FY21 budget proposal for Community Assistance?

The Governor is not proposing an FY20 supplemental appropriation. His budget appropriates \$28,731,500 to the Community Assistance Fund from the Power Cost Equalization Fund, which represents the statutory distribution from that fund. His budget does not include the additional UGF appropriation to reach a \$30 million total deposit.

Under the Governor's budget, the FY21 distribution would be \$20 million and the FY22 distribution would be \$22.9 million. See the table below.

RESOLUTION NO. 4903

A RESOLUTION REQUESTING THE BOROUGH ASSEMBLY TO REESTABLISH THE CITY COUNCIL AS THE BOARD OF ADJUSTMENT FOR APPEALS INVOLVING PROPERTY LOCATED WITHIN THE CITY OF FAIRBANKS

WHEREAS, at the April 25, 2016, City Council meeting, the Council voted unanimously to veto the decision of the Fairbanks North Star Borough (FNSB) Planning Commission to rename Terminal Street as Citizens Way; and

WHEREAS, later in that same meeting, the Council, sitting as the board of adjustment, voted to grant an appeal which reversed a decision of the FNSB Planning Commission and denied a request for a conditional use permit; and

WHEREAS, on June 9, 2016, Ordinance No. 2016-36 was introduced by the FNSB mayor that revoked the City Council's authority to veto the Planning Commission's street naming decisions and revoked the City Council's authority to sit as the board of adjustment to hear appeals from administrative land use decisions for land located with the City of Fairbanks; and

WHEREAS, while the FNSB Assembly amended Ordinance No. 2016-36 to eliminate the provision regarding the Council's veto power over street names, the Assembly adopted the provision removing the Council as the board of adjustment; and

WHEREAS, throughout the City's history the City Council was the board of adjustment until 1974 when the borough assumed area-wide zoning functions, and the Council served as the board of adjustment under the borough code for at least 28 years before the Assembly revoked that authority in 2016; and

WHEREAS, the City Council believes that appeals involving land use decisions for land located within the corporate boundaries of the City of Fairbanks are best made by the City Council, the officials elected by the people most affected by such land use decisions.

NOW, THEREFORE, BE IT RESOLVED, that the City Council encourages the Fairbanks North Star Borough Assembly to amend its code to reestablish the Fairbanks City Council as the board of adjustment for appeals concerning property located within the City of Fairbanks.

ORDINANCE NO. 6123

AN ORDINANCE TO AMEND FAIRBANKS GENERAL CODE CHAPTER 78, BY REPEALING ART. XIV, SEC. 507 BICYCLE LICENSES AND SEC. 508 BICYCLE LICENSE FEE

WHEREAS FGC Sec. 507, which mandates that all bicycles operated in the city have a city bicycle license, and FGC Sec. 508, which requires a \$1.00 fee for such licenses, have seldom been used or enforced; and

WHEREAS, the primary purpose of the bicycle licensing scheme was to help the Police Department identify lost and stolen bicycles; and

WHEREAS, rather than this mandatory scheme, with a \$20.00 fine for violations, the Council encourages the Police Department, along with community partners, to continue a program of voluntary bicycle licensing; and

WHEREAS, since Sections 507 and 508 are the only remaining sections under Article XIV, the entire Article should be repealed.

NOW, THEREFORE, BE IT ENACTED BY THE CITY COUNCIL OF THE CITY OF FAIRBANKS, ALASKA, as follows:

<u>Section 1.</u> Fairbanks General Code Chapter 78, Article XIV. Bicycles, nonmotorized conveyances, motorcycles and motor-driven cycles, is hereby repealed.

Section 2. That the effective date of this Ordinance shall be the __ day of February 2020.

Sec. 78-507. - Bicycle licenses.

- (a) No person shall operate on the streets or public ways of the city any bicycle unless the bicycle is licensed as provided in this section.
- (b) Each owner shall apply to the police department for a license for each bicycle owned or operated by him, giving his name and address (and his parents' name and address if a minor), the make, model and serial number of the bicycle, and state the date the bicycle was purchased and from whom. Each application shall be accompanied by the fee for the registration of the bicycle as provided by section 78-508. The police chief or his designee shall thereupon assign such bicycle a license number and deliver a license bearing the number to the registrant and a receipt attesting registration. The license shall be issued for a calendar year and shall be renewed not later than May 31 of each year.
- (c) Whenever a bicycle registered under this section shall be sold or transferred, it shall be the duty of the seller to promptly advise the police department. The person acquiring ownership shall apply to the police department for a change of registration, supplying the information required in subsection (b) of this section, together with the registration number of the bicycle. The police chief or his designee shall thereupon register the new ownership of the bicycle.

She stated that equities ended flat after an eventful quarter due to two rate cuts and a resilient economy (rising wages, labor force participation, and consumer confidence). She stated that real assets had some of the best performance relative to other asset classes and that interest rates had multiple changes through the quarter and finally landed at 1.66%.

Brandy Niclai also reported that policy risks support neutral allocation because the economy is slower but positive; earnings expectations are modest but still positive; interest rates have fallen so bonds are more expensive resulting in higher returns for equities; and volatility increased across the market on trade trends and softer economic data. She reported that the Alternative was sold since other asset classes were more favorable, but the Alternative helped the portfolio when the stock market fell.

Brandy Niclai also presented the challenges of the City's goal of the permanent fund to maximize income for capital and operating expenses while preserving the principal. Based on an analysis, the permanent fund strategic asset allocation (60% equity) can support the 4.5% distribution rate while preserving the principal, but only provides partial inflation protection based upon APCM's inflation expectations of 2% per year.

PFRB members discussed the impacts of changing the equity allocation from 60% to 70%; since 70% will cover the annual draw and inflation proof the portfolio. PRFB members also discussed the City's goals for the permanent fund to maximize income while preserving the principal and to seek Council input on which of the two would be the primary goal since they can be challenging to maintain both while inflation proofing the portfolio. PFRB members expressed the importance of the Council to understand that the current equity percentage would not be sufficient for a 2% inflation.

The next quarterly meeting will be January 27, 2020 in the City Council Chambers, followed by a work session with City Council members.

The meeting adjourned at 2:50 p.m.
