The City Council convened at 6:30 p.m. on the above date, following a 5:30 p.m. Work Session to discuss the Fairbanks Downtown Plan, to conduct a Regular Meeting of the Fairbanks City Council via Zoom webinar and at the City Council Chambers, 800 Cushman Street, Fairbanks, Alaska, with Mayor Jim Matherly presiding and with the following Council Members in attendance:

INVOCATION

The Invocation was given by City Clerk Danyielle Snider.

FLAG SALUTATION

Mayor Matherly led the Flag Salutation.

CEREMONIAL MATTERS

Mayor Matherly welcomed new Fire Chief Scott Raygor and briefly spoke about his experience and history with the City. Chief of Staff Mike Sanders administered Chief Raygor's oath of office, and his wife applied his pin.

CITIZENS' COMMENTS

<u>Chief Steve Ginnis, Executive Director of Fairbanks Native Association (FNA)</u> – Chief Ginnis congratulated Chief Raygor on behalf of the FNA Board. He expressed his disappointment that the City Council had failed the land acknowledgment resolution. He shared that Native people and corporations contribute heavily to the local economy. Chief Ginnis mentioned the joint statement sent to the City Council on March 31, 2022, and the comment that followed by Council Member Clark who indicated that it was divisive measure guised as diversity. Chief Ginnis argued that the land acknowledgment is a statement built on history – not racism – and that it was important to show respect to the first people. He asked the Council to reconsider and listen to constituents.

Mr. Cleworth asked Chief Ginnis whether he believed the land acknowledgement was a political statement or a historical document. Chief Ginnis stated that it should be viewed as a statement based on history.

<u>Dr. Jessica Black, Fairbanks</u> – Dr. Black shared that she came from the villages of Fort Yukon and Nenana and provided a land acknowledgment. She added that she works for the University of Alaska Fairbanks (UAF) and serves as the FNA president. Dr. Black expressed her disappointment that the Council did not pass the land acknowledgement resolution, adding that it would have been a first step in improving relationships and increasing awareness of the history of Alaska.

Ms. Therrien asked Dr. Black if she had read the proposed language, and Dr. Black said she would like to revisit it before commenting.

<u>Sharon McConnell, Fairbanks</u> – S. McConnell gave a land acknowledgment, noting that it was a statement of recognition for the first people of the region. She shared that she had been involved in drafting the original language proposed by the resolution and that they had been honored to be involved in the City Council's request to consider a formal land acknowledgement; she noted, however, that the version presented by the Fairbanks Diversity Council (FDC) had been heavily edited. S. McConnell shared the process behind the drafting of the original language and the disappointment of the Elders to learn that their hard work had been rewritten. She added that the Elders had been surprised that the resolution was to be heard, they would have testified at that time. She asked that the Council reconsider its decision and choose to acknowledge and respect the diversity of the Fairbanks community and its ancestors.

<u>Chief Reverend Dr. Anna Frank, Fairbanks</u> – Dr. Frank shared some of her history in the Fairbanks area, adding that she did want not to see Native children being disregarded and left out of the narrative. Dr. Frank stated that all people need to work together and respect one another, adding that values written on paper are best discussed, not simply looked at.

<u>Reverend Shirley Lee, FNA Justice Director</u> – Rev. Lee spoke to the history of the local ancestors and the hardships they suffered, adding that reading a small land acknowledgement before City Council meetings would go a long way in strengthening bonds. She noted that Native leadership contributes a great deal to the City and asked that the Council reconsider its action and approve a land acknowledgement. <u>David Costello, Fairbanks</u> – D. Costello spoke in favor of a tax exemption for new multi-unit developments, adding that he has been a general contractor in the area for over 20 years. He noted that the proposed exemption would be in line with the recently adopted exemption by the Fairbanks North Star Borough (FNSB). He highlighted portions of the Borough's resolution, adding that he had already applied for their exemption. He added that the process is lengthy and, if approved, he would not be able to start construction until mid- or late June.

<u>Christina Carlson, Fairbanks</u> – C. Carlson shared that she is the head teacher at Chinook Montessori Charter School and asked the Council to consider another ordinance to provide tax relief for charter schools; she added that such exemptions are in place in Anchorage and Mat-Su.

<u>Tanya Kaquatosh, Fairbanks</u> – T. Kaquatosh stated that the Doyon Corporation represents over 20,000 shareholders with more than a quarter of them living in the Fairbanks area. She shared her personal experience attending schools in the Fairbanks area, adding that she had attended Stanford and Arizona State University, where she obtained her master's degree. She spoke in support of the City adopting a land acknowledgement, likening it to the opening invocation, which she believed was given with nothing but good intentions. She added that she did not believe it was failed with intentional disrespect to the Native community, but she did believe that the relationship between the two could be improved. She stated that she would personally like to see the acknowledgement in place as a proud Native parent who is raising a proud Native daughter.

<u>Scott McCrea, Explore Fairbanks Executive Director</u> – S. McCrea spoke in favor of the City Council reconsidering the adoption of a land acknowledgement, noting that Explore Fairbanks had adopted the same acknowledgement the previous summer. He added that he did not feel that the reading of the acknowledgement before each meeting detracted from the business at hand. He shared that part of the Explore Fairbanks pride is in recognizing the Native culture along with the landscape and wildlife.

<u>Roscoe Britton, No Limits Program Director</u> – R. Britton shared that he had planned on testifying in regard to a different topic but opted to defer that testimony so that the current issue regarding the land acknowledgment could be addressed. He spoke in favor of the land acknowledgment.

David van den Berg, Downtown Association (DTA) Executive Director – D. van den Berg spoke in support of Resolution No. 5009. He also spoke to the Work Session regarding the Downtown Plan, expressing his concern that the FSNB may take some unwanted liberties. He stated it is a good idea to see an early draft of the plan so that the City may properly respond.

<u>Tim Staton, Fairbanks</u> – T. Staton expressed concern about vendor booth placement during the Midnight Sun Festival, adding that he had been told that planning meetings were not yet scheduled by Mr. van den Berg. He shared his desire to meet one-on-one with the DTA to discuss issues for business owners. He added that some of the statements made during the Work Session were unfair and inflammatory regarding the Parking Authority. T. Staton added that the DTA has not communicated with the Parking Authority outside of asking for information, noting that the contract between the City and the Parking Authority does not concern the DTA. He added that the DTA is detrimental to many of the downtown businesses in some respects, and that has kept some business owners from joining the organization.

Mayor Matherly asked that Mr. Staton email the Council.

Hearing no more requests for in-person comment, individuals on Zoom were heard next.

<u>Dewey Kk'oleyo Hoffman, Fairbanks</u> – D. Hoffman spoke in support of the resolution regarding the land acknowledgement, adding that he was the Deputy Director of Tribal Government Client Services at the Tanana Chiefs Conference. He shared an introduction in his Native language. He added that the land acknowledgement helps shed light on Native history while also showing respect to the Native ancestors.

Hearing no more requests for comment, Mayor Matherly declared Citizens' Comments closed.

Mayor Matherly called for testimony and hearing none, declared Public Testimony closed.

Mr. Gibson asked about the process for the transfer since no location had been listed on the transfer. Clerk Snider explained that the liquor license would have to come back before the City Council prior to becoming operational at a new location.

Mayor Matherly called for testimony and hearing none, declared Public Testimony closed.

Ms. Rogers asked about any previous issues with the applicant; Clerk Snider replied that she recalled no issues.

MAYOR'S COMMENTS AND REPORT

Mayor Matherly noted how heavily he relies on City department heads, and he welcomed Chief Raygor. He congratulated the Fairbanks Ice Dogs on securing the Club 49 Cup. He noted that there is still a lot of snow and ice on the roads and in the drains; he thanked Public Works for the job they do and asked the public to be patient. Mayor Matherly spoke to the Tetlin mine and the hauling of ore, noting that he had done a lot of research on the topic and had some traffic concerns. He encouraged others to attend public meetings on the topic, adding that he will be meeting with other organizations; he again expressed his concern about the traffic and the impact it will have on tourism and highway traveling. He wished everyone a happy Easter, noting the public service that would be held at the bridge downtown on Sunday at 7:00 a.m. Mayor Matherly thanked those present during the Work Session, noting that over 9,000 parking spaces are available in the downtown area, even though some of them belong to private businesses. He went on to speak to the concerns regarding the street fair downtown, noting that not everyone can be pleased all the time, but he understood Mr. Staton's concerns. He encouraged Mr. Staton to work with the DTA, as they were the organization putting on that event. He also noted that Mr. Staton's complaint regarding booth placement is the only complaint that he has heard. Mayor Matherly spoke to the land acknowledgement testimony, noting that former Council Member Kun had read it at every meeting; he noted that he recently attended a Native leadership meeting regarding public safety.

COUNCIL MEMBERS' COMMENTS

Mr. Gibson congratulated Chief Raygor and stated he is excited to see what the Chief would bring to the Fire Department.

Mr. Marney thanked Chief Raygor for accepting the position. He thanked all those who testified regarding failed Resolution No. 4981, adding that he had a great deal of respect for the Native people of Alaska and their culture. He noted that the comments gave him new perspectives to consider. He went on to express his hope that the DTA, Parking Authority, and Festival Fairbanks could better communicate and work together.

Mr. Clark thanked those who testified and clarified that the message intended in his response to the letter from the Native leadership was that by formally acknowledging one population within the City, others are effectively excluded. He stated that his belief does not diminish the respect he holds for the Native population and culture. He addressed the water on roadways, noting that he nearly splashed a pedestrian unintentionally; he asked drivers to be courteous and aware.

Ms. Therrien thanked everyone for their testimony, noting that it was unfortunate that the testimony had come too late for the consideration of the land acknowledgement. She thanked Mr. Costello for his comments regarding the FNSB tax exemption and shared that a City ordinance was still in the works. **Ms. Therrien** added that the DTA and Mr. Staton need to work together to find a solution, adding that moving the stands seemed like a simple fix to the issues presented.

Ms. Rogers thanked Chief Raygor and recognized his promotion. She added that the testimony was very positive and respectful and thanked those who took the time to speak. She spoke to the idea of active and respectful listening, adding that she had hope for a brighter and more connected community moving forward.

Mr. Cleworth spoke to Mr. Staton's comments and to the issue of vendors being set up on the sidewalk; he added that having the event on Sunday is also troublesome. He recognized Chief Raygor in his new appointment. **Mr. Cleworth** spoke to the testimony regarding the land acknowledgment, expressing concern that the relationship between the City and the Native community has not always been amicable. He noted that it should concern everyone to hear such comments but noted some of the growth and improvements over the years. He added that he did not feel that it was fair to consider the vote regarding the reading of a land acknowledgment as a lack of respect or appreciation for the Native population and culture. **Mr. Cleworth** added that he would still be in favor of adding the land acknowledgement as a permanent historical record to be displayed in City Council Chambers, clarifying that he felt the reading of a document as normal part of business devalues the meaning of the statement over time.

Ms. Therrien added to her previous comments by congratulating Chief Raygor and wishing everyone a happy Easter.

UNFINISHED BUSINESS

a) Ordinance No. 6202 – An Ordinance Authorizing the City of Fairbanks to Apply for Funds from the United States Department of Transportation for the Rebuilding American Infrastructure with Sustainability and Equity (RAISE) Discretionary Grant Program. Introduced by Mayor Matherly. SECOND READING AND PUBLIC HEARING.

Mr. Marney, seconded by Ms. Therrien, moved to ADOPT Ordinance No. 6202.

Mayor Matherly called for testimony and, hearing none, declared Public Testimony closed.

Mr. Clark asked if this was a first-time application or a re-application. Mayor Matherly confirmed that it was the first time.

Ms. Therrien shared a concern that the grant had a matching fund requirement when the Council had not yet created its prioritized list of projects.

Ms. Rogers acknowledged Ms. Therrien's concern but felt that the grant would address an important and long-needed project.

A ROLL CALL VOTE WAS TAKEN ON THE MOTION TO ADOPT ORDINANCE NO. 6202 AS FOLLOWS:

YEAS: Cleworth, Marney, Therrien, Rogers, Gibson NAYS: Clark **Mayor Matherly** declared the MOTION CARRIED and Ordinance No. 6202 ADOPTED.

NEW BUSINESS

a) Resolution No. 5009 – A Resolution Expressing Gratitude to Senator Lisa Murkowski for Helping Secure Funding for the Demolition of the Polaris Building. Introduced by Council Member Therrien.

Ms. Therrien, seconded by Ms. Rogers, moved to APPROVE Resolution No. 5009.

Ms. Rogers asked to co-sponsor the resolution and suggested that all Council members do the same. **Mayor Matherly** asked for a show of hands from others who would like to be added as sponsors; Mr. Marney, Mr. Cleworth, and Mr. Gibson indicated that they wished to be added.

Mr. Marney asked if there had been participation by any other legislative members in securing the funds. **Mayor Matherly** stated that there was other involvement, but Sen. Murkowski had done most of the heavy lifting. **Ms. Rogers** confirmed that the discussions have always revolved around Sen. Murkowski and her involvement.

Mr. Cleworth, seconded by **Ms. Therrien**, moved to AMEND Resolution No. 5009 by adding the language "and for the work of the Polaris Working Group" at the end of the document.

Mr. Cleworth stated that the Polaris Working Group has spent a great deal of time on the project and had worked with Sen. Murkowski to make it a priority; he added that the group should also be recognized for its efforts.

A ROLL CALL VOTE WAS TAKEN ON THE MOTION TO AMEND RESOLUTION NO. 5009 BY ADDING THE LANGUAGE "AND FOR THE WORK OF THE POLARIS WORKING GROUP" AT THE END OF THE DOCUMENT AS FOLLOWS:

YEAS: Therrien, Rogers, Cleworth, Marney, Gibson NAYS: Clark **Mayor Matherly** declared the MOTION CARRIED.

Mr. Clark explained that he appreciated Ms. Therrien's intent behind the resolution but stated that he does not support the overall cost of the infrastructure bill where the funds originated.

Mr. Cleworth acknowledged Mr. Clark's concern over the cost of the infrastructure bill, especially given that there was no associated funding source. He stated, however, that the City might as well get a small portion of the funds as everyone will be paying for the bill in one way or another.

Ms. Therrien asked for the Council's support of the resolution.

Mayor Matherly shared his appreciation for the work done to obtain the funds for the Polaris Building, adding that he could not see a future where the City would ever have enough funds to demolish the building on its own. He added that each year the cost and risk of the project escalates.

A ROLL CALL VOTE WAS TAKEN ON THE MOTION TO APPROVE RESOLUTION NO. 5009, AS AMENDED, AS FOLLOWS:

COUNCIL MEMBERS' COMMENTS & COMMITTEE REPORTS

With no objection from the Council, Members' Comments and Committee Reports were combined.

Mr. Clark stated he had no comments.

Mr. Marney spoke to the Tetlin mining project and to his concern due to the 188 school bus stops on the route from Tetlin to Fairbanks. He spoke to the Clerk's quarterly report regarding the FNSB election ordinance and asked that the Council begin discussing the potential effects it may have on the City elections.

Mr. Gibson stated he had no comments.

Mr. Cleworth echoed Mr. Marney's concern about the FNSB election ordinance being introduced, adding that he had previously believed that it was not legally possible to combine state and local elections on the same day. He added that it would be good to discuss the issue with the Clerk at a Finance Committee meeting, possibly obtaining the Borough Clerk's opinion as well. He noted that it would be good to have a resolution or opinion to present to the FNSB Assembly. **Mr. Cleworth** shared that he had visited Galveston, Texas recently and noted that Fairbanks sidewalks are in better shape and are more ADA compliant than in Galveston; he noted also that Galveston is a wealthier community. He stated that it had been a good experience to tour other communities

and see how differently things are done. He requested that the Administration provide the number of grievances that have been filed at the City and how they impact City departments.

Ms. Rogers thanked the Clerk for her quarterly report, noting that she appreciates receiving her insight.

Ms. Therrien spoke to the changes made to the AML annual conference, which was also noted in the City Clerk's report; she stated she had been working with CFO Bell in regard to budget meetings in light of the change. She went on to share that the State budget had been passed by the House and was currently with the Senate and that she did not feel there would be much more legislation passed at this point in the legislative session.

Mayor Matherly shared that Public Works Director Jeff Jacobson had recently shown him the plaques that were created in memory of Mr. Mike Meeks. Chief of Staff Sanders added that the plaques would be mounted along with some of Mr. Meeks' photography. **Mayor Matherly** added that there would be a memorial for Mr. Meeks on June 18, and more information would follow.

CITY CLERK'S REPORT

City Clerk Snider stated that the City Council is required to meet twice per month per the City Charter and pointed out that that the change in the AML conference dates may present a conflict with the meeting schedule. She added that the budget adoption deadline is also noted in the City Charter as December 15. She stated that starting the budget process earlier would help, but it may not solve the meeting issue entirely.

ADJOURNMENT

Mr. Clark, seconded by Mr. Marney, moved to ADJOURN the meeting.

Mayor Matherly called for objection and, hearing none, so ORDERED.

Mayor Matherly declared the meeting adjourned at 8:18 p.m.

SECTION 1. That a lease instrument, substantially in the form shown in attached Exhibit A, is hereby authorized by the Council for the purposes stated herein, providing for a term of three years.

SECTION 2. That the Mayor's execution of the lease must take place not less than 30 days after the effective date of this ordinance, as prescribed by Charter Section 8.3 and FGC Sec. 70-56.

REAL ESTATE LEASE

WHEREAS, the City of Fairbanks, a municipal corporation of the State of Alaska, 800 Cushman Street, Fairbanks, Alaska 99701, hereinafter called Lessor, as trustee for the public and pursuant to Ordinance No. 6203, hereby authorizes lease of the property described below under the conditions stated; and

WHEREAS, Festival Fairbanks, Inc., 516 Second Avenue, Suite 318, Fairbanks, Alaska 99701, hereinafter called Lessee, hereby enters into this lease of the property described below under the conditions stated.

NOW THEREFORE, Lessor and Lessee, in consideration of the rent specified and of the mutual covenants and agreements expressed herein, agree as follows:

1. <u>Lease of Property</u>. The Lessor leases to Lessee, and Lessee leases from Lessor, the real property located at Fairbanks, Alaska, more particularly described as follows:

Lots 3 and 4, Block 4, Fairbanks Townsite, also known as "Golden Heart Plaza", and the improvements thereon, as shown on the attached "Lease Exhibit 1".

- 2. <u>Term</u>. The term of this Lease will be for three years, beginning April 13, 2022 and ending April 12, 2025.
- 3. <u>Use</u>. Lessee shall use the Property in compliance with FGC Sections 70-96 through 70-99, Golden Heart Plaza.
- 4. <u>Rent</u>. As compensation for use of the Property during the life of this lease, Lessee shall pay the sum of One Dollar (\$1.00) per year, paid in advance. Payments will be made at Lessor's Office of the City Clerk, 800 Cushman Street, Fairbanks, Alaska 99701.
- 5. <u>Prohibited Uses</u>. Lessee shall not use or permit the use of the Property or any part thereof in violation of any applicable law, ordinance, or regulation.
- 6. <u>Maintenance and Expenses</u>. Lessee shall perform routine cleaning associated with the leased Property proper, keeping the Property in a clean, safe condition, free of litter and debris. Lessee shall notify Lessor of hazards or safety concerns on or

about the Property in a timely manner. Lessor shall provide repairs or alterations as it deems necessary, at its expense.

- 7. <u>Termination</u>. In the event of Lessor's sale or redevelopment of the property, Lessee's rights hereunder will terminate, and Lessee must vacate the property within 60 days of written notice.
- 8. <u>Exculpation and Indemnity</u>.
 - (a) *Exculpation of Lessor*: Lessor shall not be liable to Lessee for any damage to Lessee or Lessee's property from any cause. Lessee shall bear all risk of loss as to all personal property of the Lessee stored or remaining on or near the Property, including without limitation, inventory, equipment, fixtures, and employees' personal effects.
 - (b) *Indemnity*: Lessee shall defend and hold the Lessor harmless from all damages arising out of any damage or injury to any person or property occurring in, about, or on the Property.
 - (c) *Public Liability and Damage Insurance*: Lessee at its sole cost shall at all times maintain public liability and damage insurance with a single combined liability limit of \$1,000,000, insuring against all liability of Lessee and its authorized representatives arising out of and in connection with Lessee's use or occupancy of the Property. All public liability insurance and property damage insurance will insure performance by Lessee of the indemnity provisions provided herein. Lessor shall be named as an additional insured.
- 9. <u>Prevention of Waste and Nuisance</u>. Lessee shall not use the Property in any manner that will constitute waste, nuisance, or unreasonable annoyance to Lessor or the owners or occupants of adjacent properties. Violation or breach under this section will be determined at the sole discretion of the City Mayor.
- 10. <u>Assignment and Sublease</u>. Lessee shall not assign or sublet its rights under this Lease without written consent of Lessor, which consent will be at Lessor's sole discretion.
- 11. <u>Liens</u>. Lessee shall keep the Property free from any liens, including without limitation those liens arising out of any work performed, materials furnished, or obligations incurred by Lessee.

- 12. <u>Consultation with Attorney</u>. Lessee acknowledges that it has the right to review this Lease and all other documents relating to the Lease with its own attorney. Each party electing to have this Lease reviewed by an attorney shall bear the costs and expenses so incurred.
- 13. <u>Right of Entry</u>. Lessor and its agents and authorized employees have the right to enter the rented Property to examine it and to make repairs, alterations, improvements, or additions, as Lessor may deem necessary or desirable during Lessee's business hours. All such entry shall be preceded by 72-hour advance notice to Lessee, except that immediate entry will be allowed in event of emergency, as determined by the City Engineer.
- 14. <u>Default</u>. Failure to occupy and operate the Property for two consecutive weekends or failure to perform any provision of this Lease constitutes a default by Lessee. Upon Lessee's default, Lessor shall give Lessee 10 days' notice to cure the default. No default notice may be deemed a forfeiture or a termination of this Lease unless Lessor so elects in the notice.
- 15. <u>Notice</u>. Any notice, demand, request, consent, approval, or communication that either party desires or is required to give to the other party or any other person must be in writing and either served personally or sent by prepaid, first-class mail, addressed to the other party at the address set forth in the introductory paragraph of this Lease. Either party may change its address by notifying the other party of the change of address.
- 16. <u>Attorney's Fees</u>. If Lessor brings or maintains an action for enforcement of any of the covenants, terms, or conditions of this Lease, Lessee shall pay all costs incurred by Lessor for such action, including attorney's fees in the event Lessee is found to be at fault.
- 17. <u>Time of Essence</u>. Time is of the essence of each provision of this Lease.
- 18. <u>Successors</u>. This Lease is binding on the parties and their successors.
- 19. <u>Severability</u>. The unenforceability, invalidity, or illegality of any provision will not render the other provisions unenforceable, invalid, or illegal.



ORDINANCE NO. 6204

AN ORDINANCE ESTABLISHING AN EDUCATION REIMBURSEMENT PROGRAM WITHIN FAIRBANKS FIRE DEPARTMENT FOR RECRUITMENT AND HIRING

WHEREAS, the Fairbanks Fire Department (FFD) continues to struggle to recruit paramedics; and

WHEREAS, retention of paramedic staff has been extremely difficult for more than three years; and

WHEREAS, the current cost for the City of Fairbanks at a minimum is \$16,000 for tuition and up to \$120,000 in salaries, overtime, and benefits to send one employee to complete a paramedic program; and

WHEREAS, a sign-on bonus of \$1,000 for a student paramedic, already in the end stages of their education, would help attract applicants and would constitute a significant cost savings to the City; and

WHEREAS, an additional \$2,000 after three years and \$5,000 after five years will be paid to the employee to promote retention; and

WHEREAS, a retention bonus of \$2,000 after three years and \$5,000 after 5 years will be paid to paramedics hired outside of the student paramedic program as an educational reimbursement to promote retention beginning May 1, 2022.

NOW, THEREFORE, BE IT ENACTED BY THE CITY COUNCIL OF THE CITY OF FAIRBANKS, ALASKA, as follows:

SECTION 1. A Sign-on Bonus/Retention Bonus program for Fairbanks Fire Department paramedics is hereby established, providing for a \$1000 sign-on bonus and a retention bonus of \$2,000 after three years and \$5,000 after five years, for eligible applicants, subject to the terms and conditions of the Sign-on Bonus/Retention Bonus Contract attached as Exhibit A.

<u>SECTION 2</u>. The bonuses established in this ordinance will be funded through salary savings, as available.

SECTION 3. This program will sunset on December 31, 2023, unless extended by Resolution of the City Council.

SECTION 4. That the effective date of this Ordinance shall be the 1st day of May 2022.

Fairbanks Fire Department Sign-on Bonus/Retention Bonus Contract

This agreement is made between the CITY OF FAIRBANKS ("City") and _ ("Employee").

WHEREAS, the Employee has been offered employment for the City as a Paramedic in the Fire Department ("Department") for the first time;

WHEREAS, the Department wishes to bestow upon the Employee a Sign-on Bonus/Retention Bonus as an incentive for the Employee to accept employment at the City and to remain satisfactorily employed in the Department as a Paramedic for at least five full years;

WHEREFORE, the City and the Employee agree to the following terms:

- 1. The City, acting through the Department, agrees to bestow upon the Employee \$1,000 as a Signon Bonus, to be paid on the Employee's first paycheck, and to pay the Employee an additional \$2,000 after three years and \$5,000 after five years as a Retention Bonus, to be paid on the Employee's first paycheck after completing the time-period requirement, in return for the Employee accepting the City's offer of employment and remaining employed as a paramedic for the full-time periods.
- 2. The City will apply all required federal and state tax deductions and will report all payments made under this Agreement as required by federal and state law. Taxes will be withheld as bonus earnings from the Sign-on Bonus/Retention Bonus and reported to the Internal Revenue Services as income on the Employee's Form W-2. The Sign-on Bonus/Retention Bonus is not considered "salary" and will not be included for purposes of retirement benefit calculations or salary increases.
- 3. The Department will adhere to all relevant City and Department policies during the hiring process and in making bonus payments to employees.
- 4. In return for accepting the Sign-on Bonus/Retention Bonus as provided in paragraph 1, the Employee agrees to work for the Department as a paramedic on a regular and full-time basis for at least five years beginning ______ and ending on ______ (the "ending date"). Should the Employee resign, quit, or be terminated for cause before the ending date, the Employee shall repay a prorated amount of the Sign-on Bonus/Retention Bonus as provided in paragraph 5.
- 5. The Employee's failure to remain employed by the Department as a paramedic for the applicable time period will trigger the Employee's duty to repay, pro-rata, the amount paid by the Department pursuant to paragraph 1 (this amount may be more than the Employee received due to taxes or other withholdings). To facilitate this repayment, the Employee, by signing below, expressly gives the City a lien on all their salary, wages, and other sums payable to them by the City, subject to state and federal law. In addition, the Employee authorizes the City to withhold all amounts so due from any sum payable to the Employee by the Department and the City. The Employee also agrees that any tax consequences that result from the repayment of the Sign-on Bonus/Retention Bonus will be the sole and exclusive responsibility of the Employee.

- 6. If the Employee fails to remain employed by the Department as a paramedic for the applicable time period for reasons beyond the Employee's control (e.g., injury, illness, or death), other than termination for just cause, the Department may, in its sole discretion, waive all or part of the lability owed by the Employee. Any such waivers must be approved in writing by both the Fire Chief and the Mayor.
- 7. If any part of the Agreement is found to be invalid or unenforceable, the other parts remain valid and enforceable, and the Employee agrees, represents, and warrants that they will be held to any applicable repayment of Sign-on Bonus/Retention Bonus.

BY SIGNING BELOW, the Employee certifies that he/she has not accepted a financial incentive for accepting employment at the City, other than as described in this Agreement.

The FDC will consist of 11 voting members, 10 of which will be appointed by the City Mayor and subject to approval by the City Council. All members must be members of the Fairbanks community. One of the voting members will be appointed by the Fairbanks North Star Borough (FNSB) Mayor, subject to confirmation by the Borough Assembly. All appointments of the public members shall be for three-year terms, without compensation. The City Mayor shall serve as the non-voting Chairperson of the FDC. The Mayor may appoint a chairperson from the membership of the FDC. If the Mayor appoints a chairperson, the person will remain a voting member and will serve a one-year term as chairperson. The FDC will choose a vice chairperson from among its members. The person chosen will serve a one-year term as vice chairperson. When the term of the chairperson expires, the vice chairperson will become the chairperson, and the FDC will choose a new vice chairperson from among its members. If the Mayor chooses to serve as the chairperson, the vice chairperson will not progress to the chairperson position. The Mayor will remain a non-voting member of the FDC even if not serving as chairperson. The FDC may organize committees and adopt administrative rules and procedures to accomplish its purposes.

Meetings

A quorum shall be necessary to conduct a meeting. A quorum shall consist of six public voting members of the FDC. The business of the FDC shall be transacted by a majority vote of voting members present after a quorum is established. All meetings shall be held, and notices and agendas shall be posted, in compliance with the Alaska Open Meetings Act. Meetings are held on the second Tuesday of each month at 5:30 p.m. in the City Council Chambers at City Hall. Minutes of FDC proceedings shall be kept and filed in accordance with applicable laws dealing with public records. In all matters of parliamentary procedure not covered by rules and procedures adopted under Ordinance No. 5939, the current version of Robert's Rules of Order will govern. The FDC shall keep permanent records or minutes of all meetings. The minutes shall promptly be filed in the office of the City Clerk and shall be open to public inspection. The City Clerk shall supply the FDC with administrative support.

The Building Code and Landscape Review and Appeals Commission consists of nine regular members appointed by the Mayor, subject to confirmation by the City Council, and each member shall serve a five-year term. The members of the Commission must reside or work within the City and have experience with the design or construction of structures or with landscaping. The Building Official shall be an ex officio member of the Commission, who may provide information and recommendations but may not vote on any matter. Two alternate members are appointed by the Mayor, subject to City Council confirmation, to serve in the place of any absent member or otherwise assist the Commission as directed by the chairman. A secretary, who need not be a Commission member, shall be selected by its regular members. The composition of the commission must be as follows: (1) Two structural engineers; (2) Two architects; (3) One electrical engineer; (4) One mechanical engineer; (5) One architect or landscape architect; (6) Two general construction contractors; (7) Two alternates with experience in construction or design.

Meetings

Meetings of the Building Code and Landscape Review and Appeals Commission are called by the chairman or a majority of the regular members. All meetings shall be open to the public. A majority (five members) of the Commission shall constitute a quorum, and a majority vote of those present and voting shall be necessary to carry any question. Minutes shall be kept as a permanent record of all meetings and shall be filed in the Office of the City Clerk.

City of Fairbanks Permanent Fund Review Board Quarterly Meeting Minutes January 17, 2022

The Permanent Fund Review Board (PFRB) convened at 3:35 p.m. in the City Council Chambers to conduct a quarterly meeting.

Bernard Gatewood moved, and Dave Owen seconded to approve the minutes from the October 13, 2021 meeting. The PFRB unanimously agreed.

Margarita Bell reviewed the account's performance through December 31, 2021:

- \$157,040,678 Balance including accrued income
- \$ 3,274,199 Dividend and interest earnings
- \$ 6,441,245 Realized gain
- \$ 8,719,353 Unrealized gain
- \$ (108,179) Management and custodial fees
- \$ 18,326,618 Earnings, net of expenses

The City received \$426,357 in deposits as of December 31, 2021. The 2021 draw was made on December 13, 2021 in the amount of \$5,833,254 to the general fund (\$5,185,115) and capital fund (\$648,139).

Brandy Niclai reported that the balance of the fund was \$155,284,532 on January 13, 2022.

Brandy Niclai presented information about APCM Model 6; an investment strategy to meet the expected goals of the permanent fund of asset preservation and budgetary stabilization. Model 6 will have a higher risk but will provide the 4.5% distribution rate while preserving purchasing power at a 2% inflation rate. Model 6 would require a change in the code to add alternative beta and high yield bonds asset classes.

PFRB members discussed APCM Model 6. Patty Mongold inquired about the transition; Brandy Niclai responded that it would take one month. Dave Owen inquired about the risk of high yield bonds; Brandy Niclai responded that high yield bonds are not as risky as investing in stock. Valerie Therrien

inquired about the 2% inflation rate with the current inflation being higher; Brandy Niclai responded that 2% is the Federal Reserve objective. Valerie Therrien made a motion to move forward with Model 6, Bernard Gatewood seconded the motion. PFRB unanimously agreed.

Brandy Niclai presented the market outlook. The market is still transitioning from recovery to expansion. Developed economic growth is expected to be higher than the trend while emerging market growth is expected to be lower than the trend. Monetary policy will be tighter but remain accommodative with rates below neutral. Inflation, supply chain issues, and tight labor markets are expected to gradually improve. There are still key risks involving policy mistakes in timing, inflation expectations, and coronavirus variants. The mid-cycle investing selectivity with underweight global fixed income asset classes; overweight equities and alternatives asset classes; and emphasis on sectors and countries levered to spending have been successful for the portfolio.

Brandy Niclai presented a portfolio review for the fourth quarter. She stated that the portfolio allocation was slightly positive over the quarter as equity outperformed fixed income; however, the overweight to cash dampened the positive effects. An overweight to credit was a contributor to performance during the quarter and an underweight to 30yr bonds due to anticipating interest rate increases detracted from relative performance. The combined equity allocation returned 7.25% and the combined fixed income allocation returned 0.20% for the quarter.
