# FAIRBANKS CITY COUNCIL REGULAR MEETING MINUTES, SEPTEMBER 11, 2017 FAIRBANKS CITY COUNCIL CHAMBERS 800 CUSHMAN STREET, FAIRBANKS, ALASKA

The City Council convened at 7:00 p.m. on the above date to conduct a Regular Meeting of the Fairbanks City Council at the City Council Chambers, 800 Cushman Street, Fairbanks, Alaska, with Mayor Jim Matherly presiding and with the following Council Members in attendance:

Deputy City Clerk Emily Braniff read aloud the Mission Statement of the City of Fairbanks.

# **INVOCATION**

The Invocation was given by Deputy Clerk Braniff.

# **FLAG SALUTATION**

Mayor Matherly led the Flag Salutation.

Mayor Matherly spoke to the horrible tragedy that occurred on September 11, 2001, when over 3,000 people were killed. He spoke to the honored first responders, fire fighters and police officers who ran toward the fallen towers hoping to save lives. He drew attention to a steel cross that had been cut out of the twin tower building as well as some other memorabilia from some of the fire fighters who responded that day.

## **CITIZEN'S COMMENTS**

<u>Brittany Smart, 907 Terminal Street, Fairbanks</u> – Ms. Smart thanked Mayor Matherly for the 9/11 presentation and shared her memory of visiting ground zero after it happened. She spoke

about the Borough's Central Recycling Facility grand opening and thanked Mayor Matherly for attending the event. She stated that there will be a "Clear the Air" conference later in the month at Wedgewood Resort, and she encouraged everyone to take a flyer. Ms. Smart stated that the downtown Fairbanks community planning meeting is scheduled for September 27 from 6-9 p.m. She reported that she will soon be on personal leave but that Ms. Krista Major would be filling in for her while she is out of the office.

Representative Tammie Wilson, 301 Santa Claus Lane, North Pole – Rep. Wilson asked if the City of Fairbanks Building and Fire Departments could inspect properties outside the City. She stated that developers wait long periods of time for a State inspector to inspect properties, and deals end up falling through. She stated the State Fire Marshal is way behind, and the State is too broke to hire more staff. She spoke of a specific situation that occurred with a project in North Pole.

**Mr.** Cleworth asked how many State inspectors are in the area. Ms. Wilson stated plans are not inspected locally; she stated that the process is statewide—you put in your plans and wait in line.

<u>Tim Berg, 3536 Vian Way, Fairbanks</u> – Mr. Berg reported that his wells have tested positive for PFCs, and he asked where he falls in the water hook-up list. He stated one well is over the limit and one is not; he asked what the City is planning to do for him.

**Mr. Pruhs** asked Mr. Berg if he has a water holding tank; Mr. Berg stated he that he does have a holding tank. **Mr. Pruhs** stated the City would hook him up but that he would not get the \$2,500 credit with the water company because he is currently hauling water. **Mr. Pruhs** stated the City would get him hooked up as soon as possible.

Morgan Evans, 302 Cushman Street, Fairbanks – Mr. Evans stated that Rep. Wilson's testimony compelled him to speak. He stated he has been working to get inspections from the Anchorage Fire Marshal all summer long, but it has taken them months and months to get back to him. He reported it is a much faster process when dealing with the City of Fairbanks; he stated they only take a couple of weeks.

<u>Frank Turney</u>, 329 6th Avenue, Fairbanks – Mr. Turney stated he hopes the City will do the right thing and pay for everyone's water service; he added that the City is the reason they have to hook up to the water. He spoke to the importance of remembering everyone who died on September 11, not just the first responders. He spoke to the conspiracy theories that came about after the attacks. Mr. Turney stated that many people do not shovel their sidewalks, and many businesses do not plow their parking lots.

Fatima Mancuso, 3350 Holden Road, Fairbanks – Ms. Mancuso stated the City should have to pay for her water because they are the reason she has to hook up to water service. She stated her family should be compensated for the 33 years they have lived at the property without knowing about the contamination. She stated she did not care about the City's budget problems and that the City should fear being sued. Ms. Mancuso spoke about concerns for the health of her and her family. She stated she has been exposed to the contamination her entire life and that paying for two years' of water service is not adequate compensation. She stated the soil has not been tested and shared concern about animals being affected. She stated she has been brushed off and has

not received information others were provided by the City. She stated that Alaskans seem to have a laissez-faire attitude toward environmental issues.

**Ms. Therrien** asked Ms. Mancuso if she would waive her claims against the City if the City paid for unlimited water. Ms. Mancuso stated that she feels people would not resort to those types of things if they had felt like they were being heard and taken care of. Ms. Mancuso stated that there have been no neighborhood notifications about the agenda item pertaining to the contamination issue. **Ms. Therrien** clarified that the ordinance is only up for advancement at the meeting, not adoption. Ms. Mancuso stated that she and her father are engineers and that she has done undergrad studies on water contamination; she added that many people are not even aware of the contamination issue. Ms. Mancuso stated her family is used to well water and that the usage on their last water bill was 5,000 gallons.

**Ms. Rogers** asked Ms. Mancuso who at the City brushed her off. Ms. Mancuso stated she called the City Engineering Department, and she was told her property is far enough from the plume that she did not need to worry. She reported being so concerned about it that she persisted and insisted her water be tested. **Ms. Rogers** acknowledged her concern. Ms. Mancuso stated she is calling everyone to get information; she stated that there should be more public notification. She stated two years of "free" water service is ridiculous.

<u>David Berry, 3174 Davis Road, Fairbanks</u> – Mr. Berry stated he has spoken to the Council before, and he was guaranteed he would be made whole. He stated he would like the City Attorney to give him the definition of "being made whole" and he would like to know what the Council's definition of being made whole is. **Ms. Huntington** clarified that Council members can only ask questions during public comment; she stated they can address citizens' concerns under Council members' comments. Mr. Berry stated his family has not been made whole.

Mr. Pruhs asked Mr. Berry if he read Ordinance No. 6060. Mr. Berry stated he only heard about the meeting the day before and that he had not had time to read the ordinance. He stated if a person has a milk cow and someone comes and kills the cow then offers to sell milk back to you, you would not feel whole. Mr. Berry stated it is the same for the City of Fairbanks contaminating his well; he stated that two years of free water does not make him whole. He stated any court of law would arrive at the same conclusion. Mr. Pruhs asked Mr. Berry to read the ordinance and come to the next meeting to express his concerns for what the Council could do to make the situation better. Mr. Berry stated he heard that \$2.4 million dollars was set aside for the water hook up project which has not yet happened. Mr. Pruhs again requested that Mr. Berry read the ordinance so he can let the Council know what changes he would like to see.

Mr. Berry stated he wanted an opinion from the City Attorney about being made whole. Mayor Matherly implored Mr. Berry to read the ordinance; he stated he personally went to Mr. Berry's house twice and he can see the water connection is being made. Mr. Berry asked which ordinance he is supposed to take a look at; Mayor Matherly stated it is Ordinance No. 6060 that they discussing. Mr. Berry whether the ordinance was just being proposed at this Council meeting; Mayor Matherly clarified the ordinance is just being introduced. Mr. Berry stated he wants answers about being made whole and about what was encumbered for the project. He stated the work is not the only part of being made whole.

<u>Michael Ferrell, P.O. Box 83327, Fairbanks</u> – Mr. Ferrell spoke to the forms the people at the Visitor's Center provided him with, and he reported that the numbers are different than those provided by the City Clerk's Office. Mr. Farrell spoke to the bonus program which was not reported to the City but was reported to the federal government. He asked why the Council is not taking an issue with the salary of the top employees at the Visitor's Center.

<u>Tom Benson, 3330 Holden Road, Fairbanks</u> – Mr. Benson stated he owns several plots of land in the contaminated area that he would like to develop. He stated that the City should have to pay for those hook-ups also. He stated the future costs should be covered fully because the City is responsible for the contamination.

<u>Arlette Eagle-Lavelle</u>, 828 8th Avenue, Fairbanks – Ms. Eagle-Lavelle reported on the many events that took place at the Taphouse over the summer and stated that the events raised \$44,286 for good causes in the community. He stated that one of her employees donated all of his tips to the causes. Ms. Eagle-Lavelle stated when she opened the Taphouse she did not want it to be considered a bar and that she thinks they are proving it to be an asset to the community. She expressed hope that she can use the outdoor serving area again in the future.

**Mr.** Cleworth stated Ms. Eagle-Lavelle had a great summer but that blocking the road when it is not under construction probably will not happen. He stated the City owns some property between 1st and 2nd Avenue that she could possibly use. Ms. Eagle-Lavelle stated she knows the space he is referring to but that she is concerned about pigeons falling off the Polaris Building onto patrons. She reported she also sees young teenagers breaking into the Polaris Building and questioned what would stop them from vandalizing her space.

<u>Dan Peters, 2604 Davis Road, Fairbanks</u> – Mr. Peters asked the Council to support onsite consumption for cannabis. He asked everyone to vote no on Proposition 1, and he asked the Council to support the marijuana licenses on the agenda. He stated people should not be penalized because they have a holding tank, and the City should pay the water service for those who have them.

<u>Victor Buberge, P.O. Box 58192, Fairbanks</u> – Mr. Buberge thanked Public Works for focusing on the potholes on the Southside.

<u>Linda Kershner</u>, 3455 <u>Vian Way</u>, <u>Fairbanks</u> – Ms. Kershner stated she attended the Finance Committee meeting relating to the water ordinance because her family owns two properties in the contamination zone; she stated that the City will only hook up one of them. She stated her family has a well on the property which services their house and a duplex on the adjacent property. Ms. Kershner stated the City contaminated her groundwater, and she should not have to pay \$140 for water service. She stated if the City does not hook up the duplex it would decrease the property value. She stated there are many people in her neighborhood that have major health problems.

**Mr. Pruhs** stated the ordinance affects those who have water needs at the present time only.

Hearing no more requests for public comment, **Mayor Matherly** declared Public Testimony closed.

Mayor Matherly called for a five minute recess.

**Mr. Pruhs**, seconded by **Ms. Huntington**, moved to APPROVE the Agenda and Consent Agenda.

Mayor Matherly requested that the Executive Session be removed from the Agenda.

Mr. Pruhs pulled Ordinance No. 6060 from the Consent Agenda.

Mayor Matherly called for objection and, hearing none, so ORDERED.

Deputy City Clerk Braniff read the Consent Agenda, as Amended, into the record.

**Mayor Matherly** stated that the Council would hear the renewals for the different businesses separately. He called for public comment on The Grass Station, LLC license.

**Ms. Therrien**, seconded by **Ms. Huntington**, moved to WAIVE PROTEST on The Grass Station, LLC Retail Marijuana Store License Application for Renewal.

<u>Frank Turney</u> – Mr. Turney spoke in favor of the retail marijuana license. He stated the place is nice and clean and is operated very professionally. He reported that the edibles they sell are delicious.

<u>Gary Evans, 1326 Cushman Street, Fairbanks</u> – Mr. Evans thanked Mr. Turney for his kind words about his store. He stated that the marijuana issue is controversial and emotional, but he asked the Council to consider the application based on the law and regulations.

**Ms. Huntington** stated the Council gets to see public safety call lists when licenses renew, and she asked if he could speak to the police activity that occurred at the business. Mr. Evans stated the first call was a trespasser who had broken in and needed to be removed so they could start construction. He stated that two of the callouts were caused by intoxicated individuals who walked across Airport Way from Thrifty Liquor and were screaming at customers and employees. Mr. Evans reported the other call involved a person who broke into the shed in the back that was trying to sleep in it.

<u>Morgan Evans</u> – Mr. Evans stated that the Grass Station is paying about \$20,000 a month in sales taxes which must help the City. He stated the business has helped to employ 13 to 14 people, and he spoke in favor of the renewal.

<u>Greg Allison, 1430 Porchet Way, Fairbanks</u> – Mr. Allison spoke in support of the renewal of the retail marijuana license. He spoke highly of others in the industry and stated that they all want to make the community better.

<u>Tom Benson</u> – Mr. Benson encouraged people to vote "no" on October 3.

Hearing no more requests for public comment, Mayor Matherly declared Public Testimony closed.

**Ms. Huntington** stated that there has been very little crime related to the retail marijuana license; she stated that she feels okay with voting to renew their license.

A ROLL CALL VOTE WAS TAKEN ON THE MOTION TO WAIVE PROTEST ON THE GRASS STATION, LLC MARIJUANA RETAIL STORE LICENSE APPLICATION FOR RENEWAL AS FOLLOWS:

Mayor Matherly declared the MOTION CARRIED.

Council Members agreed to consider the GoodSinse, LLC licenses separately.

**Mr. Pruhs**, seconded by **Ms. Therrien**, moved to WAIVE PROTEST on the GoodSinse, LLC Retail Marijuana Store License Application for Renewal.

<u>Frank Turney</u> – Mr. Turney spoke in support of GoodSinse, LLC. He encouraged the Council to approve the application and indicated that liquor is the problem.

<u>Dan Peters</u> – Mr. Peters thanked the Council for supporting his license and asked that they vote in support of renewing it.

**Ms. Huntington** asked Mr. Peters about the police calls to his location. Mr. Peters stated that when they first opened, someone broke in and stole some product. He stated that he has performed major safety upgrades since that time. He stated the second call was the result of staff

error. He stated he is unsure about the 1036 referenced on the list. Police Chief Eric Jewkes stated that a 1036 is a code for a traffic stop which happened to be near the GoodSinse business.

Hearing no more requests for public comment, **Mayor Matherly** declared Public Testimony closed.

Mayor Matherly declared the MOTION CARRIED.

**Mr. Pruhs**, seconded by **Ms. Therrien**, moved to WAIVE PROTEST on GoodSinse, LLC Standard Marijuana Cultivation Facility License Application for Renewal.

<u>Frank Turney</u> – Mr. Turney spoke in support of the cultivation license; he stated that they are putting people to work.

<u>Dan Peters</u> – Mr. Peters spoke in favor of the Council supporting the renewal of his cultivation license. He shared that the new head of the Laborers Union apologized for how GoodSinse was treated by his predecessor. Mr. Peters stated he was told he is a good neighbor and that is exactly what he wanted to prove he could do for the industry.

**Ms. Huntington** asked Mr. Peters to speak to some of the challenges he has faced in getting his facility up and running. Mr. Peters stated that there were many unknowns when he began. He stated he is surprised there are still people trying to defeat the marijuana industry even though it is legal.

<u>Gary Evans</u> – Mr. Evans stated when he was working to get his store up and running he ran into many cutthroat competitors but that the Peters family was kind and helpful at every turn. He stated they were there to offer help and honest advice.

Hearing no more requests for public comment, **Mayor Matherly** declared Public Testimony closed.

Mayor Matherly declared the MOTION CARRIED.

**Ms. Therrien**, seconded by **Mr. Pruhs**, moved to PROTEST the Good, LLC Retail Marijuana Store License until a Certificate of Occupancy is issued by the Building Department.

<u>Cindy Olson, 222 Second Street, Fairbanks</u> – Ms. Olson stated she has lived in her home for over 55 years, and it is within two blocks of the retail location. She stated there are needles in the parking lot across from her home, and she is worried that GOOD, LLC might exacerbate the problem. She reported that there is a school across the street from the license location.

**Ms. Rogers** asked Ms. Olson where the school is; Ms. Olson reported it is in the same mall as Jazzercise. She stated she did not know the address, but it is across the street from her house.

Gayle Garrigues, 1991 Perkins Drive, Fairbanks – Ms. Garrigues stated she came to speak on behalf of the Girl Scouts Council; she stated that they do not want a marijuana store so close to their headquarters. She stated there are often children onsite, and it is too close to a place of learning to have a marijuana store. She stated her office is not technically a school or a church, but because of the nature of their business, they should qualify as a youth facility. She thanked the Council for their service to the community.

**Ms.** Therrien stated she is looking at the map provided by the Borough, and it says that the locations are 672 feet apart. Ms. Garrigues stated she did not know the exact distance, but if it says 672 feet that must be the case.

Frank Turney – Mr. Turney spoke in favor of GOOD, LLC getting their retail license.

<u>Shaun Huot, Representative of Protect Cannabis Access, Fairbanks</u> – Mr. Huot stated that crime has not increased since marijuana has been legalized. He stated that if the Council is not going to allow for a marijuana store, they should ban all alcohol establishments in the same area.

<u>Dan Peters</u> – Mr. Peters stated he has met with the owners of GOOD, LLC and that they are good community members with good hearts and intentions. He stated that Mr. Allison has done a lot of community outreach, and he will not allow youth to purchase marijuana.

<u>Greg Allison</u> – Mr. Allison stated he understands people's concerns with the industry, but his business will follow the industry's best practices. He stated he is proud to be a leader in the industry, and he looks forward to giving back to the community. He thanked his team members for working hard every day to better the community. Mr. Allison stated he is ecstatic about opening a business in the City, and invited anyone with questions to call him.

**Mr. Pruhs** asked Mr. Allison if he is aware of the ballot question that will be presented in less than a month; he stated it has the potential to shut his business down. Mr. Allison replied that he is aware of the issue, and it is a risk they are willing to take.

**Ms. Huntington** thanked Mr. Allison for attending and for his testimony. She stated that when the license is up for renewal, the Council will be provided with call out history from the Police Department. **Ms. Huntington** stated those kind of issues are important to the Council, and she asked Mr. Allison if he is aware of the importance the Council places on those reports. Mr. Allison stated he would attend any meeting to discuss any issues they may have in full detail. **Ms. Huntington** asked Mr. Allison what the outside of his business would look like. Mr. Allison stated his storefront is low-key, and his sign will only say GOOD in black and white. He stated the door has a mural painted on it.

**Ms. Rogers** asked what kind of personal interest he has in helping keep the community safe. Mr. Allison stated that each time a sale takes place the message will be to discourage driving under the influence; he stated that his customers will be encouraged to consume responsibly. He stated that safety has to be consistent in the messaging, and every patron needs to hear it.

**Ms. Therrien** asked about the other owners of the LLC. Mr. Allison introduced Christian Hood and stated they are fortunate to have her as the owner. He stated that Linda Lewis is another owner, but she was unable to attend the meeting.

<u>Gary Evans</u>, 1326 <u>Cushman Street</u>, <u>Fairbanks</u> – Mr. Evans stated he has worked with Mr. Allison quite a bit over the past few months and that he knows him to be a stand-up guy who cares about the community. He stated children will not be allowed inside a marijuana store. He stated that parents have tried to bring their kids into his store, but he turns them around immediately.

Hearing no more requests for public comment, Mayor Matherly declared Public Testimony closed.

**Mr. Pruhs** stated GOOD, LLC is the first marijuana store in the City on the north side of the Chena River. He stated that he has not heard complaints from any of the other business owners in the mall. He stated that density is not an issue, so he would be voting in favor of the license.

**Ms. Therrien** stated she heard Ms. Garrigues' testimony but that she does not believe that Girl Scouts will be breaking down the door to get into the marijuana facility.

**Mr. Bagwill** stated he does not have a personal vendetta against the licenses presented, but he will be voting against the license. He stated that no one should ever trust the bling of a drug dealer. He stated he understands that the industry brings revenue to the City, but he does not see that it increases the quality of life for anyone outside of its medicinal uses. He commended owners for trying to get their businesses up and running. **Mr. Bagwill** stated the industry won the vote to legalize by a slim margin, and he will not forget about those who voted "no." He stated that he feels the marijuana industry is not a safe direction for the future.

**Ms. Rogers** stated that while she is not in favor of marijuana, the applicants have followed the path to opening a legal business, so she will vote in their favor.

**Mr.** Cleworth stated he has voted for and against marijuana license issues but that he has to vote against this one because of its location. He stated it is a sensitive use area and that he needs to

listen to the people who live in the area; he stated that based on earlier testimony, the residents do not want it in their neighborhood.

Mayor Matherly declared the MOTION CARRIED.

# **MAYOR'S COMMENTS AND REPORT**

**Mayor Matherly** stated that he used his comments to speak to the tragedy that occurred on September 11, 2001 earlier in the meeting.

## **NEW BUSINESS**

a) Ordinance No. 6060 – An Ordinance to Provide a Stipend and Resolutions to Residents and Businesses with Drinking Water Contamination by Perfluorinated Compounds (PFCs). Introduced by Council Members Pruhs and Rogers.

Mr. Pruhs, seconded by Ms. Huntington, moved to ADVANCE Ordinance No. 6060.

**Mr. Pruhs** stated the issue is an emotional one because it deals with contamination of private property. He stated the City is proposing to pay for residents' water hook-up and two years of water service. He stated no scenario on how to deal with the problem is perfect because of the nature of the problem itself. **Mr. Pruhs** spoke to the different categories of properties that are included in the contamination zone and to what kind of service they can expect the City to cover. He stated that the Department of Environmental Conservation (DEC) was impressed with how quickly the City has responded to the contamination issue.

Ms. Huntington asked if the City would pay for two years of service or for a \$2,500 stipend.

**Mr. Pruhs** stated the \$2,500 proposal is based on average household use; he stated that it should cover two years' worth of water service.

**Ms.** Therrien asked Attorney Ewers if the City would recover all the money paid towards water service. Mr. Ewers responded that it is likely the City would not recover all the funds. **Ms.** Therrien stated that she was not satisfied with a two-year cap on stipend for water bills.

**Ms. Huntington** asked whether the Council should pay for residents' water service costs as long as they own their home or for as long as they have lived at the location that has contaminated water. She stated the contamination started in the 1990s. **Mr. Pruhs** stated there is no way to prove when the contamination hit a property, so it is an unknown variable. **Ms. Huntington** asked Mr. Fox if there is a way to pinpoint when a home became contaminated. She indicated

that she could not put a number on making someone whole. She asked the Council what their thoughts were on alternatives to the two-year proposal.

**Ms. Rogers** asked about the meaning of being "made whole." **Mr. Pruhs** stated it is up for interpretation and could mean different things to different people. **Ms. Rogers** spoke to the issue of communication; she stated that communication is key in identifying what people interpret as being made whole. She shared concern that there was a citizen who was not properly updated on the progress of the project.

**Mayor Matherly** stated he gets a lot of phone calls from residents, and he has been authorized by Mr. Fox to give out his cell phone number. He stated the situation has been addressed at a very rapid pace and that he cares about every single property in the contamination plume. He reported that 1,000 feet of water main piping was laid earlier that day.

**Mr.** Cleworth reported that many entities around the State have used the Fire Training Center, including the military and the university. He stated there needs to be some kind of parameter as to how much the City is willing to pay. He stated that no matter what happens he believes there will be lawsuits.

**Mr. Pruhs** stated there was not supposed to be wells in the area because there are so many different sources of contamination in the vicinity.

**Ms. Huntington** stated it would be helpful to discuss the parameters of the timeframe to pay for residents' water at the Finance Committee meeting. She stated the City cannot pay for everyone's water forever because it would go broke.

Mayor Matherly declared the MOTION CARRIED.

b) Ordinance No. 6061 – An Ordinance Amending Fairbanks General Code Section 70-321 Regarding Responsibility for Removal of Snow and Ice from Sidewalks and Moving Snow from Private Property onto a Street or Sidewalk. Introduced by Mayor Matherly.

ADVANCED on the CONSENT AGENDA.

# **COMMUNICATIONS TO COUNCIL**

a) Recommendation for Appointment to the FNSB Planning Commission (POSTPONED from the Regular Meeting of August 21, 2017; motion to APPROVE was made by Mr. Pruhs, seconded by Ms. Huntington)

**Mr. Pruhs** asked if Mr. Sims had worked on the FNSB Planning Commission; **Mayor Matherly** reported that he had not; he added that Mr. Sims was the only applicant for the position.

Mr. Cleworth spoke to a conditional use permit appeal that the Council was involved with a couple of years prior for a homeschool/business office in Slaterville. He stated that many residents in the area opposed the conditional use permit, but the Planning Commission ultimately approved the conditional use permit. He explained that the residents appealed the decision, and the City Council served as the Board of Adjustment. Mr. Cleworth stated that the Council overturned the Planning Commission's decision and not long after that, the Borough amended their Code to remove the City Council as the Board of Adjustment for Planning Commission appeals. Mr. Cleworth stated the Borough now handles appeals in-house because they want to control the process. He expressed concern with placing a longtime Borough employee on the Planning Commission as a City representative; he stated it is imperative that City representatives have the City's best interest in mind. He stated he will not support the appointment.

**Ms. Therrien** stated she has worked with Mr. Sims, and he has proven to be an honorable man; she stated he is a good candidate for the position.

**Mr. Bagwill** asked how soon Mr. Sims would begin after being recommended by the Council; he stated that the term will run out at the end of 2017. He stated that if any issues arise, the Council could choose not to reappoint him.

Mr. Cleworth asked Mr. Ewers when the Planning Commission will take up the litigation. Mr. Ewers explained that the Superior Court ruling on the appeal was remanded to the Planning Commission and to the Board of Adjustment for a determination on whether the procedural errors were significant. He indicated that he would have to receive permission from the Borough Assembly to continue to provide representation in the appeal since they are now serving as the Board of Adjustment. Mr. Ewers stated that since the deadline is quickly approaching and because the City is no longer the Board of Adjustment, he has moved to withdraw from the case. He stated he is not sure about the timeline of the appeal or who may represent the Borough Assembly as the Board of Adjustment; he stated that an attorney in the Borough Attorney's Office is representing the Planning Department in the appeal.

A ROLL CALL VOTE WAS TAKEN ON THE MOTION TO APPROVE THE RECOMMENDATION FOR APPOINTMENT TO THE FNSB PLANNING COMMISSION AS FOLLOWS:

Mayor Matherly declared the MOTION CARRIED.

b) Memo Regarding Change Order for Bjerremark Subdivision Improvement Project

APPROVED on the CONSENT AGENDA.

# **COUNCIL MEMBERS' COMMENTS**

**Mr. Bagwill** stated he will have to call in for the next Council meeting because he will be in Kansas City. He spoke to the events that occurred on September 11, 2001, and to where he was

when it happened. He stated he honors all those who lost their lives on that tragic day in New York. He stated that being made whole is making something like it was; he indicated that there is no way to make the contaminated property residents whole. He asked how the contamination issue came about and stated that everyone is working together to remediate the problem.

Mr. Cleworth stated the Building Department needs to serve the citizens of the City first and foremost, but if they have extra time and they find a way to bill for it they could inspect other projects outside the City. He spoke to the citizen concern about wages in other organizations, and he shared that he is surprised with the wages people are being paid. He spoke specifically to the wages at Explore Fairbanks and the Fairbanks Economic Development Corporation (FEDC) since they receive annual funding from the City of Fairbanks. He commented that some employees are being paid a higher wage than the highest paid City employee. Mr. Cleworth suggested a discussion on limiting the salary of employees of organizations that receive bed tax funds. He stated that the City Council unanimously approved a resolution in support of a smokefree Alaska. He shared that the Borough Assembly will consider a resolution requesting that the State of Alaska Marijuana Control Board adopt regulations allowing onsite consumption of marijuana or approved designated areas for onsite consumption in licensed retail establishments. Mr. Cleworth asked the Council Member representing the City at the next Borough Assembly meeting to speak against the ordinance because it conflicts with City legislation. He thanked Mayor Matherly for speaking to the September 11, 2001 tragedy earlier in the evening.

**Mr. Pruhs** stated he does not look at the salaries within organizations the City allocates bed tax funds to; he stated that he looks only their budgets. He stated he received a call from Vivian Stiver who asked him to speak at an event on Friday evening at Raven's Landing. He thanked the Mayor for speaking to the September 11 tragedy.

**Ms. Therrien** stated she attended the September 11 memorial at the Fire Department and commented on how few people were at the event. She stated people are still suffering from the tragedy. She stated she feels badly for the residents living on contaminated property because there is no way to make them whole; she stated she would like to extend the stipend beyond two years.

**Ms. Rogers** thanked everyone for attending the recent memorial. She expressed appreciation for the silent moments at the event, because remembering and honoring the fallen is important. She indicated that the Director of Explore Fairbanks deserves the salary that is paid.

**Ms. Huntington** suggested the Council be consistent with members of the public; she stated that if they are going to make changes to the order of business, they need to be consistent in doing so.

## **CITY ATTORNEY'S REPORT**

City Attorney Ewers stated that he and Clerk Snider have been working with Mr. Bagwill to draft proposed amendments to the City's Order of Business; he stated that an ordinance will be introduced soon.

# **ADJOURNMENT**

Mr. Bagwill, seconded by Ms. Huntington, moved to ADJOURN the meeting.

Mayor Matherly called for objection and, hearing none, so ORDERED.

Mayor Matherly declared the meeting adjourned at 11:52 p.m.

A "retail marijuana store" is a listed permitted use in the General Use 1 (GU-1) zoning district pursuant to FNSBC 18.84.020.A.1. Zoning permit # 17471 was issued to use an 842 square foot unit in a commercial strip mall for a retail marijuana establishment. Because the retail marijuana establishment is not "adjacent to a lot upon which a principal building used as a dwelling" this use does not require a conditional use permit.

FNSBC 18.96.240.A.3 addresses buffer distances for commercial marijuana establishments. More specifically, FNSBC 18.96.240.A.3.c establishes the distance of 100 feet from "youth centers, group homes serving persons ages 18 and under, public swimming pools, state licensed day care facilities, arcades, state licensed substance use treatment provider or facility providing substance abuse use treatment, church buildings and residential zones (RE, RR, SF, TF, MF, MFO)." Buffer distances are measured from the "nearest public entrance of a commercial marijuana establishment" to the "principal building containing other uses listed in subsections (A)(3)(a) through (c)" of FNSBC 18.96.240.A.3, in accordance with FNSBC 18.96.240.A.3.d.

The proposed marijuana establishment is not located within any known sensitive use buffers listed in FNSBC 18.96.240.A.3. There is a TF residential zoning district approximately 142 feet away and a daycare facility approximately 485 feet away to the west, across Noyes Slough. Both of these uses meet the required buffer of 100 feet. Please see the attached map identifying approximate distances.







#### West Front Andrew, LLC

#### A Member-Managed Limited Liability Company

#### **Alaska Entity # 10011288**

THIS OPERATING AGREEMENT (the "Agreement") is made and entered into by: **Buik Hong** as sole member and manager of **West Front Andrew**, **LLC** (hereinafter the "Company").

This Agreement (unless amended) shall continue in full force and effect, and be binding upon each individual and/or business entity as may be subsequently admitted to the Company. Any individual and/or business entity subsequently admitted to the Company shall be known as and referred to as "Member."

As long as the Company has only one member, the plural term "Members," wherever it appears in this Agreement, shall be interpreted as referring to the Sole Member of the Company.

#### **ARTICLE I - Company Formation and Registered Agent**

- 1.1 FORMATION. The Company was formed on March 8, 2013, and is subject to the provisions of the Alaska Revised Limited Liability Company Act (the "Act") in effect as of this date of the Company was formed. Articles of Organization were filed with the State of Alaska Department of Commerce and Economic Development on March 8, 2013, and a Certificate of Organization was issued effective March 08, 2013. The Company was issued an Alaska Business License (#988058). Any additional documentation as may from time to time be required has been filed with the State of Alaska at the designated office for maintaining such records.
- 1.2 NAME. The name of the Company shall be: West Front Andrew, LLC.
- 1.3 PRINCIPAL PLACE OF BUSINESS / REGISTERED AGENT. The name of the registered agent and location of the principal business office of the Company shall be:

Buik Hong 201 Old Steese Highway, Suite 2 Fairbanks, AK 99701-1739 or at such other place as the Member(s) may from time to time select.

- 1.4 TERM. The Company has commenced doing business in calendar year 2013, and the business shall continue in perpetuity, unless sooner terminated as provided in this Agreement, or by operation of law, or at the direction of the Member(s).
- 1.5 **BUSINESS PURPOSE**. The initial purpose of the Company is "[t]o operate a retail smoke, gift and souvenir shop and any other lawful businesses as allowed." The Company is authorized to engage in any lawful act or activity for which a Limited Liability Company may be formed under the Limited Liability statutes of the State of Alaska.
- 1.6 **NAMES AND ADDRESSES OF MEMBERS**. The name and place of residence of each Member is as follows:

Buik Hong - 201 Old Steese Highway, Suite 2, Fairbanks, AK 99701-1739

1.7 **ADMISSION OF ADDITIONAL MEMBERS**. Except as otherwise provided in this Agreement, no additional Members may be admitted to the Company without the prior unanimous written consent of the then-existing Members.

#### **ARTICLE 2 - Capital Contributions**

- 2.1 **INITIAL CONTRIBUTIONS**. The Members shall initially contribute to the Company capital in the form of cash or cash equivalent, with a combined value of not less than \$5,000.
- 2.2 ADDITIONAL CONTRIBUTIONS / INTEREST. No Member shall be obligated to make any additional contribution to the Company without the prior unanimous written consent of the Members. Members are not entitled to interest or other compensation for or on account of their capital contributions to the Company, except to the extent, if any, expressly provided in this Agreement.

#### **ARTICLE 3 - Profits, Losses and Distributions**

- 3.1 **PROFITS/LOSSES**. For financial, accounting and tax purposes, the Company's net profits or net losses shall be determined on an annual basis and shall be allocated to the Members in proportion to each Member's relative capital interest in the Company, and as may be amended from time to time in accordance with Treasury Regulation 1.704-1 and such other Regulations as may apply.
- 3.2 **DISTRIBUTIONS**. The Members shall determine and distribute available funds annually, or at more frequent intervals as they deem fit. "Available funds,"

as referred to herein, shall mean the net cash of the Company available after appropriate provision is made for expenses and liabilities, as determined by the Members. Distributions in liquidation of the Company or in liquidation of a Member's interest shall be made in accordance with the positive capital account balances pursuant to Treasury Regulation 1.704-l(b)(2)(ii)(b)(2). To the extent a Member shall have a negative capital account balance, there shall be a qualified income offset, as set forth in Treasury Regulation 1.704-l(b)(2)(ii)(d).

#### **ARTICLE 4 - Management**

- 4.1 MANAGEMENT OF THE COMPANY. The Members, within the authority granted by the Act and the terms of this Agreement, shall have the complete power and authority to manage and operate the Company and make all decisions affecting its business and affairs. Such authority includes, but is not limited to, all decisions as to: (a) the sale, development, lease or other disposition of the Company's assets; (b) the purchase or other acquisition of other assets of all kinds; (c) the management of all or any part of the Company's assets; (d) the borrowing of money and the granting of security interests in the Company's assets; (e) the pre-payment, refinancing or extension of any loan affecting the Company's assets; (f) the compromise or release of any of the Company's claims or debts; and (g) the employment of persons, firms or corporations for the operation and management of the Company's business.
- 4.2 **DECISIONS AND DOCUMENTS.** Except as otherwise provided in this Agreement, all decisions and documents relating to the management and operation of the Company shall be made and executed by the Members. If there are two Members, all decisions shall be jointly made. If there are more than two Members, then decisions shall be made by a majority of the Members.
- 4.3 **THIRD PARTIES.** Third parties dealing with the Company shall be entitled to rely conclusively upon the power and authority of a sole Member, or a majority in interest if more than one Member, to manage and operate the business and affairs of the Company.
- 4.4 EXCULPATION. Any act or omission of a Member, the effect of which may cause or result in loss or damage to the Company or any other individual Member(s), if done in good faith to promote the best interests of the Company, shall not subject the Member to any liability to other members.
- 4.5 **INDEMNIFICATION.** The Company shall indemnify any person who was or is a party defendant or is threatened to be made a party defendant, in any pending or completed action, suit or proceeding, whether civil, criminal, administrative, or investigative (other than an action by or in the right of the

Company) by reason of the fact that he is or was a Member of the Company, Manager, employee or agent of the Company, or is or was serving at the request of the Company, for expenses (including attorney's fees), judgments, fines, and amounts paid in settlement, actually and reasonably incurred in connection with such action, suit or proceeding, if the person is determined to have acted in good faith and in a manner he/she reasonably believed to be in the best interests of the Company, and with respect to any criminal action or proceeding, had no reasonable cause to believe his/her conduct was unlawful. The termination of any action, suit, or proceeding by judgment, order, settlement, conviction, or upon a plea of "nolo contendere" or its equivalent, shall not in itself create a presumption that the person did or did not act in good faith and in a manner which he/she reasonably believed to be in the best interests of the Company, and, with respect to any criminal action or proceeding, had reasonable cause to believe that his/her conduct was lawful.

- 4.6 **RECORDS**. The managing Member(s) shall cause the Company to keep at its principal place of business the following:
- (a) a current list in alphabetical order of the full name and current physical address of each Member;
- (b) a copy of the Certificate of Organization and any other documentation evidencing compliance with the Act, as well as the Company Operating Agreement and all amendments;
- (c) copies of the Company's federal, state and local income tax returns and reports, if any, for the three (3) most recent years;
- (d) copies of any financial statements of the Company for the three (3) most recent years.

#### ARTICLE 5 - Salaries, Reimbursement, and Payment of Expenses

- 5.1 **ORGANIZATION EXPENSES.** All expenses incurred in connection with the organization of the Company will be paid by the Company.
- 5.2 **SALARY.** No salary will be paid to a Member for the performance of his or her duties under this Agreement unless the salary has been approved in writing by the Members, or if more than two Members, then by a majority of the Members.
- 5.3 **LEGAL AND ACCOUNTING SERVICES.** The Company may obtain legal and accounting services to the extent reasonably necessary to conduct the Company's business.

#### ARTICLE 6 - Accounting Reports, Tax Returns, Fiscal Year, Banking

- 6.1 **METHOD OF ACCOUNTING.** The Company will use the method of accounting as previously determined by the Member(s) for financial reporting and tax purposes, or such other method as may be recommended by the accountant for the Company.
- 6.2 FISCAL YEAR; TAXABLE YEAR. The fiscal year and the taxable year of the Company is the calendar year.
- 6.3 **CAPITAL ACCOUNTS.** The Company will maintain a Capital Account for each Member on a cumulative basis in accordance with federal income tax accounting principles.
- 6.4 **BANKING.** All funds of the Company will be deposited in a separate bank account in a financial institution, the name and location to be selected at the discretion of the Members, or if more than two Members, then as determined by a majority of the Members. Company funds will be invested or deposited with a financial institution, the accounts or deposits of which are insured or guaranteed by an agency of the United States government.

#### ARTICLE 7 - Transfer/Assignment of Interest/Removal of Member

- 7.1 **SALE OR ENCUMBRANCE PROHIBITED.** Except as otherwise permitted in this Agreement, no Member may voluntarily or involuntarily transfer, sell, convey, encumber, pledge, assign, or otherwise dispose of (hereinafter collectively, "transfer") an interest in the Company without the prior written consent of the other Member, or if more than two Members, then by a majority of the non-transferring Members.
- 7.2 **RIGHT OF FIRST REFUSAL.** Notwithstanding Article 7.1, a Member may transfer all or any part of the Member's interest in the Company (the "Interest") as follows:
- (a) The Member desiring to transfer his/her Interest must first provide written notice (the "Notice") to the other Members, specifying the price and terms on which the Member is prepared to sell the Interest (the "Offer").
- (b) For a period of thirty (30) days after receipt of the Notice, the non-transferring Members may acquire all, but not less than all, of the Interest at the price and under the terms specified in the Offer. If the other Members desiring to acquire the Interest cannot agree among themselves on the allocation of the

Interest among them, the allocation will be proportional to the Ownership Interests of those Members desiring to acquire the Interest.

- (c) Closing of the sale of the Interest will occur as stated in the Offer; provided however, that the closing will occur not more than forty-five (45) days after expiration of the 30day notice period.
- (d) If the other Members fail or refuse to notify the transferring Member of their desire to acquire all of the Interest proposed to be transferred within the 30day period following receipt of the Notice, then the non-transferring Member(s) will be deemed to have waived their right to acquire the Interest on the terms described in the Offer, and the transferring Member may sell and convey the Interest consistent with the Offer to any other person or entity; provided however, that notwithstanding anything in Article 7.2 to the contrary, should the proposed sale to a third person be at a price or on terms that are more favorable to the purchaser than stated in the Offer, then the transferring Member must first re-offer the sale of the Interest to the remaining Members at the more favorable price and terms; provided further, that if a proposed sale to a third person is not closed within six months after the expiration of the 30day period describe above, then the provisions of Article 7.2 will again apply to the Interest proposed to be sold or transferred.
- 7.3 **SUBSTITUTED PARTIES.** Any transfer in which the Transferee becomes a fully-substituted Member is not permitted unless and until:
- (1) Documents and instruments of conveyance necessary or appropriate in the opinion of counsel to the Company to effect the transfer and to confirm the agreement of the transferee to be bound by the provisions of this Agreement; and
- (2) The transferor furnishes to the Company an opinion of counsel, satisfactory to the Company, that the transfer will not cause the Company to terminate for federal income tax purposes, or that any such termination would not otherwise adversely impact the best interests of the Company or the other Members.
- 7.4 **DEATH, INCOMPETENCY, OR BANKRUPTCY OF MEMBER.** In the event of death, adjudicated incompetence, or bankruptcy of a Member, unless the Company exercises its rights under Article 7.5, the successor-in-interest to the Member (whether an estate, personal representative, bankruptcy trustee, or otherwise) will receive only the economic right to receive distributions whenever made by the Company and the Member's allocable share of taxable income, gain, loss, deduction, and credit (the "Economic Rights") unless and until such time as a majority of the other Members as determined on a per capita basis admit the

transferee as a fully-substituted Member in accordance with the provisions of Article 7.3.

- 7.5 **DEATH BUYOUT.** Notwithstanding the foregoing provisions of this Article, the Members covenant and agree that upon the death of any Member, the Company, at its option, by providing written notice to the estate of the deceased Member within 180 days of the death of the Member, may purchase, acquire, and redeem the Interest of the deceased Member in the Company pursuant to the following provision:
- (a) The value of each Member's Interest in the Company will be determined on the date this Agreement is signed, and shall be stated as each individual Member's "capital contribution." The value of each Member's Interest will be re-determined unanimously by the Members annually, unless the Members unanimously decide to re-determine those values more frequently. The purchase price for a deceased Member's interest shall be the value last-determined before the death of such Member; provided however, that if the latest valuation is more than two years before the death of the deceased Member, the provisions of Article 7.5(b) will apply in determining the value of the Member's Interest in the Company.
- (b) If the Members have failed to value the deceased Member's Interest within the prior twoyear period, the value of such Member's Interest in the Company on the date of death, in the first instance, will be determined by mutual agreement of the surviving Members and the personal representative of the estate of the deceased Member. If the parties cannot reach an agreement on the value within 30 days after the appointment of the personal representative of the deceased Member, then the surviving Members and the personal representative each must select a qualified appraiser within the next succeeding 30 days. The appraisers so selected will each then independently determine a fair market value for the Interest. If the Members and personal representative are still unable to agree on a value within 30 days of being selected, then the two appraisers will select a third appraiser within 30 days of reaching an impasse. The third appraiser shall review the values ascribed to the Interest by the first two appraisers, and then solely determine a fair value for the Interest of the decedent. That amount will be final and binding on all parties and their respective successors, assigns, and representatives. The costs and expenses of the third appraiser and any costs and expenses of the appraiser retained but not paid for by the estate of the deceased Member will be offset against the purchase price paid for the deceased Member's Interest in the Company.
- (c) Closing of the sale of the deceased Member's Interest in the Company will be held at the office of the Company on a date designated by the Company,

not later than 90 days after final determination of fair market value of the deceased Member's Interest in the Company. If no personal representative has been appointed within 60 days after the deceased Member's death, the surviving Members shall have the right to apply for and have a personal representative appointed.

- (d) At closing, the Company will pay the purchase price for the deceased Member's Interest in the Company. If the purchase price is less than \$10,000, the purchase price will be paid in cash; if the purchase price is \$10,000 or more, the purchase price will be paid as follows:
  - (1) \$10,000 in cash, bank cashier's check, or certified funds;
  - (2) The balance of the purchase price shall be paid by the Company executing and delivering its promissory note for the balance, with interest at the prime interest rate stated by the primary banking institution utilized by the Company (or its successors and assigns), at the time of the deceased Member's death. Interest will be payable monthly, with the principal sum being due and payable in three equal annual installments. The promissory note will be unsecured and will not have a prepayment penalty.
- (e) At closing, the deceased Member's estate or personal representative must assign to the Company all of the deceased Member's Interest in the Company free and clear of all liens, claims, and encumbrances, and further agrees to execute all other instruments as may reasonably be necessary to vest in the Company all of the deceased Member's right, title, and interest in the Company and its assets.
- (f) On completion of the purchase of the deceased Member's Interest in the Company, the Ownership Interests of the remaining Members will increase proportionately to their thenexisting Ownership Interests.

#### 7.6 ASSIGNMENT BY UNANIMOUS CONSENT OF MEMBERS.

Notwithstanding any of the above provisions of this Article 7, a Member may, with unanimous consent of all of the other remaining members, freely assign the Member's interest in the Company, and upon the terms and conditions as may be agreed upon in a separate writing signed by all members.

#### 7.7 INVOLUNTARY REMOVAL OF MEMBER FOR CAUSE

A Member may be involuntarily removed from the Company if a Member holding a majority interest in the Company, or a combination of Members holding

a majority interest (majority percentage of ownership interest) in the Company finds that any of the following circumstances exist:

- (a) The Member to be removed committed a felony crime, as such crimes are defined under the laws of the State of Alaska, on the Company's business premises or during the course and scope of Company business;
- (b) The Member to be removed recklessly or intentionally engaged in conduct or committed an act or omission that resulted in severe damage to the Company's interests. "Severe damage to the Company's interests" includes but is not limited to:
  - i. Damage or destruction of the Company's property in a manner that results in damages or loss exceeding \$2,000.
  - ii. Harm to a third-party that creates liability on the part of the Company in an amount that exceeds \$2,000.
- (c) The Member to be removed recklessly, knowingly, or intentionally engaged in repeated acts or omissions that harm the interests of the Company, after having been notified by a majority of the other Members that such acts or omissions were harmful to the interests of the Company.

If a Member is removed pursuant to this section (Involuntary Removal of Member) the Member's ownership interest shall be purchased as described in Section 7.5 (Death Buyout) above.

#### ARTICLE 8 - Dissolution and Winding Up of Company

- 8.1 **DISSOLUTION.** The Company will be dissolved on the happening of any of the following events:
- (a) Sale, transfer, or other disposition of all or substantially all of the property of the Company;
  - (b) By agreement of all of the Members;
  - (c) By operation of law; or
- (d) By the death, incompetence, expulsion, or bankruptcy of a Member, or the occurrence of any event that terminates the continued membership of a Member in the Company, unless there are then remaining at least the minimum

number of Members required by law and all of the remaining Members, within 120 days after the date of the event, elect to continue the business of the Company.

- 8.2 WINDING UP. Upon dissolution of the Company (if the Company is not continued as provided above), the Members must take full account of the Company's assets and liabilities, and the assets will be liquidated as promptly as is consistent with obtaining their fair value, and the proceeds, to the extent sufficient to pay the Company's obligations with respect to the liquidation, will be applied and distributed, after any gain or loss realized in connection with the liquidation has been allocated in accordance with Article 3 of this Agreement, and the Members' Capital Accounts have been adjusted to reflect the allocation and all other transactions through the date of the distribution, in the following order:
- (a) To payment and discharge of the expenses of liquidation and of all the Company's debts and liabilities to persons or organizations other than Members;
- (b) To payment and discharge of any Company debts and liabilities owed to Members; and
- (c) To Members in the amount of their respective adjusted Capital Account balances on the date of distribution.

#### **ARTICLE 9 - General Provisions**

- 9.1 **AMENDMENTS.** Amendments to this Agreement may be proposed by any Member. A proposed amendment will be adopted and become effective only upon the written and unanimous approval of all Members.
- 9.2 GOVERNING LAW. This Agreement and the rights and obligations of the parties under it are governed by and interpreted in accordance with the laws of the State of Alaska.
- 9.3 ENTIRE AGREEMENT; MODIFICATION. This Agreement constitutes the entire understanding and agreement between the Members with respect to the subject matter of this Agreement. No agreements, understandings, restrictions, representations, or warranties exist between or among the Members other than those in this Agreement or referred to or provided for in this Agreement. No modification or amendment of any provision of this Agreement will be binding on any Member unless in writing and signed by all the Members.
- 9.4 ATTORNEY FEES. In the event of any suit or action to enforce or interpret any provision of this Agreement (or that is based on this Agreement), the prevailing party is entitled to recover, in addition to other costs, reasonable

attorney fees in connection with the suit, action, or arbitration, and in any appeals. The determination of who is the "prevailing party" and the amount of reasonable attorney fees to be paid to the prevailing party will be decided by the court or courts, including any appellate courts, of by the Arbitrator if the matter is submitted to arbitration.

- 9.5 FURTHER EFFECT. The parties agree to execute other documents as may be necessary to further effect and evidence the terms of this Agreement, as long as the terms and provisions of the other documents are fully consistent with the terms of this Agreement.
- 9.6 **SEVERABILITY.** If any term or provision of this Agreement is held to be void or unenforceable, that term or provision will be severed from this Agreement. The remaining terms and provisions of the Agreement will survive, and the balance of this Agreement will be reasonably construed to carry out the intent of the parties as evidenced by the terms of this Agreement.
- 9.7 **CAPTIONS.** The section captions used in this Agreement are for the convenience of the parties only and will not be interpreted so as to enlarge, reduce, modify or alter the terms and provisions of this Agreement.
- 9.8 NOTICES. All notices required to be given by this Agreement will be in writing and will be effective when actually delivered or, if mailed, when deposited as certified mail, postage prepaid, directed to the address designated for each Member, or to such other address as a Member may specify by notice given in conformance with these provisions to the other Members.

Restricted Access Areas (3 AAC 306.710):

#### Describe how you will prevent unescorted members of the public from entering restricted access areas:

When customers initially enter FAIRDANKS CANNABIS, through the front entrance, they will be restricted to a 6' x 5' Public Access Control Area (PACA) space. The physical perimeter of the PACA will consist of the front entrance door, store walls, an ID check podium and a velvet rope setup. The ID check podium and velvet rope setup will divide the PACA space and the Marijuana Retail Area (MRA). For further PACA layout details, please refer to Form MJ-02, Section 2, Items 1-4.

No member of the public will be allowed past the PACA, into the MRA, until government issued, non-expired photo identification are checked and verified for legitimacy by a trained employee of FAIRDANKS CANNABIS at the ID check podium. The trained employee of FAIRDANKS CANNABIS must ensure the visitor is 21 years of age or over for entry into FAIRDANKS CANNABIS. Only members of the public whose photo identification has been verified will be allowed into the MRA.

The RAA has one point of entry, the RAA entrance, which is located within the store. The RAA entrance will be posted with a sign that says "Restricted access area. Visitors must be escorted." A trained FAIRDANKS CANNABIS employee will be strategically placed at the ID check podium in order to also guard the RAA entrance at all times, during open business hours. All visitors to the RAA must show photo identification as required in 3 AAC 306.350 to prove that they are 21 years of age or older. The trained FAIRDANKS CANNABIS employee posted at the RAA entrance will ensure the ID provided is government issued, non-expired, and verified for legitimacy. Upon verification, a FAIRDANKS CANNABIS employee will produce a visitor identification badge for the authorized visitor before allowing access to the RAA. FAIRDANKS CANNABIS will limit the number of visitors to not more than five visitors for each licensee, employee, or agent of licensee and must be actively engaged in supervising visitors. Should any photo ID presented to the trained FAIRDANKS CANNABIS employee appear expired, altered, or fraudulent, the person presenting the ID will be denied entry Into the Marijuana Retail Area (MRA) and the RAA and will be asked to leave. All FAIRDANKS CANNABIS employees will be trained to identify altered or fraudulent IDs.

#### Describe your processes for admitting visitors into and escorting them through restricted access areas:

FAIRDANKS CANNABIS has established a Restricted Access Area (RAA) based on the guidance of 3 AAC 306.710 and will strictly follow the regulations listed within for admitting visitors and escorting them through the RAA. The RAA has one point of entry, the RAA entrance, which is located within the store. The RAA entrance will be posted with a sign that says "Restricted access area. Visitors must be escorted." A trained FAIRDANKS CANNABIS employee will be posted at the RAA entrance at all times, during open business hours. In accordance with 3AAC 306.710, FAIRDANKS CANNABIS will limit the number of visitors to not more than five visitors for each licensee, employee or agent of the licensee and must be actively engaged in supervising visitors.

The rear exit to FAIRDANKS CANNABIS connects to the RAA but will remain locked to the outside at all times. At no time will the rear exit be used as an exit by authorized visitors. At no time will anyone be allowed entry into FAIRDANKS CANNABIS through the rear entrance.

All visitors to the RAA must show photo identification as required in 3 AAC 306.350 to prove that they are 21 years of age or older. A trained FAIRDANKS CANNABIS employee posted at the RAA entrance will ensure the ID provided is government issued, non-expired, and verified for legitimacy. Upon verification, a FAIRDANKS CANNABIS employee will produce a visitor identification badge for the authorized visitor before allowing access to the RAA. Authorized visitors will be escorted at all times by a licensee, employee, or agent of FAIRDANKS CANNABIS.

Each RAA visitor must log their visit in the FAIRDANKS CANNABIS visitor log. The visitor log will document: each visitor's name; date and time of entry; purpose of visit; the escorting employee's name and signature; and a signature of the visitor acknowledging and agreeing to be subject to FAIRDANKS CANNABIS policies and procedures, as well as conforming to regulations pursuant to 3 AAC 306.710. Upon the visitor's exit, the escorting employee of FAIRDANKS CANNABIS will be responsible for ensuring that each visitor logs their time of departure from the RAA in the visitor log.

Should any photo identification presented to the trained FAIRDANKS CANNABIS employee appear expired, altered, or fraudulent, the person presenting the ID will be denied entry into the Marijuana Retail Area (MRA) and the RAA and will be asked to leave. All FAIRDANKS CANNABIS employees will be trained to identify altered or fraudulent IDs.

Exterior lighting is required to facilitate surveillance. Describe how the exterior lighting will meet this requirement:

Pursuant to 3 AAC 306.715, retail marijuana store, FAIRDANKS CANNABIS will install security lighting at its retail location. FAIRDANKS CANNABIS will use mounted luminaries which are designed for general security lighting and will mount the lighting to adequately illuminate the front entrance and rear exit. Only the front and rear of the licensed premises will have exterior security lighting as FAIRDANKS CANNABIS shares a wall with other stores on both sides of the retail marijuana store.

An alarm system is required for all license types. Describe the security alarm system for the proposed premises:

Pursuant to 3 AAC 306.715 (2), the licensed premises, FARIDANKS CANNABIS, will have a security alarm system on all exterior doors and windows. In addition, FAIRDANKS CANNABIS will strategically place duress buttons around the store to immediately alert the police of an emergency situation. Fire and Carbon Monoxide alarms will be installed within the licensed premises for general safety purposes.

The front entrance and rear exit will have a monitored alarm system which will be deactivated by PIN code at the start of the business day and activated at the closing of the business day. The monitored alarm system will alert law enforcement upon a forced unauthorized entry into FAIRDANKS CANNABIS.

All exterior windows of FAIRDANKS CANNABIS will have glass break detectors. Upon a glass break of any exterior window, law enforcement will be alerted through the monitored alarm system. All security alarms will have a back up battery.

The alarm system must be activated on all exterior doors and windows when the licensed premises is closed for business. Describe how the security alarm system meets this requirement:

FAIRDANKS CANNABIS will train all staff on how to properly activate the security alarm system at the close of the business day. The last employee to leave the premises will be responsible to ensure all doors and windows are closed and locked. The last employee will then activate the alarm system that will alert a third party security firm upon a physical security breach. When an alarm is triggered, the third party security firm will alert pre-determined FAIRDANKS CANNABIS staff and law enforcement.

#### Describe your policies and procedures for preventing diversion of marijuana or marijuana product:

Pursuant to 3AAC 306.715, FAIRDANKS CANNABIS will have policies and procedures in place to prevent diversion of marijuana from employees and members of the public. FAIRDANKS CANNABIS will screen all employees with background checks, past employment references and interviews. Upon hire, new employees of FAIRDANKS CANNABIS will be placed in a training period and given copies of government marijuana regulations and the FAIRDANKS CANNABIS training manual. (The FAIRDANKS CANNABIS training manual.) The FAIRDANKS CANNABIS training manual will cover the POS system used by retail store, as well as how to prevent customer diversion, and the use of METRC.) At the end of the training period, employees must pass a written test to prove they understand all regulations and expectations of FAIRDANKS CANNABIS. Employees will be subject to random bag checks at the end of each business day.

FAIRDANKS CANNABIS, in accordance with 3 AAC. 630.720 (1)(2) will prevent customer diversion by posting a sign, which will state "NO LOITERING. Violators will be prosecuted" at the entrance of the retail store. (The following signage posted at the store will be no less than 12" x 12", with lettering at least one-half inch in height in black and against a white background or in high contrast to lettering, background)

FAIRDANKS CANNABIS will also conduct random video surveillance checks on visitors as well as employees. Inventory of marijuana and cash will be counted by at least two employees at the end of each business day. Any discrepancies will be investigated immediately, by the store manager of FAIRDANKS CANNABIS.

If diversion is suspected, FAIRDANKS CANNABIS will conduct an internal investigation. If the investigation confirms diversion, or requires assistance with the investigation, FAIRDANKS CANNABIS will alert the local law enforcement authorities.

#### Describe your policies and procedures for preventing loitering:

FAIRDANKS CANNABIS will have a sign which states: "NO LOITERING. Violators will be prosecuted" at the entrance of the retail store. (The following signage posted at the store will be no less than 12" x 12", with lettering at least one-half inch in height in black and against a white background or in high contrast to lettering, background)

A video surveillance will be periodically checked by a FAIRDANKS CANNABIS employee to monitor violators of the "NO LOITERING" policy. Any violators of the policy will be asked to leave the area immediately.

Describe your policies and procedures regarding the use of any additional security device, such as a motion detector, pressure switch, and duress, panic, or hold-up alarm to enhance security of the proposed premises:

FAIRDANKS CANNABIS will have a training manual for employees with instructions on how to use the duress buttons placed around the retail marijuana store. These strategically placed duress buttons around the store will alert the police of an emergency situation upon activation.

FAIRDANKS CANNABIS will train all staff on security provisions, including, but not limited to, anti-diversion strategy, unanticipated alarm notifications to law enforcement, security breaches, and use of the electronic alarm, and video surveillance security systems.

The Retail Marijuana Store Manager of FAIRDANKS CANNABIS will train necessary staff to properly activate and deactivate the monitored security system and duress buttons. Upon automatic or electronic notification to local law enforcement of an unauthorized breach of security, employees will immediately notify the licensee and manager of FAIRDANKS CANANBIS and, if possible, confirm that a breach was made at the licensed premise.

FAIRDANKS CANNABIS policy will dictate that all security incidents are logged with general description of events, approximate time-lines, the parties involved, resolution of the incident, external notifications required and recommendations for prevention and remediation will be developed immediately after a breach. After evaluation of video surveillance of security breach, FAIRDANKS CANNABIS will cooperate and coordinate with local law enforcement to assist in the apprehension and prosecution of the responsible parties.

When FAIRDANKS CANNABIS packages marijuana for sale: (1) ALL employees will wash hands in accordance with 3 AAC 306.735 and FAIRDANKS CANNABIS training manual before handling marijuana. (2)All employees will also wear synthetic polymers gloves, such as vinyl and nitrile gloves, when handling marijuana and/or marijuana product to ensure the product will not be contaminated in any way. (3) Packaging of marijuana will not have any printed images, including cartoon characters, that specifically target persons under 21 years of age. In addition, the packaging will protect the product from contamination and will not impart any toxic or damaging substance to the marijuana. (4) Marijuana and/or marijuana product will be packaged in opaque, resealable, child-resistant packaging. The packaging will be designed or constructed to be significantly difficult for children under five years of age to open, but not normally difficult for adults to use properly. (5) Each package prepared in compliance with 3 AAC 306.470 will be identified by a tracking label generated for tracking by the marijuana cultivation facility's marijuana inventory tracking system, METRC, from seed to disposal. (6) FAIRDANKS CANNABIS will ensure that EVERY marijuana package sold contains each of the following statements: (a) "Marijuana has intoxicating effects and may be habit forming and addictive."; (b) "Marijuana impairs concentration, coordination, and judgment. Do not operate a vehicle or machinery under its influence."; (c) "There are health risks associated with consumption of marijuana."; (d) "For use only by adults twenty-one and older. Keep out of the reach of children."; (e) "Marijuana should not be used by women who are pregnant or breast feeding."

(5) No such statements such as "Organic" will be allowed on packaging/label.

(6) The label which FAIRDANKS CANNABIS will place on product will identify the retail marijuana store by its name: "FAIRDANKS CANNABIS", and state its marijuana establishment license number, the total amount of THC in the labeled product, the marijuana product's unique name, and its effect on a person (as mentioned herein), and ensure that label requirements is affixed in accordance with 3 AAC 306.470, 3 AAC 306.570, and 3 AAC 306.645.

METRC will log the type of products destined for transport will be packaged in an opaque container, limited to five pounds per package, with tamper evident seal. A complete printed transport manifest will be kept with marijuana at all times. METRC will be used to record the type, amount, weight of marijuana product being transported, name of transporter, time of departure and expected delivery, the make, model, and license plate number for transporting vehicle. In the event cannabis products need to be transported off premises marijuana will be stored in a lockable compartment of the vehicle where it will remain until arrival at the destination.

Describe the type of locked, safe, and secure storage compartments that will be used in any vehicles transporting marijuana or marijuana product:

Pursuant to 3 AAC 306.750, FAIRDANKS CANNABIS may transport marijuana or a marijuana product to another retail marijuana store. In doing so, FAIRDANKS CANNABIS shall ensure that: Products destined for transport will be packaged in an opaque container, limited to five pounds per package, with tamper evident seal. A complete printed transport manifest will be kept with marijuana at all times. METRC will be used to record the type, amount, weight of marijuana product being transported, name of transporter, time of departure and expected delivery, the make, model, and license plate number for transporting vehicle. In the event cannabis products need to be transported off premises, marijuana will be stored in a lockable compartment of the vehicle where it will remain until arrival at another retail marijuana store. Only authorized FAIRDANKS CANNABIS employees will have the key to the lock of the safe in the transport vehicle.

The transporting vehicle will travel directly to destination. The recipients will only include licensed marijuana retail locations. A signature, printed name, marijuana handler permit number, and time of arrival will be required from the receiving party before any transfers can be deemed complete.

If an individual asked to leave the licensed premises by a FAIRDANKS CANNABIS employee refuses to leave, local law enforcement will be notified to escort the person out.







#### **ORDINANCE NO. 6066**

#### AN ORDINANCE AMENDING FAIRBANKS GENERAL CODE SECTION 74-34 RESIDENTIAL PROPERTY TAX EXEMPTION TO CLARIFY AMOUNT OF EXEMPTION

**WHEREAS,** in April of 1982, the City Council passed Ordinance No. 4119 that placed the issue of a residential property tax exemption before the voters; and

**WHEREAS,** in October of 1982, City voters approved ballot Proposition A, which read: "Shall Ordinance No. 4119, providing for a residential property tax exemption in the city of Fairbanks in the maximum amount allowed under state law, as amended from time to time, be ratified?"; and

**WHEREAS,** in 2016 the State legislature amended AS 29.45.050(a) to increase the maximum allowable municipal residential property tax exemption to \$50,000; and

**WHEREAS,** the Borough, by Ordinance No. 2016-10 (ratified by the voters in October of 2016), approved an increase in the Borough's residential property tax exemption to \$50,000, effective December 31, 2017; and

**WHEREAS,** in 2007, the City Council adopted Ordinance No. 5716 that amended FGC Sec. 74-32 to clarify that the grant of an optional property tax exemption by the Fairbanks North Star Borough under AS 29.45.050 or any other statute would not apply to real property within the city unless the City Council concurred by ordinance; and

**WHEREAS,** based upon City Ordinance No. 4119 and the language of the ballot proposition approved by that ordinance, the increase in the maximum allowable residential property tax exemption would go into effect absent action by the City Council; and

**WHEREAS,** certain amendments to the language of Sec. 74-34 are needed to update the code and make its language consistent with the Borough's filing requirements.

### NOW, THEREFORE, BE IT ENACTED BY THE CITY COUNCIL OF THE CITY OF FAIRBANKS, ALASKA, as follows:

**SECTION 1**. That Fairbanks General Code Section 74-34. Residential property tax exemption is hereby amended as follows [new text in **underlined bold** font; deleted text in **strikethrough** font]:

#### Sec. 74-34. Residential property tax exemption.

- (a) Residential real property within the city shall be exempt from property tax as set forth in AS 29.45.050(a), provided that:
  - (1) The property is owned and occupied <u>as a residence</u> by the owners of record.
  - (2) There are no property taxes or penalties or interest owing at the time of application or on April 1 of each successive tax year after initial application.
  - (3) The owners of record shall annually sign a real property exemption statement and file the statement with the borough assessor <u>prior to April 1 of the tax year</u>on or before May 10 of each year. <u>The owners of record need not file such a statement for successive tax years if there is no change in ownership and no change in occupation as a residence by the owners of record.</u>
- (b) The maximum amount of the real property tax exemption provided for under AS 29.45.050(a) and this section shall be \$20,000.

#### LEASE AMENDMENT NO. 1

This Lease Amendment No. 1, entered into by the City of Fairbanks, 800 Cushman Street, Fairbanks Alaska, 99701 (the "City") and Golden Heart Utilities, Inc., 3691 Cameron Street, Suite 201, Fairbanks, Alaska 99708 ("GHU"),

#### **RECITALS**

- (1) The City and GHU entered into a lease dated October 6, 1997, under which GHU leases the Wastewater Treatment Plant, including land located at 4247 Peger Road, Fairbanks, Alaska (the "Lease").
- (2) The City and GHU mutually desire to amend said Lease, and do hereby enter into this Amendment No.1 for the purposes stated below.

#### NOW THEREFORE:

A. Lease Paragraph 1; Premises, Term, and Rent:

<u>Subparagraph (b)</u>: The original Lease termination date is October 6, 2027. GHU may extend the lease for up to twenty-five years from said date. GHU may exercise this lease extension(s), first having given written notice to the City six months in advance of such exercise.

<u>Subparagraph (c)</u>: The current annual rent of \$396,900.00 shall remain unchanged for the duration of the lease, including any lease extension(s).

B. Lease Paragraph 5; Option to Purchase:

#### Subparagraph (a):

- (a.1) The term of the Option shall not expire, but shall continue as a right of GHU through the end of the Lease term, or any extension(s) thereof. GHU may exercise its Option to Purchase at any time, first having given written notice to the City.
- (a.2) Purchase Price at Time of Exercise. From October 6, 2017 through October 6, 2027, the purchase price is fixed at \$5,200,000.00. If the option is not exercised by October 6, 2027, the purchase price shall be reduced at the end of each subsequent year by 5%, but never less than \$400,000, the unimproved land value, hereby agreed and established.
- (a.3) Credit Toward Purchase Price. A credit is hereby established in favor of GHU in the amount of \$4,000.000.00, to be applied against the purchase price at time of exercise. The credit is valid through October 6,

2030. This credit is fixed and shall remain available to GHU at any such time as GHU may elect to exercise its option to purchase on or before October 6, 2030. After October 6, 2030, the net purchase price shall be \$400,000, the agreed and established unimproved land value. This credit does not apply to the agreed unimproved land value stated in Subparagraph a.2.

#### Subparagraph (b): [reserved]

- C. Future Financial Assistance. The City previously provided financial assistance to GHU in the form of pass-through low interest loans and grants not otherwise available to GHU. The City will continue to seek such funds as and when available from State or Federal sources for the benefit of GHU's ratepayers.
- D. Terms Unaffected. Except as set forth in this Amendment, the original Lease is unaffected and shall continue in full force and effect in accordance with its terms. If there is conflict between this Amendment and the Lease, the terms of this Amendment will prevail.
- E. Succession: This agreement, while in force, shall be binding upon the heirs, successors or assigns of the parties hereto.



The Permanent Fund Review Board shall advise and make recommendations to the City Council concerning investment policy, strategy, and asset selection and allocation of the permanent fund. The Board may use the services of a professional investment advisor/manager in rendering its advice and recommendations to the City Council.



### BOARD/COMMISSION CHARACTERISTICS

The Mayor, with confirmation from the City Council, shall appoint five members to the Permanent Fund Review Board. Members shall possess some background in any one or more fields in accounting, banking, financial investment advisement, securities regulation, public finance, or other similar professional fields regulated by the State of Alaska or other professional or national organizations. Each member shall serve a three-year term.

#### **MEETINGS**

The Permanent Fund Review Board was formed in accordance with the Fairbanks Home Rule Charter, Section 8.8(b). Meetings are held quarterly at City Hall in the Council Chambers and are open to the public. Special meetings may be called by the chairman or by a majority of the members. A majority of the board shall constitute a quorum and a majority shall be necessary to carry any question. Minutes shall be kept as a permanent record of all meetings and shall be filed in the Office of the City Clerk.





There shall be seven voting members of the Public Safety Commission, appointed by the City Mayor and confirmed by the City Council. A chairperson shall be selected from among the voting members and all voting members shall serve three-year terms. One City Council Member shall be a non-voting member of the Commission, nominated by the Mayor and confirmed by the City Council. The City shall ensure the following staff are available to attend meetings: Chief of Police or his/her designee; one current police department employee; Fire Chief or his/her designee; one current fire department employee; Emergency Services Dispatch Director or his/her designee; one current dispatch employee.

#### **MEETINGS**

The Public Safety Commission is a Committee operating under the authority as described in Fairbanks General Code 2-471 through 2-474. Meetings of the Commission are held quarterly or on an "as needed" basis and all meetings are open to the public. The Commission does not have the power to meet privately in executive session. 





# Fairbanks North Star Borough / City of Fairbanks CHENA RIVERFRONT COMMISSION MINUTES

June 14, 2017

The Fairbanks North Star Borough/City of Fairbanks Chena Riverfront Commission (CRFC) met on Wednesday, June 14, 2017 Chair Olson presiding. The following Commission members were in attendance: Julie Jones, Lee Wood, Kelley Hegarty-Lammers, Ben Jaffa, Anna Plager (via phone), Bob Henszey, Gordy Schlosser, Ian Olson and Buki Wright.

Also present were: Andrew Ackerman, City of Fairbanks; Kellen Spillman; FNSB Community Planning Deputy Director; Bryn McElroy, TVWA; Joe Kemp, DOT; Donna Gardino, FMATS; Brittany Smart, FNSB Mayors Office; Brian Charlton, FNSB Parks & Recreation; Laura McLean, FNSB Recording Clerk; Ann Worhatch, FNSB Public Works Engineer; Nancy Durham, FNSB Floodplain Administrator and Merritt Helffrich, member of the public.

Absent Commissioners: Carrie McEnteer, Susan Rainey

#### 1. CALL TO ORDER

**Olson** called the meeting to order at 12:00 p.m.

#### 2. APPROVAL OF AGENDA

**Olson** announced that Gary George will not be attending the meeting. Item #1 will be postponed to a later date.

A motion was made by **Hegarty-Lammers**, seconded by **Wood** to approve the Agenda for June 14, 2017, as amended. There were no objections.

#### 3. APPROVAL OF MINUTES OF May 10, 2017

A motion was made by **Hegarty-Lammers**, seconded by **Wright**, to approve the minutes for May 10, 2017 as presented. There were no objections.

#### 4. COMMUNICATIONS TO THE COMMISSION

**Olson** communicated that Mark Peterburs with the Alaska Railroad has resigned from the railroad and will not be representing them as a liaison anymore.

**Hegarty-Lammers** reported on the worksession that was given to the Planning Commission on June 2<sup>nd</sup> regarding the planning process of the Chena Riverfront Plan and its applicability to Planning Commission decisions.

**Henszey** reported on the worksession that he and Mitch Osborne gave to the Planning Commission on June 2<sup>nd</sup> regarding the Riparian Bank Habitat and recent restoration projects on the Chena River.

#### 5. PUBLIC COMMENTS

None

#### 6. NEW BUSINESS

1. Ruth Burnette Fish Hatchery – Gary George

Postponed to a later date.

2. Warm Water Discharge – Buki Wright

**Wright** gave a presentation regarding the Warm Water Discharge into the Chena River at Aurora Energy. He further commented that they anticipate their permit request to go to public hearing later this year.

A brief question and answer period followed the presentation by Wright.

#### 3. DOT Projects

**Joe Kemp**, DOT, addressed the CRFC. He gave a brief update on the projects that DOT currently have that affect the river and this Commission.

He suggested that this commission contact Lauren Little with ideas for the project at the University Avenue bridge over the Chena River, specifically for the lot northeast of said project.

**Kemp** commented that the Phillips Field project is ready to go to advertising. They are currently waiting on some railroad approvals for temporary construction permits.

Also, the Cushman Street bridge project did get reactivated. They are estimating construction in 2020 or 2021.

**Kemp** also reported on a project at Mile 356 to 362 of the Mitchell Expressway with bridge work over the Chena River.

**Gardino** reported on the Chena Riverwalk from Peger Road to the existing pedestrian bridge behind the hotel near Pioneer Park.

**Olson** asked for volunteers to meet as a working group to discuss the possibilities for the lot on the northeast side of the bridge over the Chena River on University Avenue. Plager, Jaffa and Schlosser volunteered.

**Gardino** requested that Kemp give an update on the Airport Way West project. **Kemp** updated the commission with what he knew. He will report back at the next meeting.

4. Draft Ordinance authorizing CRFC review of Quasi-judicial and legislative matters

**Spillman** addressed the CRFC and gave a brief background to the Commission regarding this ordinance and its need.

**Spillman** reported that a working group did meet to discuss the draft ordinance. The draft version handed out today is a reflection of that meeting.

**Wood** gave a recap of the working group meeting. She further commented that this draft ordinance will correct the fact that there is not an ordinance providing for the CRFC to comment on projects along the Chena River. The process for review will stay essentially the same as it has in the past. There will be a 24 day window for the Commission to review and comment.

**Wood** further explained that this draft ordinance will change the 200' river corridor to 150' from the ordinary high water mark.

**Spillman** commented that Mayor Kassel intends to introduce this ordinance to the Assembly on June 22<sup>nd</sup> and refer it to three different bodies, the CRFC, the Planning Commission and the City Council.

**Wood** asked if Community Planning will still be notifying this commission of projects along the river corridor while this ordinance is moving forward. **Spillman** replied that this could happen.

**Spillman** went through the ordinance explaining each change and the justification for each.

Suggestions were made for changes to the draft by the Commission. Unfortunately, **Spillman** confirmed that it is too late to make changes to this draft version. However, this Commission will have the opportunity for recommendations as this ordinance moves forward through the Assembly, the City Council and this Commission for recommendation.

5. Potential Field Trip for the July meeting

**Wood** suggested either the Fish Hatchery or the Aurora Power Plant. This item will be discussed further at the next meeting.

**Andrew Ackerman,** City of Fairbanks, reported on the annual Stream Clean-up project along Noyes Slough.

**Bryn McElroy,** TVWA, commented that they are hosting a nomination campaign for "Green Streets". She provided fliers for the event. Nominations can be made on-line at the TVWA website.

#### 8. COMMISSIONERS COMMENTS

**Hegarty-Lammers** thanked Spillman for his work on the draft ordinance.

**Henszey** inquired about the plan to develop property along the river near the Carlson Center. He commented that this commission should have an opportunity to comment on this project.

A motion was made by **Hegarty-Lammers**, seconded by **Henszey** to extend the meeting for five (5) minutes. There were no objections.

**Spillman** clarified for the commission that due to the zoning on this parcel, they aren't required to get a zoning permit. However, the owner did apply of a zoning permit. As the Department of

Community Planning only has five (5) days to approve a zoning permit request, the permit was issued without notification to this commission.

Wood thanked Spillman for his work on the draft ordinance.

**Jones** commented that she was embarrassed by the behavior of certain members of this Commission after the last meeting. She continued that a special working group meeting was held to discuss with DOT the color of the wall. It was her understanding that they had a letter that went out recommending the Green Streets color scheme. Therefore, this commission did make a recommendation. For this commission to spend another entire meeting addressing this issue again, she felt, was a waste of her time.

1. Chair's Comments

Ms. McLean accepted and thanked the Commission for honoring her. **Mr. Schlosser** gave additional praise.

3. Communications to Chena Riverfront Commission

a. Riparian Management Zones, September 2002

Mr. Spillman and Mr. Henszey introduced the Riparian Management Zone document and explained the history of its development and how it is utilized today.

#### 4. Citizen's Comments

**Ms. Christy Evert** on behalf of Tanana Valley Watershed Association spoke about the Riparian Management Zone and introduced the publication "Living Alongside Salmon Homes". **Ms. Plager** commented on the beneficial use of the word "Salmon" in the publication and inquired on outreach efforts. **Ms. Evert** explained the purposefulness of the title in drawing attention to the Chena River and explained planned future distribution. **Mr. Henszey** emphasized the photograph on the pamphlet, "Living Alongside Salmon Homes", shows that small streams are important to the large streams.

Discussion ensued about the format of the minutes and handling of excused absent members, and how Commissioners are excused. **Ms. Smart** explained the goals of participation of members of all FNSB Boards and Commissions. It was agreed that this matter would be tabled and added to the October meeting agenda.

**MOTION:** To approve the July 12, 2017 meeting minutes with corrections under section B, removing the word "Planning" and in section G, noting that Mr. Henszey was also excused.

#### **E. UNFINISHED BUSINESS**

1. University Avenue at Chena River Bridge Update

**Mr. Joe Kemp** reported that there were no new updates on this project.

2. Airport Way West Improvement Project Update

- **Mr. Carl Heim** reported that there currently is no construction funding for this project. He stated that in the next year and a half to two years, work will be completed on the design with current funding. He further communicated that DOT&PF has the CRFC's concerns and will continue to work towards incorporating some of the concepts, including the rain garden concept.
- **Ms. Plager** asked if there was anything the Commission could do to help speed the project along. Mr. Heim mentioned that when the next STIP comes out, there is a comment period, and encouraged people to comment. **Mr. Spillman** explained that the Borough and this Commission has commented before and agreed to bring it up in a future meeting.
- **Ms.** Hegarty Lammers and Ms. Plager questioned that only "some" of the Commissions' design ideas may be included, and indicated that if some are not, it should be reported back to the Commission prior to going out to bid.
- **Mr. Heim** clarified that he has not, not considered any of the ideas in the letter and reported that in approximately a year the 65% design will be complete and a walk-around conducted that the Commission can attend.
- 3. Review of CRFC Project List
  - **Mr. Olson** postponed this item to the next meeting.

#### F. <u>NEW BUSINESS</u>

- Recommendation on RZ2018-02, an application by the Alaska Railroad Corporation to rezone Tract 4 and Tract 5 of Chena Landings Subdivision from General Use one (GU-1) to Multiple-Family Residential/Professional Office District (MFO) with a waterways setback designation.
  - **Ms. Wood** expressed concern about the process established for handling these types of matters which included notice to the CRFC. Mr. Spillman responded that as much of the process that could be followed, given the new ordinance, was followed. Discussion ensued about timing for recommendation and deadlines.
  - **Mr. Spillman** introduced Paula Hicks of Northland Survey as the Applicant's representative, and explained potential actions available to the Commission on this request.
  - **Ms. Stacy Wasinger** gave a presentation of the application request and provided preliminary findings on behalf of the Borough's Planning Department.
  - **Mr. Spillman** oriented everyone to the landmarks in the area from the map on the screen.
  - **Ms. Jones** commented that there is a right-of-way for the Chena River Walk that goes to lot number 3 and starts again after lot number 5 and that a permit is in place.
  - Ms. Wasinger resumed her presentation.

Mr. Henszey inquired if the trees and shrubs would remain intact and Ms. Wasinger replied that it is not required under zoning and setbacks.

**Mr. Jaffa** asked if there is a cap to the number of 1,500 square foot residential units to be constructed in the MFO, and **Ms. Wasinger** responded that there is not that it is dependent on the size of the lot.

**Ms.** Hegarty Lammers inquired if pathways are allowed in the setback. **Ms.** Wasinger responded that they are and clarified that setbacks are for structures and the definition is a building that is enclosed.

The Commission briefly discussed setback requirements.

**Ms. Wasinger** resumed and concluded her presentation.

#### Questions by Commissioners

**Ms. Wood** asked what types of businesses are allowed in the MFO.

**Ms. Wasinger** indicated that in addition to the general residential type of uses, there are permitted uses such as bed and breakfasts, daycare facilities, etc., and then there are those that are conditional uses.

**Ms.** Rainey commented on the potential for high density in the area and inquired about any requirements concerning access, particularly from Landing Road.

**Ms. Wasinger** stated that the road requirements would be under the authority of the City of Fairbanks.

Discussion ensued about access requirements, roadways and potential traffic issues. **Ms. Plager** brought the meeting back to order and reminded everyone of the need to focus on what the Commission is responsible for reviewing.

**Ms. Jaffa** inquired if Staff is going to be able to provide a recommendation prior to the Commission making a decision. Discussion ensued about the new process, timeline, and options available to the Commission.

#### Applicant's Presentation

**Ms. Paula Hicks** and **Mr. Jon Cook**, Chairman of the Board of Directors for the Alaska Railroad, were present before the Commission.

Discussion followed on the platted map presented by Ms. Hicks which she indicated was used to create tract 4 and 5, and the relative setbacks and ordinary high water markings.

**Mr. Cook** offered background information on the past use of the land in the area, including existing permits, and provided insight on the Railroad's goals for potential development of the proposed property if it were to be rezoned.

#### **Questions by Commissioners**

**Ms. Wood** asked what benefit this area would have by going MFO versus single family. **Mr. Cook** replied it offers options to allow operation of a small office type business or even a duplex, and still offers compatible uses while allowing flexibility in development.

**Mr. Schlosser** inquired of any known erosion along the river and if that will be a consideration when building. **Mr. Cook** stated that he is unsure of any erosion issues, and pointed out that there a 25 foot setback will be maintained, and that it is not the Railroad's intent to do any work along the bank. **Mr. Schlosser** further sought a commitment from Mr. Cook that during the subdivision process that covenants be established requiring all property owners to treat the riverbank as a fish habitat. **Mr. Cook** pointed again to the 25 foot setback.

**Mr.** Henszey communicated that he is working on a draft report that includes how the Chena River width has changed since 1938, and explained how the area in question has accreted due to channel narrowing caused by the Chena Flood Control Project".

**Mr. Jaffa** inquired why tract 3 is not included in the rezone. **Mr. Cook** replied that the Railroad's development plan does not allow for that at this time.

**MOTION:** To extend the meeting by 20 minutes to 1:50 p.m., by **Ms. Jones** and seconded by **Ms. Lee**.

#### PASSED WITHOUT OBJECTION

**Ms. Plager** expressed her concern for the waterway setback since it could be lawn all the way to the waters' edge, but noted the protection offered by the additional approval requirements for certain types of activity such as bank restoration, etc. She further stated that the waterways protection promotes the riparian habitat, and questioned if the 25 foot setback moves if there is erosion. **Mr. Spillman** responded that the waterway setback runs with the property, so if the property shifts, the waterway setback shifts.

Discussion followed on permissible building within the waterway setback and concerns over potential developments in the setback, riparian management, potential lot sizes and number of structures, maintaining the walkways, and future developments on other lots.

**MOTION:** To endorse the proposed rezone including the 25 foot setback by **Ms. Plager** and seconded by **Mr. Jaffa**.

#### Discussion on the Motion

**Mr.** Henszey stated he would prefer the waterway protection zone, and stated his appreciation for what the Railroad is doing.

**Ms. Hegarty Lammers** agreed with Mr. Henszey and asked Mr. Cook to speak to the developers prospective.

(Chair allowed out-of-order question and allowed Mr. Cook to respond)

**Mr. Cook** asked for flexibility on the waterway issues to allow for maximum marketability of the tracts.

**Ms. Plager** clarified her position on the Motion in that it gives the Commission the ability to work with the Railroad and do necessary community outreach on matters concerning the riverbank, etc.

**Mr. Schlosser** expressed similar concerns to Mr. Henszey, but also agreed with Ms. Plager on education outreach opportunities.

**MOTION:** To extend the meeting by 5 minutes to 1:55 p.m., by **Ms. Hegarty** 

Lammers and seconded by Mr. Schlosser.

**Mr. Olson** advised that Gary George is unable to give his presentation on the Fish Hatchery and postponed it to a future meeting.

**Ms. Plager** inquired about "excused absences" not making the agenda. Discussion ensued and it was determined that item number 3 under New Business related to the FNSB Board & Commission Policy which is what brought up the topic at the September meeting.

**Mr. Henszey** stated that if the minutes remain under the consent agenda then there is no discussion and **Mr. Olson** concurred. **Mr. Henszey** requested the September 13, 2017 minutes be pulled for discussion. Discussion ensued about there not being a quorum and the proper process for discussion of the minutes.

(Chair moved back up to Chair's Comments)

#### D. MINUTES

- 1. \*Minutes from July 12, 2017 meeting.
  - **Ms. Plager** requested to hear Commissioner Henszey's requested changes.

**Mr. Henszey** noted that page 2 of the minutes, under Citizen's Comments, he would like his statement to read "**Mr. Henszey** emphasized the photograph on the pamphlet, Living Alongside Salmon Homes, shows that small streams are important to the large streams.

**Mr. Henszey** requested a change on page 5, third paragraph, should read: "**Mr. Henszey** communicated that he is working on a draft report that includes how the Chena River width has changed since 1938, and explained how the area in question has accreted due to channel narrowing caused by the Chena Flood Control Project".

Further discussion ensued about the proper processes for removing the minutes as a Consent Agenda Item.

#### E. <u>NEW BUSINESS</u>

- 1. Presentation of the Ruth Burnette Fish Hatchery
  - **Mr. Olson** reiterated that Gary George was not able to be present and advised this matter would be heard at a later date.
- 2. CRFC Rules and Procedures Amendment to Rule 16 (Commissioner Plager)
  - **Mr. Olson** communicated that a modification of Rule 16 is necessary to be in alignment to the ordinance passed relating to the center line and review period.
  - **Mr. Spillman** drew attention to the existing Rule 16 and a draft of a new Rule 16, in the meeting packet, and advised he worked with Commission Plager on the draft to align it with the new ordinance.
  - **Ms.** Rainey inquired if the distribution is to the Chair or the entire Commission since it does not specifically indicate who is on the distribution list.
  - **Mr. Henszey** commented that all projects will be coming before the Commission now, but that the Commission does not necessarily need to bring it forward.

  - **Mr. Spillman** communicated that the policy is directed at Borough staff, and stated much of the policy related to proper public noticing requirements. He further pointed out that the Mayor will be getting a report of attendance for all Boards and Commissions.

  - **Ms. Plager** requested that when DOT&PF comes to the Commission, it bring actual samples of potential options to maximize the feedback and Mr. Kemp said he understood.
  - **Ms.** Plager asked for an update on the Phillips Field Road project, and Mr. Kemp indicated it is awaiting some approval from the Alaska Railroad concerning an easement and advised the design is complete. Mr. Kemp indicated he could bring a design to the next meeting.

Ms. Stiver, seconded by Ms. Carnahan, moved to ADD Item 15 to the application requiring a detailed listing of miscellaneous expenses if they total more than 10% of the organization's total expenses.

Ms. Fitzgerald, seconded by Mr. Woolf, moved to AMEND the motion by specifying miscellaneous income and expenses instead of only expenses.

Chair Rogers called for objection to the motion to AMEND the main motion and, hearing none, so ORDERED.

Chair Rogers called for objection to the motion to ADD Item 15 to the application requiring a detailed listing of miscellaneous income and/or expenses if they total 10% or more of the organization's total income and/or expenses and, hearing none, so ORDERED.

iii) Presentations by Organizations (requirement not mentioned in application)

Members discussed adding wording to the application to inform applicants of the required presentation and that presenters need to be prepared to answer financial questions from the Committee. Ms. Stiver also commented that organizations should be acknowledging the City of Fairbanks Discretionary Fund in printed materials. Members discussed adding a statement to the application that requires applicants to provide examples of how the logo was used to recognize the grant sponsorship, if applicable.

Ms. Stiver, seconded by Ms. Carnahan, moved to ADD language to the application that all grant recipients must acknowledge the Discretionary Fund Grant at the sponsorship level and provide examples of how the logo was used on promotional items, if applicable.

Chair Rogers called for objection and, hearing none, so ORDERED.

Members discussed Schedule A of the application and fiscal year reports.

Ms. Stiver, seconded by Ms. Carnahan, moved that the Clerk and Ms. Bell make all appropriate changes to the application per the Committee's discussion and recommendations.

Chair Rogers called for objection and, hearing none, so ORDERED.

It was agreed that the Clerk would send the revised application to Committee members for final review. **Ms. Bell** stated that she has received questions as to why there are presentations if organizations or individuals cannot present further information at that time. Members discussed the issue.

Ms. Stiver, seconded by Ms. Fitzgerald, moved to AMEND the Policies and Procedures by striking the sentence, "Electronic presentations are permitted as long as they stay under the three minute time period allotted" and by clarifying that electronic presentations and hard copy handouts of any kind are prohibited.

Chair Rogers called for objection and, hearing none, so ORDERED.

Ms. Fitzgerald, seconded by Mr. Woolf, moved to REQUIRE that the application have a place to designate which is the original and which ones are copies and a checklist to verify that each one is complete.

A lengthy debate ensued regarding the proposed requirement. Members also discussed at length whether applicants should be disqualified if information is missing from any of the eight total application packets submitted. They discussed ways to check for completeness of each packet submitted. Members debated how to designate an "original" application.

Ms. Stiver, seconded by Ms. Carnahan, moved to AMEND the motion by requiring the applicant to determine which application is the original and by requiring the applicant to complete the checklist.

Chair Rogers called for objection and, hearing none, so ORDERED.

Chair Rogers called for objection to REQUIRING that the application have a place to designate which is the original and which ones are copies and a checklist to verify that each one is complete; and requiring the applicant to determine which application is the

original and requiring the applicant to complete the checklist and, hearing none, so ORDERED.

Ms. Carnahan and Ms. Stiver left the meeting at 7:32 p.m., and there was no quorum present for the remainder of the meeting.

Remaining members discussed past practice for disqualifying applications and how best to move forward to ensure that no information is missing from application packets at the time of submittal. No action was taken.
