# FAIRBANKS CITY COUNCIL REGULAR MEETING MINUTES, JANUARY 9, 2017 FAIRBANKS CITY COUNCIL CHAMBERS 800 CUSHMAN STREET, FAIRBANKS, ALASKA

The City Council convened at 7:00 p.m. on the above date to conduct a Regular Meeting of the Fairbanks City Council at the City Council Chambers, 800 Cushman Street, Fairbanks, Alaska, with Mayor Jim Matherly presiding and with the following Council Members in attendance:

# **INVOCATION**

The Invocation was given by City Clerk Danyielle Snider.

#### **FLAG SALUTATION**

Mayor Matherly led the Flag Salutation.

#### **CITIZEN'S COMMENTS**

Brittany Smart, 809 Pioneer Road, Fairbanks – Ms. Smart stated the Borough was approached by representatives of entities that serve the senior community. She stated the Fairbanks Economic Development Corporation (FEDC) will now be doing an updated assessment on support for services for the elderly. Ms. Smart stated the assessment will lead to more medical services for seniors in the community. She stated she expects an RFP to be out soon relating to the issue. She spoke to the expanded hours on the sale of alcoholic beverages that will be considered at the January 12 Borough Assembly meeting.

**Mr. Cleworth** asked Ms. Smart if the administration has taken a position on the ordinance to extend bar hours. Ms. Smart replied that to the best of her knowledge, they had not.

Marcy Ward, 4376 Dartmouth Drive, #4, Fairbanks – Ms. Ward stated she works for the Catholic Schools of Fairbanks and that she is happy to announce they will be bringing astronaut Dr. Leroy Chow to Fairbanks for the third time. She stated he will be visiting local schools to inform students about the space program. She stated she would forward his schedule information to Mayor Matherly once it is set.

<u>Sean Rice, 2521 Clydesdale Drive, North Pole</u> – Mr. Rice stated he works for the City of Fairbanks Public Works Department, and he invited every to the Martin Luther King, Jr. gospel fest taking place at Corinthian Baptist Church on January 13, 2017 at 6:30 p.m. He stated he would be giving the opening speech at the event. He shared that on January 14 there will be a youth breakfast that will be free for children and \$10.00 for adults at the JP Jones Community Center. Mr. Rice introduced his daughter, Isabelle Rice.

<u>Isabelle Rice, 2521 Clydesdale Drive, North Pole</u> – Ms. Rice reported that she would be attending the Presidential Inauguration through a leadership summit put on by the Envision Experience Program.

**Mr. Pruhs** asked Ms. Rice if she was looking for sponsorships. Ms. Rice stated she is not looking for scholarship, but that she was asked to speak at the meeting to bring awareness to the program.

Ms. Rogers asked Ms. Rice to report back after attending the summit; Ms. Rice stated she would.

**Ms. Huntington** asked Ms. Rice to tell the Council a bit more about herself. Ms. Rice stated she is a senior at North Pole High School and that she is considering New York University and Washington State University for college.

Brian Wilson, 317 Seward Street, #7, Juneau – Mr. Wilson stated he just flew in from Juneau and that he is the Executive Director of the Housing & Homeless Coalition. He stated the Coalition manages federal funding for housing and homeless programs throughout the State. He reported that the Coalition has a board of 15 members, two of which reside in Fairbanks. Mr. Wilson shared his excitement that the Council is creating a housing and homeless coordinator position at the City of Fairbanks. He spoke to the importance of the position and stated that it will have great momentum in getting help to those in need. He stated that those in the greatest need will receive help first.

**Ms. Rogers** stated the City has a serious commitment to work on housing and homeless issues; she stated that she was happy Mr. Wilson came to Fairbanks to speak on the issue. She expressed hope that everyone will work together to be more productive.

**Ms. Huntington** stated the new position will be tackling two big jobs at once: coordinating the project and identifying sustainable funding. She asked Mr. Wilson how he believes two such important tasks could be accomplished. Mr. Wilson stated that one of the things helps the other; he added that when efforts are coordinated statewide, it is easier to receive federal funding.

Kara Carlson, 782 7th Avenue, Fairbanks – Ms. Carlson reminded the Council that the Point in Time count will take place on January 25, 2017, and she asked for volunteers for the event. She stated interviews take about 15 minutes each. She stated that they will be at the Stone Soup Café from 7:00 a.m. until 10:00 a.m., then at the JP Jones Community Center from 10:00 a.m. until 3:00 p.m. Ms. Carlson stated the event costs \$2,000.00 to put on and that they are about \$700.00 short; she asked for sponsorships. She stated that everyone who participates in a survey gets a \$5.00 gift card for food or coffee. Ms. Carlson stated that State ID cards are paid for that day for attendees who need one in order to vote or get a job. She stated they also give out socks at the event to help people stay safe and warm.

**Mayor Matherly** asked Ms. Carlson if she would email him information about the event; Ms. Carlson stated she would send him an invite.

**Ms. Huntington** asked Ms. Carlson if the event was the Project Homeless Connect (PHC) event. Ms. Carlson stated it is not the same event but that they do it on the same day in coordination with PHC. Ms. Carlson asked Mr. Wilson if he could help with Ms. Huntington's question. Mr. Wilson stated that PHC is an opportunity for service agencies to come together as a one-stop-shop for the day. He stated it helps them get a better turnout for the count.

<u>Frida Shroyer, 1635 Becker Ridge Road, Fairbanks</u> – Ms. Shroyer stated she did not live in City limits but that Fairbanks is her home. She spoke in favor of the Housing and Homeless Coordinator position and encouraged the Council to support it. She stated the issue of homelessness is more than just a City of Fairbanks issue, but is a Fairbanks North Star Borough (FNSB) and City of North Pole issue as well. She stated that she is an 8th grade teacher and is not an activist. She expressed hope that the position will work out to help the community.

<u>Victor Buberge</u>, P.O. <u>Box 58192</u>, <u>Fairbanks</u> – Mr. Buberge thanked Public Works for their efforts in snow removal. He stated the flower boxes on Cushman are good for creating jobs, and he asked where the extra funds were coming from to pay employees to hand shovel around the planters. He spoke against the proposed ordinance that would decrease public testimony time.

<u>Frank Turney</u>, 329 6th Avenue, <u>Fairbanks</u> – Mr. Turney stated that Public Works is going a good job keeping the snow off the sidewalk and around the flower boxes. He spoke to the importance of having the Bill of Rights hanging in the Council Chambers and stated he would like it more prominently placed. He shared that he was ashamed of the Council Members for not thanking the 5th grade class for reading the Bill of Rights at the previous Council Meeting. Mr. Turney spoke to the importance of having public restrooms in the downtown area.

<u>Kelvin Lee, 253 Romans Way, Fairbanks</u> – Mr. Lee stated that No Limits, Inc. took over the Ranch Motel and has turned it into permanent supportive housing. He thanked the Council for the selection of a new Police Chief. He stated that stable housing opportunities are the most important thing to the Coalition. Mr. Lee spoke an issue with one of the residents causing vandalism, and he stated that the program did not evict him because they did not want him to be homeless. Mr. Lee stated the Coalition is trying to take a different approach to homelessness.

**Mr. Pruhs** asked Mr. Lee if he would leave his contact information with the City Clerk so he could stop by and see the facility; Mr. Lee stated he would.

**Ms. Huntington** thanked Mr. Lee for the service the Coalition is providing and asked about the priority for the population he is working with. Mr. Lee replied that permanent housing for the homeless is the goal of his Coalition.

<u>Julie Jones, 516 2nd Avenue, Fairbanks</u> – Ms. Jones welcomed Ms. Therrien and Mr. Norum to the Council. She read aloud a letter from the Mayor of Fanano, Italy addressed to Mayor Matherly.

<u>Darlene Herbert</u>, 609 Woodlawn Road, Fairbanks – Ms. Herbert stated she did not support the Council decreasing the time for public testimony. She spoke against the homeless housing project Mr. Lee spoke of because it costs residents too much money to live there. Ms. Herbert spoke in favor of public restrooms in the downtown area.

<u>Richard Lane, Fairbanks</u> – Mr. Lane spoke to the importance of people knowing the facts before giving public testimony. He spoke to the importance of people following the rules at the homeless shelter. He expressed his belief that everyone in Fairbanks has the opportunity to work if they are not lazy.

<u>Lee Despain, 325 Driveway Street, Fairbanks</u> – Mr. Despain spoke against shortening the time allowed for public testimony. He spoke to the quote Mayor Matherly gave to the newspaper in regard to not getting to City business until 9:00 p.m., and stated that his testimony is City business.

Hearing no more requests for public comment, Mayor Matherly declared Public Testimony closed.

**Mr. Pruhs**, seconded by **Ms. Therrien**, moved to WAIVE PROTEST on the Liquor License Applications for Renewal.

Mayor Matherly called for Public Testimony.

<u>Darlene Herbert, 609 Woodlawn Road, Fairbanks</u> – Ms. Herbert stated she read an article about a bar owner closing his bar down after a shooting death only to open another bar where another citizen was killed. She asked the Council if they knew that the situation was occurring. She stated she could not remember the owner's name but that he is avoiding problems by moving his business around town.

**Ms. Rogers** asked Ms. Herbert if the business she was speaking of was on the list of renewal applications. Ms. Herbert stated she did not think the owner was on the list but that she could not recall the owner's name.

Hearing no more requests for public comment, Mayor Matherly declared Public Testimony closed.

**Ms. Huntington** stated that the Council is not provided with the history of a licensed liquor establishment when it comes up for renewal.

**Mr.** Cleworth stated that the Fairbanks Police Department (FPD) weighs in on all liquor licenses that are up for renewal. He stated that if there is an establishment with chronic problems, the FPD can lodge a recommendation for protest on the renewal application.

**Mr. Pruhs** stated that Ms. Huntington raised a good point; he asked if the Council could be provided with a two-year call history for establishments. Police Chief Eric Jewkes stated it would not be a problem to fulfill Mr. Pruhs' request, depending how in-depth a report the Council would like.

Ms. Snider asked if the call report information would be gathered for all license transfers or just for renewals. Chief Jewkes stated that transfers can mean a change of ownership, and the history should not affect a new business.

**Mr. Pruhs** stated he would like to see a history for all liquor licenses on the agenda.

**Ms. Huntington** stated she would also like to see a history on transfers because of the issues Ms. Herbert brought up in her testimony.

#### **MAYOR'S COMMENTS AND REPORT**

Mayor Matherly wished everyone a Happy New Year and thanked City employees for putting on a wonderful Christmas party. He thanked Public Works Director Jeff Jacobson and his staff for doing their best to get the snow cleared from the streets. He reminded everyone to check the City's Facebook page for plow schedules and updates. Mayor Matherly spoke to the loss of former Fire Chief Warren Cummings and reminded everyone about the building dedication in Cummings' honor. He stated he is happy to have Eric Jewkes as the new Police Chief and that he hopes Chief Jewkes will be able to get the department at full staff in 2017. He stated it is an honor to serve with everyone.

**Mr.** Cleworth, seconded by **Ms.** Huntington, moved to ADVANCE Ordinance No. 6040.

**Mr. Cleworth** spoke to the history of the public testimony issue and spoke against the ordinance. He stated that giving public testimony can be difficult, and that three minutes is not enough time. He stated that if there had been consistent problems with meetings running very late he could see making some sort of additional limitation, but that is not the case.

**Mr. Cleworth**, seconded by **Mr. Pruhs**, moved to AMEND Ordinance No. 6040 Sec. 2-119(a)(4), by removing the proposed changes and keeping the original language.

**Mayor Matherly** spoke to phone calls he has received because citizens wanted the Council to get to City business sooner. He stated it is not his intention to silence anyone but that he would like to allow for more people to come and testify.

**Ms. Huntington** spoke in favor of Mayor Matherly bringing the ordinance to the table. She spoke in support of the ordinance and stated she would give anyone extra time to testify if they needed it.

**Mr. Pruhs** stated that the Council always grants extra time to citizens if they need it. He stated the Council is not trying to take away citizens' free speech.

**Mr.** Cleworth stated he has come and testified as a citizen, and he was criticized by the Mayor at the time for asking for additional time; he stated that it took a vote of the Council to allow him to speak past his five-minute time allowance. **Mr.** Cleworth strongly encouraged the Council not to reduce public testimony time.

**Ms. Therrien** stated when she was on the Borough Assembly they allowed for three minutes of public comment and discussion on ordinances started at 8:00 p.m.

**Mayor Matherly** stated he would not want to cap the public comment at a certain time because then some people may not be able to speak at all.

#### **DISCUSSION ITEMS**

#### a) Committee Reports

<u>Fairbanks Diversity Council</u> – **Ms. Rogers** stated the Fairbanks Diversity Council met and it was Mayor Matherly's first meeting as Chair. She stated there was a lot of good discussion and a renewed commitment by the members.

**Mayor Matherly** stated it was a good meeting and he was able to put the rumors to rest that he was going to disband the Diversity Council. He reported that the next meeting would be the following evening in Council Chambers.

<u>Hotel/Motel Discretionary Fund Committee</u> – **Ms. Rogers** stated the Committee has met several times and the minutes for those meetings are in the Council's agenda packet.

**Mayor Matherly** stated the Hotel/Motel Discretionary Fund Committee is not easy to chair because of the competitive process; he thanked Ms. Rogers for taking on the Committee.

**Mr.** Cleworth thanked Ms. Rogers for taking the Chair position of the Committee and shared how happy he was that it was a seamless process this year.

**Ms. Rogers** reported that there were applicants who did not receive funds for various reasons but that the group made sure the process was done thoroughly.

Golden Heart Parking Services Board of Directors – Mr. Cleworth stated that one problem with the parking garage is that people have used the tower as a place to sleep because it is heated. Mr. Cleworth stated that the City came up with a solution of installing card readers to get into the tower. He stated it is a safe facility and is well run by its manager and staff.

**Ms. Huntington** stated she has a full female staff and they all feel safe using the parking garage because of the additional security measures.

## **COUNCIL MEMBERS' COMMENTS**

**Ms. Huntington** thanked Public Works for the great job on snow removal in the City. She offered condolences to the family of former Fire Chief Warren Cummings and stated that she would attend his building dedication ceremony. She thanked the Engineering Department for all the work they dedicated to Ordinance No. 6038.

Ms. Rogers thanked Julie Jones for bringing the letter from the Mayor of Fanano, Italy, and she spoke of her involvement in the Sister City group. She spoke to the importance of having a

Sister City relationship. **Ms. Rogers** asked that everyone turn on their headlights when driving and encouraged everyone to drive safely.

**Ms. Therrien** asked for an update on the investigation into former Police Chief Randall Aragon. Mr. Meeks reported that he received it just before the Council Meeting and that the Mayor has not had a chance to see it yet. He stated he would be sending it out to Council Members after Attorney Ewers had time to review it.

**Ms. Therrien** stated she took her daughter on a trip to Fanano, Italy, and she stated that she supports a Sister City relationship.

**Mr. Pruhs** thanked the City Clerk's Office for the memo to the Council. He spoke to the anniversary of the 1967 flood, and he encouraged the Council to acknowledge it in some way.

**Mr.** Cleworth offered his condolences to the family of former Fire Chief Warren Cummings and shared that it was an honor to work with him. He spoke to Chief Cummings' great attitude and stated that he was a wonderful advocate for the Fire Department. **Mr.** Cleworth thanked the Clerk's Office for the memo and spoke to the plummeting traffic citation revenue. He asked Attorney Ewers if the money from the sale of the snow dump was still in limbo.

Mr. Ewers stated that the funds have not been received yet and that there are a number of things to be done procedurally before receiving the funds. Mr. Cleworth stated he feels strongly that the funds should not go into the Permeant Fund. He stated that the employee Christmas party was a very happy event and that morale has improved. He thanked Mayor Matherly for making it a priority. Mr. Cleworth spoke to the murder rate in Chicago and spoke to the hesitancies of officers rushing into tense situations or issuing citations. He stated that the hesitation may stem from the number of officers being killed in the line of duty nationwide.

Mr. Norum stated he had no comments.

**Ms. Therrien** asked if the Council wanted to take a position on the Borough ordinance to extend liquor establishment hours. She asked Chief Jewkes to come forward. Borough representative Brittany Smart came forward to provide more information about the ordinance.

Attorney Ewers informed the Council that they could not vote on a resolution without proper public notice. He stated that Mr. Pruhs could relay to the Borough Assembly that it is the sense of the Council to oppose the ordinance. No Council Members spoke in support of the ordinance.

The motion to RESOLVE was not permitted.

**Ms. Huntington**, seconded by **Mr. Norum**, moved to ENTER Executive Session for the purpose of discussing AFL-CIO Labor Negotiations and the Gavora, Inc. v. City of Fairbanks Settlement Offer.

Mayor Matherly called for objection and, hearing none, so ORDERED.

Mayor Matherly called for a five minute recess.

  - (3) Must have a current Alaska State Driver's License.
  - (4) Must not have any delinquent city criminal or traffic fines or fees.
  - (5) Must not have had their driver's license suspended or revoked within two years of the date of application.
  - (6) Must not have had a conviction within 24 months of:
    - Reckless or negligent driving;
    - b. Driving while license is canceled, suspended, revoked, or in violation of a limitation.
  - (7) Except as otherwise provided in this subsection, the applicant must not have had a felony conviction within eight years or a misdemeanor conviction within four years of:
    - a. Prostitution or promotion of prostitution;
    - Any offense involving a controlled substance under AS Title 11, Chapter 71 or the laws of another jurisdiction having substantially similar elements;
    - c. Any felony or misdemeanor assault;
    - d. Burglary, felony theft, fraud or embezzlement;
    - e. Any sexual offense;
    - f. Any homicide or assault involving operation of a motor vehicle;
    - g. Two separate felony convictions of any type:
    - h. Driving a vehicle while intoxicated within five years or within eight years for a felony conviction;
    - i. Refusal to submit to a chemical test as defined in AS 28.35.032 within five years or within eight years for a felony conviction.
  - (8) The applicant must not be addicted to the use of intoxicants or narcotics.
  - (9) The applicant must not be a sex offender or kidnapper subject to the registration requirements of AS Title 12, Chapter 63.
- (b) The city clerk's office will procure an online criminal history report for each applicant, the cost of which will be included in the chauffeur license application fee in the city schedule of fees and charges for services.

**WHEREAS,** the change in the annual CPI was 0.4 percent and 0.5 percent for 2016 and 2015, respectively; and

**WHEREAS**, the Fairbanks North Star Borough landfill tipping fees increased by \$4.00/ton and \$2.00/ton in 2016 and 2015, respectively.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FAIRBANKS, ALASKA, to approve the attached version of the *Schedule of Fees and Charges for Services* amending the refuse collection rates, effective April 1, 2017.
