# FAIRBANKS CITY COUNCIL REGULAR MEETING MINUTES, SEPTEMBER 14, 2015 FAIRBANKS CITY COUNCIL CHAMBERS 800 CUSHMAN STREET, FAIRBANKS, ALASKA

The City Council convened at 7:00 p.m. on the above date to conduct a Regular Meeting of the Fairbanks City Council at the City Council Chambers, 800 Cushman Street, Fairbanks, Alaska, with Mayor John Eberhart presiding and with the following Council Members in attendance:

### **INVOCATION**

The Invocation was given by City Clerk Danyielle Snider.

### **FLAG SALUTATION**

Mayor Eberhart led the Flag Salutation.

### **CITIZEN'S COMMENTS**

<u>Frank Turney</u>, 329 6th Avenue, Fairbanks – Mr. Turney spoke to the right to free speech that is guaranteed by the First Amendment to the United States Constitution. Mr. Turney stated that he met with the Mayor the past winter, prior to his interview with Channel 11, regarding the burial of Chief Nagita and to discuss what he could report on. Mr. Turney stated that he is the caretaker of the Clay Street Cemetery by contract with the City of Fairbanks and that he does not

agree that there is a conflict of interest as Mr. Pruhs had previously stated. Mr. Turney thanked City Attorney Paul Ewers and City Clerk Danyielle Snider for reexamining the burial site to help ensure the remains went back in the right gravesite. Mr. Turney stated he has worked at the Clay Street Cemetery since the 1980's. Mr. Turney shared his support for naming the Fire Station after Fire Chief Warren Cummings.

<u>Victor Buberge</u>, P.O. Box 58192, <u>Fairbanks</u> – Mr. Buberge thanked the City for the repairs they had performed on Gilmore Street. Mr. Buberge stated that tax payers are footing the bill for all of the Mayor's travels and per diem. Mr. Buberge asked why Executive Sessions are not broadcast on the radio and commented that the general public should be able to hear what goes on during those sessions. Mr. Buberge expressed his disappointment in Mr. Pruhs' public comments at the last meeting regarding Mr. Turney's position as the grounds keeper at the Clay Street Cemetery.

<u>Terry Doerr, 306 Antoinette Avenue, Fairbanks</u> – Mr. Doerr stated he has an issue he has been dealing with the City on all summer long. Mr. Doerr stated that there are large chunks of blacktop and large rocks that were left behind after resurfacing the road he lives on. Mr. Doerr stated he spoke with Engineer II Sam Carlson several times over the summer and that Mr. Carlson put his property on a waiting list to be attended to. Mr. Doerr stated that the water has built up to the point that now it is spilling into his neighbor's driveway and that something needs to be done about it.

**Mr. Matherly** thanked Mr. Doerr for his testimony and asked if he knew for sure that he was on a waiting list.

Mr. Doerr stated that his property is on Exclusive Paving's punch list but that nothing has been done to this point.

**Mr. Matherly** stated he would drive by the property and make a few calls to ensure that Mr. Doerr's property is attended to.

**Mayor Eberhart** stated that this is the first time he has heard of the issue and that he will have Chief of Staff Jim Williams speak with Public Works and Engineering staff to verify that the property issue is resolved.

Hearing no more requests for public comment, **Mayor Eberhart** declared Public Testimony closed.

**Mayor Eberhart** pulled Ordinance No. 5990 from the Consent Agenda.

Mayor Eberhart called for objection and, hearing none, so ORDERED.

City Clerk Snider read the Consent Agenda, as Amended, into the record.

### **SPECIAL ORDERS**

a) The Fairbanks City Council, Sitting as a Committee of the Whole, heard interested citizens concerned with the following Appeal of Denied Application for New Chauffeur License.

Applicant: Emil G Hugny-Farr

Mr. Gatewood, seconded by Mr. Walley, moved to GRANT the Chauffeur License Appeal.

Emil Hugny-Farr, 1654 Eielson Street, #7, Fairbanks – Mr. Hugny-Farr stated that there is no doubt that he committed the assault but indicated that he is very sorry for it. He stated he took the Alternative to Violence Program (AVP) and LEAP Classes and that he has learned a great deal from the classes; he stated that he is about to become a trainer for the AVP. Mr. Hugny-Farr stated that now when he and his fiancé start to argue he steps away and takes a drive. He added that being a chauffeur would be helpful for him in avoiding situations of conflict. Mr. Hugny-Farr stated that he worked as security for the Goldpanners over the summer.

**Mayor Eberhart** asked Mr. Hugny-Farr if he is currently employed. Mr. Hugny-Farr stated that he is not currently working. **Mayor Eberhart** asked if he has a good chance of getting hired by a local cab company; Mr. Hugny-Farr stated he would be working for Eagle/Yellow Cab Company.

**Mr. Gatewood** asked Mr. Hugny-Farr to clarify when he took the LEAP Classes and asked why he checked "no" on the box in reference to assault convictions on the Chauffeur license application. Mr. Hugny-Farr replied he has some learning disabilities and that someone who was helping him complete the application advised him not to mark "no" to that question on the application.

**Mayor Eberhart** stated that the look back period for misdemeanor assault is four years and that even if Mr. Hugny-Farr is denied the appeal he could reapply for a Chauffeur's License in December of 2015.

**Mr. Matherly** asked Mr. Hugny-Farr about the driving without a chauffeur's license charge that is on his record from last year. Mr. Hugny-Farr stated he was driving his own vehicle and that a woman offered to pay him \$50 to drive her to North Pole. He stated that upon arriving at the North Pole Safeway that the woman started freaking out and he had to call the police to deal with her. Mr. Hugny-Farr stated that he did not realize giving someone a ride in his own vehicle for a fee was illegal.

<u>Victor Buberge</u> – Mr. Buberge stated he does not think the City Council should consider Chauffeur appeals; he commented that it should be a matter left up to the court.

Hearing no more requests for public comment, **Mayor Eberhart** declared Public Testimony closed.

**Mr.** Cleworth asked City Attorney Paul Ewers if Mr. Hugny-Farr can come back in December to reapply; Mr. Ewers replied affirmatively. **Mr.** Cleworth stated that given Mr. Hugny-Farr's lengthy criminal record he has some concern. He stated, however, that since Mr. Hugny-Farr could come back in December and obtain the license he did not see a reason to deny the appeal.

**Mr. Matherly** stated he appreciates Mr. Hugny-Farr coming in to appeal and that he believes that the appeal process is a good thing for citizens.

**Mr. Pruhs** echoed Mr. Matherly's thoughts on the appeal process. **Mr. Pruhs** stated the Council gets a view of the big picture and the Clerk only sees a box that is checked.

**Mr. Gatewood** stated he is bothered by the non-truthfulness on Mr. Hugny-Farr's application but that he sees Mr. Hugny-Farr has done a lot of work taking classes. **Mr. Gatewood** stated that he will vote in favor of granting the appeal.

Mayor Eberhart declared the MOTION CARRIED.

### MAYOR'S COMMENTS AND REPORT

Mayor Eberhart stated that he recalled meeting with Mr. Turney to discuss the interview with Channel 11 and that he told Mr. Turney that he could speak for himself in the interview. He stated that he could not report to the media on behalf of the Clay Street Cemetery Commission. Mayor Eberhart stated that three days earlier was the anniversary of September 11th and he thanked first responders for making the decision to serve as emergency personnel. Mayor Eberhart stated he hopes that the Fire Department and the City can press reset on their

relationship. **Mayor Eberhart** stated that September15 – October 15 is Hispanic Awareness Month. He stated that Fairbanks Diversity Council Member Doug Toelle is being inducted into the National Multiple-Sclerosis Society Hall of Fame in November. **Mayor Eberhart** spoke to the Polaris Building issues and stated that Mr. Marlow is no longer the owner of the building. **Mayor Eberhart** stated that three new fire fighters will be starting at the Fire Department next week and that one of them is a female. **Mayor Eberhart** stated that on his vacation he took a tour to Fanano, Italy, Fairbanks' Sister City. He reported on the many activities he took part in while in Fanano and stated that the people of Fanano were very interested in the City of Fairbanks' student work study program. He listed other activities of the Mayor's Office since the last Regular City Council Meeting. **Mayor Eberhart** stated that the fourth semester of student work study kicked off recently and that Fairbanks is the only City in Alaska that has such a program. **Mayor Eberhart** stated that when he became Mayor he asked the Information Technology (IT) Department to revamp the website and the students from the work study group did much of the work on that request.

Mr. Gatewood questioned why students were the people doing the work on the City website.

**Mayor Eberhart** asked IT Director Ben Barrio to speak to Mr. Gatewood's question. Mr. Barrio stated that the City IT Department is not trained in graphic art or website development. Mr. Barrio stated that his staff's training and focus is to keep the City secure and maintain all informational systems. Mr. Barrio stated he had graphic art students work on the project because they had fresh ideas; he stated it benefited the students by helping them reach their internship goals and it benefited the City by alleviating some of the workload.

### **NEW BUSINESS**

a) Resolution No. 4687 – A Resolution Authorizing the City of Fairbanks to Accept Funds from the Alaska Division of Homeland Security for the FFY2015 State Homeland Security Program. Introduced by Mayor Eberhart.

Mr. Gatewood, seconded by Ms. Staley, moved to APPROVE Resolution No. 4687.

**Mr. Gatewood** requested that Grants Administrator Margarita Bell come forward to explain the number discrepancies between the resolution and the attached fiscal note.

Ms. Bell stated that Resolution No. 4687 speaks to the amount of money the City is receiving from Homeland Security and that the fiscal note speaks to the amount the City plans to expend. She clarified that the number in the fiscal note includes both the grant funds and the matching funds. She stated that the matching funds have been appropriated from the Capital budget.

**Mr. Gatewood** asked if the \$500.00 maintenance cost that is listed was for an individual camera or for all 12 units. Ms. Bell stated the cost was for all 12 units.

**Mr.** Walley asked if warranty costs were included, and Ms. Bell replied affirmatively.

**Mr. Gatewood** asked how the numbers were calculated; Ms. Bell replied that they priced out individual units and then multiplied that price by the number of units requested.

**Mr.** Cleworth asked for clarification on the match. Ms. Bell stated that the grant amount requested was not fulfilled but that the department is supplementing the cost of the units. **Mr.** Cleworth asked what kind of laptops are being requested, and Ms. Bell replied that they are Dell laptops that will go into police vehicles.

Mr. Barrio stated that the Dell laptops would replace end-of-lifecycle laptops that are currently in police vehicles. Mr. Barrio stated that the existing laptops have a lot of warranty repair issues and screen delamination problems. Mr. Barrio stated that they are test driving a couple different options and that they are looking into the units that the State of Washington is currently using.

Mayor Eberhart declared the MOTION CARRIED and

Resolution No. 4687 APPROVED.

b) Resolution No. 4688 – A Resolution Awarding a Contract to Westnet, Inc. for the Fire Station Alerting System Upgrade RFP 15-13. Introduced by Mayor Eberhart.

Mr. Matherly, seconded by Mr. Gatewood, moved to APPROVE Resolution No. 4688.

**Mr.** Cleworth asked if someone could give a staff report on Resolution No. 4688. Dispatch Center Manager Stephanie Johnson explained that the existing alerting system is no longer being updated or supported so it will need to be replaced. **Mr.** Cleworth asked if the alerting system is separate from the Firehouse system; Ms. Johnson replied affirmatively. She stated explained how the new system would work and reiterated the importance of replacing the existing system.

A ROLL CALL VOTE WAS TAKEN ON THE MOTION TO APPROVE RESOLUTION NO. 4688 AS FOLLOWS:

Mayor Eberhart declared the MOTION CARRIED and

Resolution No. 4688 APPROVED.

c) Resolution No. 4689 – A Resolution Honoring Warren B. Cummings by Dedicating and Renaming Fire Station One in His Honor. Introduced by Mayor Eberhart.

Mr. Pruhs, seconded by Mr. Matherly, moved to APPROVE Resolution No. 4689.

**Mr.** Gatewood stated that he is in favor of honoring Chief Cummings by renaming the Fire Station at some point but that he does not think that it is the right time to do it. **Mr.** Gatewood stated that he was not sure whether a vote on the resolution would have an impact on the

upcoming Executive Session. **Mr. Gatewood** stated that there is no reason to rush a vote and suggested that it could be further discussed at a later date.

**Mr.** Cleworth stated that Resolution No. 4689 is a great resolution but that he is in agreement with Mr. Gatewood on the issue.

**Mr. Cleworth**, seconded by **Mr. Walley**, moved to POSTPONE Resolution No. 4689 to the Regular Meeting of October 5, 2015.

A ROLL CALL VOTE WAS TAKEN ON THE MOTION TO POSTPONE RESOLUTION NO. 4689 TO THE REGULAR MEETING OF OCTOBER 5, 2015 AS FOLLOWS:

Mayor Eberhart declared the MOTION CARRIED.

d) Ordinance No. 5990 – An Ordinance to Amend FGC Section 2-61 Regarding the Mayor's Compensation. Introduced by Council Member Cleworth.

Mr. Gatewood, seconded by Ms. Staley, moved to ADVANCE Ordinance No. 5990.

**Mayor Eberhart** questioned the reasoning behind Ordinance No. 5990. He stated that he is a City employee and should be treated the same as other employees. **Mayor Eberhart** asked Mr. Cleworth to explain his reasoning for introducing the ordinance.

Mr. Cleworth stated that he blames himself for not introducing the ordinance years ago when he was Mayor and that the issue has bothered him for some time. Mr. Cleworth stated that when he became the Mayor, Payroll came to him and requested that he keep a timesheet to track hours worked. Mr. Cleworth stated that he told Payroll that he did not see a need to keep a timecard because the Mayor's position is salaried. Mr. Cleworth stated that he called the Borough and asked how their Mayor claimed comp time and they informed him that the Borough Mayor does not receive comp time. Mr. Cleworth stated that the ordinance came up because of a citizen complaint regarding how much comp time is being claimed by the Mayor.

**Mayor Eberhart** stated that comp time came into effect in 1995 and that the Mayor is an employee of the City.

**Mr.** Cleworth stated that every Mayor since that time has claimed comp time with the exception of himself.

**Mayor Eberhart** stated that he can only accrue 240 hours of comp time and that he has worked in excess of the hours he has in his comp bank. **Mayor Eberhart** stated that this ordinance is a disincentive for working extra hours because he would not receive any compensation for all the extra work. **Mayor Eberhart** stated that if it is not broken, then do not fix it. He asked Chief of Staff Jim Williams and Human Resources Director Angela Foster-Snow to come forward and speak to the importance of comp time.

Mr. Williams stated that comp time is a retention tool for employees.

Ms. Foster-Snow stated that there are a lot of additional hours worked at her position and that it is important to keep dedicated workers. She stated that comp time is a way to make employees feel valued.

Mr. Cleworth stated that Ordinance No. 5990 does not affect regular City employees. He stated that the ordinance only applies to the Mayor who is an elected official. Mr. Cleworth stated that he hopes people run for Mayor because they want to serve the community, not because they want to earn comp time. He stated that he hopes Mayor Eberhart does not lose his incentive to work for the City. Mr. Cleworth stated that the intent of the ordinance is not to take away anything that the Mayor has already earned. He reiterated that the Mayor's position is different than that of regular City employees.

**Mr. Gatewood** asked how the Borough Mayor takes a vacation if he does not receive comp time or annual leave.

**Mr. Cleworth** replied that he just takes time off.

**Mr.** Walley questioned whether the Mayor needs to fill out a timecard. He asked City Attorney Paul Ewers if it can be changed so that the Mayor would not have to enter his time. Mr. Ewers stated that governmental entities all have different rules about salaried employees filling out timecards. **Mr.** Walley asked what would happen if the Mayor did not fill out a timecard. Mr. Ewers replied that nothing would happen and that according to the Fair Labor Standards Act (FLSA), elected officials are not considered employees.

**Mr. Pruhs** stated that he would like to take a look at the Mayor's total compensation package before voting on Ordinance No. 5990. **Mr. Pruhs** stated that he would like to discuss the Mayor's entire compensation package in a Finance Committee meeting.

<u>Fairbanks Diversity Council (FDC)</u> – **Mr. Gatewood** stated that the FDC met recently and that the group continues to discuss their role in making the City more diverse. **Mr. Gatewood** spoke to the presentation by University of Alaska Fairbanks (UAF) Professor Dr. Nicole Cundiff regarding municipality equality index (MEI) scores and the importance of the LGBT population. **Mr. Gatewood** stated that the both the Mayor's Office and the Chief of Police have reached out to the LGBT community.

### **COUNCIL MEMBERS' COMMENTS**

**Mr. Matherly** stated he appreciated Mr. Doerr's testimony and also thanked Mr. Hugny-Farr for coming in for his appeal. **Mr. Matherly** spoke to the decorum standards that should be observed during the City Council meetings. **Mr. Matherly** stated that near the beginning of every meeting, the City Clerk reads the standards of decorum into the record, which state that public members should address the Council as a body rather than any particular Council member.

**Mr.** Cleworth stated that he would like to request a Work Session to address the Polaris Building. **Mr.** Cleworth stated that options need to be looked at on the federal level because there would not be any money coming out of Juneau. **Mr.** Cleworth spoke to the issue with Mr. Doerr's property.

Mr. Pruhs stated he hoped that Mr. Doerr's property issue gets resolved quickly. Mr. Pruhs stated that it is time to have a Work Session about the Polaris Building and he updated the Council that Mr. Marlow is no longer an owner of the building. Mr. Pruhs stated that the best way to get rid of the Polaris Building is to seek out federal funding and that he has asked Representative Lisa Murkowski to help with the project. Mr. Pruhs stated that City Development Manager Pat Smith will be taking part in a video conference to discuss the possibility of federal funding. Mr. Pruhs stated that the Polaris Building must be knocked down; he discussed the black and green mold issues in the building.

Ms. Staley asked if the new owner has any interest in renovating the Polaris Building.

**Mr. Pruhs** stated that at this time he does not know if the new owner intends to develop the building. **Mr. Pruhs** stated that legal has reached out to him with no response.

**Mr.** Cleworth stated that Mr. Marlow had two notes on the property; he inquired as to whether the notes had been consolidated.

**Mr. Pruhs** stated that the note holder, Ken Gain, does not want the building.

**Ms. Staley** encouraged everyone to attend the F-35 scoping meetings. **Ms. Staley** stated that when she was in North Carolina gas was \$1.65 a gallon; she commented when she returned to home, she could not believe how expensive it is to live in Fairbanks.

**Mr.** Walley stated he had no comments.

**Mr. Gatewood** stated that he agreed with Mr. Pruhs in regard to discussing the Mayor's entire compensation package. **Mr. Gatewood** stated that the next Finance Committee meeting may be too soon to discuss the topic.

**Mr.** Cleworth stated he did not realize that there was a Finance Committee meeting the following morning and agreed with Mr. Gatewood that it would be too soon to discuss the compensation package for the Mayor.

## AN ORDINANCE TO AMEND FAIRBANKS GENERAL CODE CHAPTER 14, ARTICLE XIII BUSINESS LICENSING

**WHEREAS**, on September 21, 2015, the City Council approved Resolution No. 4690, amending the City's Fee Schedule to increase business license fees effective January 1, 2016; and

**WHEREAS,** Resolution No. 4690 increased the minimum business license fee from \$25.00 to \$40.00; and

**WHEREAS**, FGC Sec. 14-602(a) states that the minimum business license fee shall remain at \$25.00 until further amendment by ordinance.

NOW, THEREFORE, BE IT ENACTED BY THE CITY COUNCIL OF THE CITY OF FAIRBANKS, ALASKA, as follows:

<u>Section 1</u>. That Fairbanks General Code Chapter 14, Article XIII, Section 14-602(a) is hereby amended as follows [new text in **underlined bold** font; deleted text in **strikethrough** font]:

### Sec. 14.602. – License fee registration.

- (a) The annual license registration shall be based on gross receipts from the prior year regardless of the number of physical locations in the city where the business is conducted. The fee schedule shall be adjusted as part of the annual budget estimate by the estimated annual change in the Anchorage Consumer Price Index (CPI-U) with subsequent year adjustment to reflect the actual change and shall be published in the City Schedule of Fees and Charges for Service with fees rounded to the nearest dollar. The minimum license fee shall remain at \$2540.00 until further amendment by ordinance.
- (b) Any business entity that does not have an established business premises in the Fairbanks North Star Borough but that provides one-time or intermittent contractual products or services within the city must obtain a City of Fairbanks business license prior to delivery of such products or services. The business license fee amount shall be calculated based upon the estimated gross proceeds (receipts) of the products/services provided under each contract.

An ordinance amending Section II, Goals, Policies and Objectives of the

Chena Riverfront Plan.

The Fairbanks North Star Borough (FNSB) Code Title 2, Section 2.37.080(B), requires that the Chena Riverfront Plan be revised "from time to time". After the Parks and Recreation Commission and Planning Commission reviews and makes recommendations for the Plan, then the proposed revisions are to be adopted by the Fairbanks City Council and the FNSB Assembly. Currently, the Plan itself calls for updates every five (5) years. However, one proposed revision to the Plan is to change the time frame to "at least every ten (10) years".

The Chena Riverfront Commission (CRFC) held several presentations to introduce the Plan updates to the public. The CRFC was the Keynote Speaker at the Chena Riverfront Summit, sponsored by the Tanana Valley Watershed Association. The proposed revisions to the Plan were presented to various community service groups. These groups include the Fairbanks Downtown Rotary, College Rotary and North Pole Rotary. An open house was held at the Noel Wien Library's Auditorium on July 9, 2014. In addition, the Plan was presented in a work session to the Fairbanks City Council on August 25, 2014.

The CRFC voted to approve all revisions to the Plan on October 8, 2014.

The Plan was presented to the Parks and Recreation Commission on September 21, 2015 for review. The Parks and Recreation Commission had no revisions and approved the Plan update. Their approved meeting minutes are attached as **Exhibit 1**.

The final draft of the Chena Riverfront Plan Update was reviewed by the Planning Commission on November 10, 2015. The Planning Commission made a recommendation of approval with no revisions (**Exhibits 2 & 3**).

After the Fairbanks City Council's public hearing to review and adopt the Plan, a public hearing will be scheduled before the FNSB Assembly for adoption. The proposed ordinance for the FNSB Assembly is attached as **Exhibit 4**.

### **VALUE**

### -Intent

The Fairbanks community has both treated and mistreated the Chena River in several ways over the years. It is time now for Fairbanks to recognize the river as its crown jewel and to make sure it takes its rightful place as the central focus of the community. The time has come for all area residents and visitors to do what they can to promote the health and sustainability of the Chena River, the second, most productive young King Salmon (Chinook) stream in the Alaskan portion of the Yukon River.

## GOAL I: RECOGNIZE AND RESTORE THE RIVER AS THE CROWN JEWEL OF THE COMMUNITY.

- **1. POLICY:** Encourage the creation and maintenance of areas of natural and man--made beauty along the river corridor.
  - A. OBJECTIVE: Develop voluntary riverbank management guidelines to assist property owners with erosion control
    - and landscaping concerns.
  - B. OBJECTIVE: Implement annual litter control and river cleanup projects.
- **2. POLICY:** Conserve as much as feasible the integrity of the river's natural system.
  - **A. OBJECTIVE:** Identify and inventory <u>important critical</u> habitats within the river corridor.
  - **B. OBJECTIVE:** Create and maintain greenbelts in the watershed and river corridor.
  - C. OBJECTIVE: Consider Hhydrologic and sediment transport impacts of new bridge construction must also be
    - <del>considered</del>.
- **3. POLICY:** Evaluate and review public and private development projects in the context of how well the project <u>meets the adopted</u> goals and objectives of the Chena Riverfront Planincorporates the river into the project's design.
  - **A. OBJECTIVE:** Create voluntary architectural and landscaping design guidelines for use along the river corridor.
  - B. OBJECTIVE: Landscaping will be rRequired landscaping of all borough funded projects, request landscaping for all other publicly funded projects along the corridor and strongly recommended landscaping forf all
    - private commercial and industrial projects.
- 4. POLICY: Maintain riverfront residential property land use through use of consistent zoning.

- **5. POLICY:** Reduce pollution of the river.
  - A. OBJECTIVE: Apply economically achievable, best available technology to mitigate the effects of <u>invasive aquatic</u> species such as <u>Elodea and</u> possible pollutants, <u>including those borne in storm-water runoff</u>, on the river, as <u>well as those potentially born in storm-water runoff and invasive aquatic species, such as</u>

Elodea.

B. OBJECTIVE: Encourage riverfront property owners (public and private) to use shoreline practices that provide for

healthy fish and wildlife habitat, such as: retaining some natural stream bank vegetation to filter upland run-off and reduce erosion; properly disposing yard waste by avoiding the river or riverbank;

and minimizing upland pollutants that could wash into the river.

- 6. POLICY: Support Chena River recreational fishery and habitat improvement efforts, such as supporting river cleanup efforts; improving filtration methods for storm-water runoff and educating riverfront property owners about pollution sources.
- **7. POLICY:** Enhance recreation value by encouraging incorporation of the river into the various other uses, such as community events, recreation and fisheries.
- 8. POLICY: Update the Chena Riverfront Plan at least every ten (10) five (5) years.

### **OPPORTUNITIES**

### <u>Intent</u>

——The intent of this goal is to take advantage of present and future opportunities as they relate to new economic investments, expanded historical/cultural awareness and recreational uses.

The Chena River presents numerous opportunities to the Fairbanks community. The Main Street Fairbanks (now called the Downtown Association) Chena Riverfront Design Workshop of 1990 representing a broad cross section of the community, identified the following three:

- 1) Economic linkages between existing developments can be strengthened. Tourism expansion can be enhanced by how we treat the river.
- 2) Historical and cultural ties to the river have been lost over the years. A sense of place developed through the river will promote Fairbanks' identity and image as a desirable place to live, visit and do business.
- 3) Opportunities to improve recreational uses exist up and down the river in both the urban and rural contexts.

## GOAL II: DEVELOP AND INTEGRATE THE RIVER'S MULTIPLE ORIENTATIONS TO CREATE AN INTEGRATED WHOLE.

### **ECONOMIC DEVELOPMENT OPPORTUNITIES**

- **1. POLICY:** Encourage strategies to stimulate new private sector riverfront development.
  - **A. OBJECTIVE:** Develop methods by which use of property tax codes can provide incentives and encouragement for riverfront property enhancements<del>improvements</del>.
  - **B. OBJECTIVE**: Use public land resources and facilities to enhance river\_oriented business opportunities.
  - C. OBJECTIVE: Develop a marketing plan that centers on the river to be used in attracting new private sector investment.
    - **OBJECTIVE**: Expand river\_related winter tourism.

- **5. POLICY:** Support the creation and development of a native cultural center at an appropriate location.

### **RECREATIONAL OPPORTUNITIES**

- **6. POLICY:** Build upon and increase the recreational opportunities of the river for individual, public, and commercial purposes.
  - **A. OBJECTIVE:** Expand winter tourism through use of a variety of creative concepts.
  - **B. OBJECTIVE:** Provide linkages between parks through use of greenbelts, <u>designated pathways</u>, conservation easements or consistent landscaping.
- 7. POLICY: Focus existing riverfront properties such as Pioneer Park and Griffin Park toward the river.
  - A. - **5. POLICY:** Provide the FNSB Planning Commission and the Fairbanks City Council with annual updates on progress and challenges in implementing the Chena Riverfront Plan.

### **ACCESS**

### -Intent

Making physical connections between town and river is fundamental to any riverfront planning effort. Parks, greenways, trails, boating access points and other public lands can guarantee that people can reach the water. Landowners also can make useful connections by 1) orienting uses to the water in ways that result in a heightened awareness of river qualities, and 2) encouraging public access to and along the river through private property to establish continuous connections for public trail systems. The reliverfront pelan does not advocate the use of eminent domain or inverse condemnation on property to achieve its goals, policies or projects and instead, the Plan advocates the use of incentives, negotiated agreements and other positive inducements to implement the pelan.

## GOAL IV: CREATE AND ENHANCE PHYSICAL AND VISUAL ACCESS TO THE RIVER FOR ALL PEOPLE.

- **1. POLICY:** Incorporate the river into the community's daily life by increasing visual and physical access to and along the river when it is compatible with riverfront habitat sustainability.
  - **A. OBJECTIVE:** Improve existing access points with landscaping, parking, signage, maps and seating where practical.
  - **B. OBJECTIVE:** Create a safe environment for public riverfront use through additional lighting, appropriate landscaping and maintenance.
  - C. OBJECTIVE: Add new <u>public</u> access points <u>to the river</u> designed to accommodate <u>public use for year-round</u> summer fishing and wintertime sports and recreation activities.
  - **D. OBJECTIVE:** Construct new paths along, above, and as close as possible to the riverbank in order to take full advantage of river views.
  - **E. OBJECTIVE**: Enhance boat accessibility to and along the Chena River downtown and elsewhere.
  - **F. OBJECTIVE:** Enhance trails along the riverfront.

- **A. OBJECTIVE:** Provide for and encourage multi-modal transportation options, such as boat launches, canoe/kayak launch sites and river marina.
- **B. OBJECTIVE:** Develop year—round transportation and design linkages that will serve and connect riverfront attractions to other nearby attractions with emphasis on the downtown core area.
- **C. OBJECTIVE:** Develop appropriate incentives for landowners who provide public access along the river.
- **D. OBJECTIVE:** Develop new bike path routes that are compatible with adjacent land use and are safe and relaxing to use.
- **E. OBJECTIVE:** Support beneficial projects that <u>will</u>-utilize waste heat from the <u>AuroraChena River</u>\_power plant.
- **F. OBJECTIVE:** Encourage and assist commercial property owners to seek public funding to develop boat launches.
- **G. OBJECTIVE:** Work to enhance the <u>connection between river corridor from Pioneer Park and to downtown along the river corridor.</u>
- **3. POLICY:** Ensure that the urban riverfront corridor is pedestrian friendly.
  - **A. OBJECTIVE:** Encourage riverfront development that gives aesthetic consideration to all new and existing facilities within the riverfront corridor, including transportation projects.
  - **B. OBJECTIVE:** Encourage proposed riverfront development be consistent with the adopted Chena Riverfront Plan.
  - C. OBJECTIVE: Support public events scheduled along roadways adjacent to the river, including events that involve pedestrian-only roadway use.
- **4. POLICY:** Consider the aesthetic effect of all new bridge construction and evaluate new bridge projects from the perspective to the river as well as from the river.
- **5. POLICY:** Refer to comprehensive road plan policies for all new transportation projects planned within the river corridor.

### **STEWARDSHIP**

### <u>Intent</u>

Coordinating with agencies, groups and organizations that have interest in the river is a fundamental responsibility of the Commission. Many functions are well-established and others are continually evolving. This Plan advocates for actions that will improve and sustain the riverine health of the river, without adding additional regulatory oversight. Working within existing legal and policy structures, the Plan will continue to promote the well-being of the river and its riverfront for all Borough residents.

# GOAL V: ENSURE THAT APPROPRIATE ELEMENTS OF PUBLIC SAFETY, PROTECTION OF PRIVATE PROPERTY VALUES AND RIVER PLANNING EFFORTS ARE MAINTAINED.

### FLOOD-PLAIN MANAGEMENT

- **1. POLICY:** Support and encourage local flood-plain management efforts related to land use planning for the areas affected by the flood control project, which should includeing riparian zone management, channel capacity, impacts to fisheries, and public awareness programs related to flood hazards.
  - **A. OBJECTIVE:** Work proactively to pursue a plan to educate the public on harm caused to the river by sedimentation dynamics.
  - **B. OBJECTIVE:** Work proactively to pursue a plan to avoid sedimentation buildup within the Chena River.
  - C. OBJECTIVE: Support pertinent local, state and federal agencies in gathering new information on the basic physical and habitat characteristics of the Chena River through cost-shared studies, such as the 1997 USGS Chena River Watershed Study for future planning purposes.

### **REGULATORY**

**2. POLICY:** Support appropriate comprehensive planning and zoning to achieve development that is consistent with this plan.

- **A. OBJECTIVE:** Modify the FNSB zoning code to include an optional "Riverfront Influence Area" that offers greater flexibility to riverfront property owners in exchange for certain public amenities.
- **B. OBJECTIVE:** Create a rational and variable river setback distance based on consideration of river erosion rates, bank stability, aesthetics and habitat.
- **C. OBJECTIVE:** Promote provision of a comprehensive, public source of all waterway regulations by all agencies affecting development and use within the riverfront corridor.

### COORDINATEION PROACTIVELY WITH OTHER AGENCIES ON PROACTIVE EDUCATION

- **3. POLICY:** Coordinate with other river-interested parties to minimize duplication of regulatory and educational effort.
  - **A. OBJECTIVE:** Support further development of collaborative programs to assist property owners with bank erosion control guidelines.
  - B. OBJECTIVE: In cooperation with the US Coast Guard and other enforcement agencies (including ADF&G and USFWS), create and implement a series of short courses and a signage program that address boat safety, multi-use courtesy and navigational hazards of the river.
  - C. OBJECTIVE: Work with appropriate local, state and federal agencies, and the private sector to plan for the implementation of NPDES Storm Water regulations in both urban and rural areas along the Chena River corridor.
  - **D. OBJECTIVE:** Support the continuation of studies on the basic physical and biological habitat of the Chena River Watershed.
  - **E. OBJECTIVE:** Support corrective action to increase the water flow through the Chena River Watershed, including Badger (Chena) Slough and Noyes Slough.
  - F. OBJECTIVE: Coordinate closely with the Tanana Valley Watershed Association (TVWA) to enhance the progress of both the Chena Riverfront Commission and the TVWA.

## 2016 City of Fairbanks Capital and Legislative Requests

## 1. Emergency Services Patrol Funding \$400,000

Funding would allow for continued operation of safe transportation services for incapacitated persons and chronic inebriates. This service expanded to citywide, seven days per week, approximately 19 hours per day, in April 2014. Calls for service are logged and dispatched to the Fairbanks Downtown Association (DTA) as either a response to a 911 call or as a self-initiated call by DTA personnel. Per AS Title 47, the City of Fairbanks, with delegated authority to DTA, will take incapacitated persons into protective custody for transport to their homes, Gateway to Recover Detox, Fairbanks Memorial Hospital, the Fairbanks Correctional Center 12-hour sleep off, or other appropriate destination.

## 2. Fire Station 3 Emergency Management Storage \$1,464,000

The City of Fairbanks currently has four trailers and three response vehicles stored outside in the elements. These include a medium rescue vehicle, command investigation van, Ford 550 Prime Mover for trailers, collapse rescue trailer, trench rescue trailer, Fire Prevention trailer, and a propane fire training trailer. This addition to Fire Station 3 would allow storage of these vehicles and trailers inside year round, lessening response time and wear and tear on these vital pieces of equipment.

Building \$ 1,200,000 Design (at 12%) \$ 144,000 Contingency (at 10%) \$ 120,000 Total \$1,464,000

# 3. Ambulance Replacement with Cardiac Care Upgrades \$250,000

This replacement ambulance will replace the oldest of our four ambulances and allow us to place our 2005 third line ambulance into reserve status. This replacement ambulance will become our primary ambulance and handle the majority of our ambulance calls, which exceed 3,400 annually. The Fire Department wishes to replace three outdated cardiac monitors. We wish to take advantage of current technology, such as Bluetooth connectivity and carbon dioxide monitoring, and integrate our telemetry data with Fairbanks Memorial Hospital systems in order to provide better patient care.

Replacement Ambulance \$ 175,000 Cardiac care upgrades \$ 75,000 Total \$250,000

## 4. City of Fairbanks Police Department Evidence and Warm Storage Facility \$1,800,000

The City of Fairbanks requests funds to construct a 60 foot X 60 foot area for use as the evidence locker for large vehicles and equipment and an additional 40 foot X 60 foot of warm storage space. The Fairbanks Police Department currently utilizes an unheated, severely inadequate facility to house critical evidence and records from some of the most serious cases. Criminal investigations such as murders, sexual assaults, robberies, and serious assaults often require evidence and records to be retained for an extended period of time, if not indefinitely.

# 5. Public Works Facility Back-Up Generator \$610,000 (estimated)

Funding would allow for upgrade to the emergency power supply. The current 100kW back-up generator is over 30 years old. The building and operations have increased over time well beyond the capacity of the current back-up power system. Back-up power generation is necessary to maintain critical operations in the event of a sustained power outage. Extensive electrical configuration will be

required to connect all three power meters, separate disconnects, and distribution panels. The system will provide 12 days of continuous operation without refueling.

**Total Capital Requests: \$4,524,000** 

## 2016 City of Fairbanks Legislative Priorities

## 1. Maintain Current PERS Contribution Rates

Legislative action is likely necessary to address the rising costs of Alaska's Public Employee Retirement System's (PERS) unfunded liability and the impact of rising PERS liability costs on City taxpayers. The City supports keeping PERS past service costs at 22% of gross wages and eliminating termination study requirements.

# 2. Preserve Municipal Revenue Sharing

The City of Fairbanks understands the State of Alaska's current fiscal situation and the need to remove unnecessary or duplicative expenses from the State operating budget. The City of Fairbanks is concerned that budget reductions and subsequent reductions in services at the State level will manifest at the municipal level as increased demands for services. Because of this threat, municipal revenue sharing must be maintained. The City of Fairbanks supports the deposit of \$60 million into the Revenue Sharing fund in FY2017 and on an annual basis.

# 3. Support Legislation Resulting in Municipal Cost Savings

The City of Fairbanks is aware of and attentive to the current State of Alaska fiscal situation. As a matter of fiscal policy, it is critical that the State carefully consider State department budget cuts and how the burden of budget cuts and subsequent reduction in services transfers to municipalities. PERS termination study costs and municipal senior tax exemption policies are two examples of the continuing and escalating burden placed on municipalities. The City of Fairbanks respectfully requests that the Legislature and Governor carefully consider budget cuts and their unintended effects. In addition and where practicable and fiscally responsible, the State should consider proposals to eliminate redundancies in service delivery and seek cost sharing and cost savings opportunities that are beneficial to both the State and municipalities.

# AN ORDINANCE AUTHORIZING CONVEYANCE OF EASEMENTS REQUESTED BY THE ADOT FOR THE NOBLE STREET UPGRADE AND PEDESTRIAN FACILITIES PROJECTS

WHEREAS, the Alaska Department of Transportation (ADOT) has funding for right of way acquisition and construction for the NOBLE STREET UPGRADE PROJECT STP-000S (413)/61725 (the "Noble Street Project"), and the CITY OF FAIRBANKS PEDESTRIAN FACILITIES UPGRADE PROJECT STP-002(277)/62127 (the "Pedestrian Project"); and

**WHEREAS**, the Noble Street Project will reconstruct driving lanes, sidewalks, utilities, traffic signals, and other amenities from Gaffney Road to First Avenue, providing pedestrians and the traveling public with safer routes; and

**WHEREAS**, ADOT has performed an internal appraisal of the property, which established the value at \$4,350.00, and will compensate the City in this amount; and

**WHEREAS**, the City Property Manager has reviewed the appraisal and finds the value reasonable and supported; and

WHEREAS, construction of the Pedestrian Project will provide ADA compliance at several locations and will require four temporary construction easements ("TCE's"), from the City, including Parcels TCE 15A and 15B, located on Lots 2 & 3, Block 42, Aurora Subdivision, adjacent the Aurora Drive Fire Station, and Parcels TCE 115A & 115B, located on Lot 6A, Block 66, Fairbanks Townsite, adjoining 5th Avenue and upon the pedestrian walkway at that location; and

WHEREAS, the permanent and temporary easements are depicted on "Exhibit A," and the easement documents are shown on "Exhibit B," both attached to this Ordinance.

**WHEREAS**, it is the sense of the City Council that a conveyance of the easements over the specified City-owned real property to ADOT for the purposes mentioned hereinabove is in the best interest of the public.

#### **ORDINANCE NO. 6000**

#### AN ORDINANCE AMENDING THE COLLECTIVE BARGAINING AGREEMENT BETWEEN THE CITY OF FAIRBANKS AND THE PUBLIC SAFETY EMPLOYEES ASSOCIATION TO ESTABLISH AN INTERN PROGRAM FOR STUDENTS

**WHEREAS,** the City of Fairbanks and PSEA ratified a collective bargaining agreement (CBA), effective January 1, 2011 through December 31, 2013; and

WHEREAS, changes to the collective bargaining agreement are subject to member ratification and City Council approval; and

**WHEREAS,** Section 2.3 of the January 1, 2011 CBA specifies that if the Agreement terminates during the course of negotiations, the terms and conditions of the Agreement shall be extended until a new Agreement is reached; and

**WHEREAS**, the City of Fairbanks Police Department wishes to establish an intern program for students interested in careers in law enforcement; and

**WHEREAS,** the City and PSEA collectively bargained and tentatively agreed to amend the current CBA to establish an intern program;

NOW, THEREFORE, BE IT ENACTED BY THE CITY COUNCIL OF THE CITY OF FAIRBANKS, ALASKA, as follows:

**SECTION 1**. The Letter of Agreement amending the current CBA between the City of Fairbanks and PSEA, attached as Exhibit A, is approved and ratified.

The City and PSEA have negotiated an amendment to the current collective bargaining agreement (CBA). The City and PSEA hereby agree as follows:

The CBA is amended to add the following language to Section 29:

Section 29.6. Student Interns. The City and PSEA agree to establish and maintain an efficient and effective internship program for students enrolled in qualified educational institutions. The purpose of the internship program is to develop, train and mentor students interested in law enforcement related careers covered by the existing CBA. Interns will not displace members within work areas covered by the CBA. Interns will not work more than 20 hours per week and will not receive wages or benefits. Interns must be actively enrolled in an undergraduate or graduate level degree program from an accredited university pursuing a degree relevant to a career in law enforcement or emergency management. Student interns must be recommended by their academic advisor. The City Human Resources Director and Chief of Police will jointly verify eligibility. The Chief of Police will report to PSEA when student interns are selected and when internships end.

The board approved the minutes from the May 6, 2015 meeting.

Jim Soileau reviewed the account's performance through June 30, 2015:

Jeff Johnson made a motion to approve and seconded by Council Member Gatewood to prepare an Ordinance amending the investment policy to adopt APCM's recommendation to change the allowed investments and performance for international equities and emerging markets. The recommended investments and performance measure was added to the existing policy rather than replacing it along with "or substantially similar index". The board approved the motion 4 - 0. (See Attachment 1 pages 17 and 18 and Attachment 3 for detail).

Bernard Gatewood made a motion to confirm "no objection" and seconded by Jeff Johnson to APCM's recommendation to move from Vanguard to Investable Market Index products from IShares. The board approved the motion 4 - 0. (See attachment 1 pages 17 - 18 and attachment 3)

APCM reviewed the current strategic asset allocation and projected returns over an approximate seven-year time horizon (5.3%). APCM does not recommend a change in the allocation at this time. (See attachment one pages 20-23)

During the July 22, 2015 regularly scheduled meeting of the City Permanent Fund Review Board (PFRB), Alaska Permanent Capital Management (APCM) recommended replacing the benchmarks for the International Equities and Emerging Markets indices.

Current policy authorizes investments in international equities (IE) that replicates the FTSE Developed ex North America Index (FTSE DNAI) and the performance measurement for the IE allocation is measured against the target weighting using the FTSE DNAI for the benchmark.

Current policy also authorizes investments in an emerging markets equity index (EM) that replicates the FTSE Emerging Markets Index (FTSE EMERGING) and the performance measurement for the EM allocation is measured against the target weighting using the FTSE EMERGING for the benchmark.

APCM recommends amending the investment policy to (a) replicate the IE and performance against the Morgan Stanley Capital International Europe, Australasia and Far East index (MSCI EAFE) and (b) replicate the EM and performance against the Morgan Stanley Capital International Emerging Markets Index (MSCI Emerging).

The PFRB unanimously recommended presenting an Ordinance to the City Council authorizing the addition of MSCI EAFE and MSCI Emerging or substantially similar indices.

APCM proposed replacing Vanguard with Investable Market Index products from iShares. The PFRB supported the recommendation.

In accordance with Section 2-262 of the Fairbanks General Code (FGC), I authorize the substitute indices on an interim basis pending the approval of an Ordinance amending FGC sections 2-260 and 2-261.





### Investing Requires Long Term Perspectives


Short term volatility should not impact decisions for long term investment goals.

- Successful investment strategies are designed around TREAT and built on reasonable long term financial and capital market expectations vs. current market conditions.
  - Volatility over the past few years has been lower than historical averages and APCM's projections.

## Volatility Still Within Historical Norms










#### Stocks Near Fair Value

Valuations have come down recently, but remain near their long term average.



Int'l indices that include Europe & Japan have yet to regain their 2007 peak.



Yields have fluctuated in 2015, but ended Q3 near where they started the year.



The first Fed rate hike in 10 years could come in December, but markets expect 2016.







Chart shows month-end portfolio market value from January 1998 to September 2015.



  - An underweight to international bonds combined with an overweight to mid cap and developed international equity contributed to the modest underperformance.



## Background

Subject: Compliance

During this year's audit of the Permanent Fund the question was raised as to exactly how does the Finance Department know the Fund was in compliance with the various restrictions contained in the authorizing ordinances and resolutions. While the auditor's questions were answered it became apparent that a more formalized compliance system would make this question mute.

Nine specific compliance questions have been identified and it is recommended that a compliance appendix be included at each quarterly meeting illustrating that the Fund meets all of the respective criteria. The identified nine items are as follows:

- 1. Equity and Fixed-income limitations as wells range limitations within the two categories.
- 2. Corporate debt limitation of 30% of total portfolio market value.
- 3. Limitation on the purchase of any bond in excess of 600 basis points above a comparable duration US treasury.
- 4. Limitation on the purchase of any CMBS after January 1, 2009.
- 5. Ratings and downgrade limitations on corporate securities.
- 6. Five percent limitation on any one security (total portfolio).
- 7. Ten percent limitation on Baa rated securities (fixed income portfolio).
- 8. Duration constraint of between 80-120 percent of the Barclays Aggregate.
- 9. Twenty-Five percent industry limitation (total portfolio).

In the attached packet each of the nine limitations are addressed by either a specific report or calculation based upon an enclosed report to illustrate compliance. Should the Board approve of the format; the Compliance Report will become a regular appendix presented at each quarterly meeting.











### **APPROVAL OF PREVIOUS MINUTES**

The Minutes were considered and approved out of order as listed on the agenda, just prior to Adjournment.

- a) Meeting Minutes of November 25, 2014
- b) Meeting Minutes of December 10, 2014

Mr. Nobles, seconded by Ms. Carnahan, moved to APPROVE both sets of meeting minutes.

Chair Matherly called for objection and, hearing objection only from Ms. Stiver, so ORDERED.

Chair Matherly thanked Ms. Clooten and Committee Members for their hard work and dedication to the Committee. He commented on the efficiency of the Presentation Meeting and the importance of the Bed Tax Discretionary Fund for the Fairbanks community. He thanked the organizations for taking the time to apply and complimented them on their presentations. Chair Matherly explained the process of the Distribution Meeting, stating each Committee Member will read their individual allocations aloud after all allocations have been read into the record. He stated each Member will be given the opportunity to give their comments before Ms. Bell announces the final distribution amounts.

#### **NEW BUSINESS**

a) Announcement of Discretionary Funds for 2015 Distribution

Members read their individual allocations into the record for each of the twenty-seven organizations.

Chair Matherly asked Ms. Bell to confirm there were no errors in the allocations read into the record. Ms. Bell confirmed the accuracy of the individual allocations.

Ms. Stiver commented on the restructuring of multiple organizations who applied for Bed Tax Discretionary Funds. She spoke to the importance of those organizations' maintaining the ability to accurately answer questions regarding the financials throughout and after the restructuring. Ms. Stiver requested that Chair Matherly introduce an Ordinance which would place any monies allocated for a distribution year but not used in that year back into the Bed Tax Discretionary Fund to be retained until the following year's distribution. She stated the unused monies are transferred into the City's General Fund and are not again made available in the Bed Tax Discretionary Fund.

Chair Matherly asked Ms. Bell if there have been any cases where monies have been allocated but not used.

Ms. Bell confirmed that there have been cases where monies have not been used or the final 10% not awarded.

Ms. Fox commented on the excess of \$760,000.00 requested and only \$270,000.00 available in Bed Tax Discretionary Fund monies to award. She further stated she would like the City Council to consider raising the Bed Tax Discretionary Fund amount to \$300,000.00.

Chair Matherly stated that adjusting the Bed Tax Discretionary Fund amount may effect the Fairbanks Convention and Visitors Bureau and the City's General Fund; he stated that he would discuss possible adjustment options with Ms. Bell.

Ms. Stiver stated the Bed Tax Discretionary Fund should be inflation-proof.

Ms. Crawford inquired as to whether specific organizations are notified when the application period for Bed Tax Discretionary Fund is open.

Chair Matherly responded that letters are sent to all organizations who have applied previously and notices are placed in the newspaper.

Ms. Stiver stated that a government agency cannot send notifications to specific organizations and possibly leave out other eligible organizations. She stated that sending out letters would be problematic for the City, and that the advertising is completed as thoroughly as possible.

Ms. Crawford and Chair Matherly stated that Committee Members can encourage organizations to apply on their own.

Ms. Clooten stated the Clerk's Office places advertisements in the NewsMiner every Sunday during the month of October and posts information on the City's website, Facebook, and Twitter

pages. She further confirmed that the City cannot contact any organization directly as it would be giving preferential treatment.

Chair Matherly reiterated he would meet with Ms. Bell to discuss adjusting Bed Tax Discretionary Funds to \$300,000.00 and having undistributed monies be placed back into the Bed Tax Discretionary Fund. Chair Matherly asked Ms. Bell to inform the Committee Members and those in attendance how the Bed Tax Fund Distribution results will be displayed.

Ms. Bell explained the results will be distributed to the Committee Members on a spreadsheet and displayed on the projector screen presently, then posted on the City's website by the end of the day. Ms. Bell distributed the spreadsheet to Committee Members.

### **ADJOURNMENT**

Ms. Fox, seconded by Ms. Carnahan, moved to ADJOURN the meeting.

Hearing no objection, Chair Matherly declared the meeting adjourned at 12:19 P.M.



The purpose of the Building Code Review and Appeals Commission is:

- 1) To review the building, electrical, plumbing, fire prevention, residential, mechanical, fuel gas and abatement codes and related provisions of the Fairbanks Code of Ordinances and make recommendations regarding building construction and housing codes adopted by the City,
- 2) To investigate and review all operations of the building department of the City, to submit recommendations on policy to the City Council, and to make recommendations on administration to the mayor, and
- 3) To hear and determine in the first instance all appeals from final staff decisions relating to building construction within the City including the Uniform Code for the Abatement of Dangerous Buildings. Any decision of the board may be appealed to the superior court in accordance with the appellate rules of the state court system.



### BOARD/COMMISSION CHARACTERISTICS

The Building Code Review and Appeals Commission consists of nine members appointed by the Mayor, subject to confirmation by the City Council, and each member shall serve a five-year term; all terms expire on December 31st of the fifth year. The members of the Commission must reside or work, and have experience with the design or construction of structures within the City. The Building Official shall be an ex officio member of the Commission, who may provide information and recommendations but may not vote on any matter. Two alternate members are appointed by the Mayor, subject to City Council confirmation, to serve in the place of any absent member or otherwise assist the Commission as directed by the chairman.

#### **MEETINGS**

Meetings of the Building Code Review and Appeals Commission are called when the subject matter warrants. The chairman is authorized to call meetings, or a majority of the members may require that a meeting be called. All meetings shall be open to the public, except that closed meetings may be held as provided by law. A majority (five members) of the commission shall constitute a quorum and a majority vote of those present and voting shall be necessary to carry any question. Minutes shall be kept as a permanent record of all meetings and shall be filed in the Office of the City Clerk.





Fairbanks City Council Resolution 4684, passed August 10, 2015 directed the formation of a task force to evaluate the economic and operational feasibility of the City of Fairbanks being the Fairbanks North Star Borough (FNSB) natural gas utility Local Control Entity (LCE).

The task force held public work sessions on August 26<sup>th</sup> and again on September 24<sup>th</sup> 2015. The task force raised the following questions and conclusions:

- 1. City governance structure. The task force concluded the only viable way to operate a combined natural gas utility would be to establish an enterprise fund to keep operations and finances (specifically long term debt liabilities) separated from other City functions. The formation of an enterprise fund and assumption of debt would have to be presented to the voters for approval at a special or general election.
- 2. Rate expectations. The task force assessed current and historical rates for energy and unknowns about future oil prices and natural gas supplies and prices make the proposition of owning a gas utility a risky proposition. The task force was not convinced AIDEA estimates of natural gas conversion rates in the FNSB were realistic, and ultimately would result in either short run cash flow challenges or delays in area-wide infrastructure build out.
- 3. Benefit to the City. The task force could not answer that question from a City perspective when factoring in risk vs. reward and use of limited internal City resources to take on a new utility.
- 4. Value of FNG. The true value of Fairbanks Natural Gas as disclosed in Alaska Industrial Development and Export Authority's (AIDEA) recent purchase of PENTEX was not clear. The task force assessed the City would need to conduct an independent due diligence assessment of the Fairbanks Natural Gas Utility, now under AIDEA ownership.

Based on the above conclusions, the Task Force is recommending to the Fairbanks City Council to not pursue involvement as the Fairbanks combined gas utility Local Control Entity.
