FAIRBANKS CITY COUNCIL REGULAR MEETING MINUTES, MARCH 19, 2012 FAIRBANKS CITY COUNCIL CHAMBERS 800 CUSHMAN STREET, FAIRBANKS, ALASKA

The City Council convened at 7:00 p.m. on the above date, following a Work Session with the Public Safety Commission, to conduct a Regular Meeting of the Fairbanks City Council at the City Council Chambers, 800 Cushman Street, Fairbanks, Alaska, with Mayor Jerry Cleworth presiding and with the following Council Members in attendance:

INVOCATION

The Invocation was given by City Clerk Janey Hovenden.

FLAG SALUTATION

Mayor Cleworth led the Flag Salutation.

CITIZEN'S COMMENTS

<u>Greg Allison, 436 Spence Avenue, Fairbanks</u> – Mr. Allison, Tourism Senior Sales Manager for the Fairbanks Convention & Visitors Bureau (FCVB), provided an update on the Bureau's efforts to promote Fairbanks as a tourist destination for travelers worldwide. He spoke of his recent trip to Berlin where he represented the Fairbanks community. Mr. Allison summarized upcoming plans and activities for FCVB in 2012.

Mr. Gatewood mentioned seeing a Japanese flight leaving the airport. He asked Mr. Allison what destinations in Japan were available from Fairbanks.

Mr. Allison explained that the flights are not direct, due to a stop in Anchorage. He stated that they mainly fly to Northern Japan, but are hoping to add destinations in Southern Japan.

Mr. Matherly asked what Mr. Allison pitches to airlines to solicit their service to Fairbanks. He asked if 2012 was projected to be a good tourist season.

Mr. Allison stated that he familiarizes them with members of FCVB such as local hotels and takes them above the Arctic Circle to experience fly-and-drive adventures; those are some of the best ways to solicit interest in the Interior. He commented that he believes 2012 will be a good year for tourism in the Fairbanks community.

Mr. Eberhart asked if Mr. Allison had noticed a decline in European tourists or a change in trend due to the problems in the European Union.

Mr. Allison replied that the German economy is strong right now and the trend is swinging towards an increase in younger crowds.

Mr. Hilling asked how tour operator listings are prioritized on the FCVB website with a limited amount of space. He requested a copy of the flier to which Mr. Allison had referred in his testimony.

Mr. Allison explained that the listing is free, but that there are criteria that have to be met in order to participate in the list.

<u>David Leslie</u>, 3020 <u>Davis Road</u>, <u>Fairbanks/Chris White</u>, 300 <u>Howland Road</u>, <u>Fairbanks</u> – Mr. Leslie, representing "Occupy Fairbanks," stated that his group has been maintaining a 24-hour vigil in the Veteran's Memorial Park since November. He stated that, in January, the group's porta potty was removed under the ordinance that prohibits such use in the City of Fairbanks. He requested that the City Council make an exception to the ordinance. Mr. White spoke to the basic decency a porta potty would provide to the "Occupy Fairbanks" movement members.

Mr. Hilling asked Mr. Leslie and Mr. White what their objectives were in participating in the movement.

Mr. White replied that he is participating to help create a better future for his grandchildren by changing government. Mr. Leslie explained that the movement's main objectives are to raise awareness about Occupy Wall Street, to unite the community, and to provide inspiration to people around the world who have taken notice of the "Occupy Fairbanks" movement. Mr. White stated that the movement has put together a conference at UAF that brings together concerned parties with varying political perspectives.

Mr. Eberhart stated that he thought the Veteran's Memorial Park was the Borough's responsibility.

Mr. Leslie replied that the City ordinance still applies and that the Borough had referred them to the City for the porta potty issue.

Mr. Eberhart asked for clarification on what the City's discretion is regarding porta potties.

Mayor Cleworth replied that he would address the issue during his comments.

Mr. Matherly stated that he has no problems with peaceable assembly, but added that providing a facility for the protesters is not appropriate.

Mr. Leslie replied that the restroom would be open to the public. He suggested that the City Code may not address this specific issue because of the unique circumstances surrounding the movement. He suggested that protesters may have different rights than normal citizens.

Mr. Roberts stated that, to his understanding, a porta potty could be used on a temporary basis in the City of Fairbanks. He asked how long the protesters planned to occupy.

Mr. Leslie replied that "Occupy Fairbanks" protesters intend to remain in the park indefinitely.

Amy Geiger, 4400 Stanford Drive, Fairbanks, FCVB Advertising & Public Relations – Ms. Geiger addressed plans for hosting the 2012 Outdoor Writer's Association of America Conference. She stated that, to date, there are more than 120 outdoor writers registered for the conference with the total number expected to reach 200. Ms. Geiger spoke to the unprecedented amount of press tours in the Interior at present due to various activities such as dog mushing and the Ice Alaska Art Championships.

<u>David Lerman</u>, 126 2nd <u>Avenue</u>, #15, <u>Fairbanks</u> – Mr. Lerman stated that he will run for candidacy in the 2012 Municipal Election. He invited the public to join the discussion on his website, *Renovation Fairbanks*. He read aloud the City of Fairbanks mission statement. He recommended that the City be more specific in their mission statement and that the Council's domain be expanded. He spoke to the need for more public participation in local government through the implementation of various task forces. He spoke briefly to the "world-class" renovation at his own residence, Smith Apartments.

Mr. Hilling asked Mr. Lerman to provide a specific example of how a task force would affect a decline in domestic violence or DUI's.

Mr. Lerman spoke to creating synergy with Fairbanks citizens that would bring about new ideas to reduce crime and DUI's in the City.

Mr. Gatewood stated that he has visited a number of apartment buildings in Alaska, none of which he would consider "world-class." He asked Mr. Lerman what makes Smith Apartments "world-class."

Mr. Lerman listed the many improvements of the property including a new roof, windows, doors, siding, cabinetry, plumbing fixtures, ventilation and more. He stated that it is "world-class" in the sense that it is a very decent and clean place to live as opposed to what it was prior to renovation. He stated that the owner of Smith Apartments is an unusually smart man.

<u>Tim Sovde, 402 Bonnifield Street, Fairbanks</u> – Mr. Sovde announced the upcoming Alaska Mining Association Convention at the Carlson Center and the Alaska Builders & Contractors Breakfast at Pike's Landing. He questioned why road projects must be considered by the FNSB Planning Commission, stating that it's just another "hoop" to jump through.

APPROVAL OF AGENDA AND CONSENT AGENDA

Mayor Cleworth informed the Council that the Firefighter's Association (FFA) had replied to the City's latest proposal in contract negotiations. He suggested adding an Executive Session to discuss the FFA Labor Contract.

Mr. Gatewood, seconded by Mr. Matherly, moved to APPROVE the Agenda and Consent Agenda.

Mayor Cleworth called for objection and, hearing none, so ORDERED.

Mr. Hilling, seconded by **Mr. Matherly**, moved to ADD and Executive Session to discuss FFA Labor Negotiations.

Mayor Cleworth called for objection and, hearing none, so ORDERED.

City Clerk Hovenden read the Consent Agenda into the record.

SPECIAL ORDERS

Vacation of Public Right-of-Way (VA 006-11 Tanana Clinic 1st Addn.) – Request by Stutzmann Engineering on Behalf of the Greater Fairbanks Community Hospital Foundation to Vacate that Portion of 11th Avenue East of Noble Street and to Replat Lots 1-8, Blk 119, Lot 1-A, Blk 120, Portions of Lots 1 and 2, Blk 120, Lots 2-C-1-A, 2-C-1-B, and 2-C-1-C, Blk 120, Fairbanks Townsite, into Four Lots Ranging in Size from 22,865 Square Feet to 1.725 Acres within the SE ¼ of Sec. 10, T1S R1W, FM (Located on 10th and 11th Avenues and Noble Street).

Mayor Cleworth explained that by taking no action, the Council would be agreeing with the vacation. If there was an objection to the Vacation, the City would enter a protest.

No formal action was taken.

MAYOR'S COMMENTS AND REPORT

Mayor Cleworth announced that Tony Shumate had won the dog sledding competition that the City Mayor is invited to participate in annually. He explained that each local mayor had sent a proxy to compete in the competition this year on their behalf; he congratulated Mr. Shumate for defeating all the competitors, including the businessmen. Mayor Cleworth spoke to the Open North American Champion Sled Dog Race Banquet where they thanked City Police and Public Works Departments for their help in removing a vehicle blocking the mushing trail. Mayor Cleworth asked Mr. Ewers to discuss and clarify the City Code governing the use of porta potties within City limits.

Mr. Ewers referenced FGC Section 82-38, which provides for the use of chemical toilets within City limits under the following circumstances:

- 1) In conjunction with an active construction project for which a building permit has been issued.
- 2) In conjunction with special events.
- 3) For outdoor recreational and sporting events.
- 4) For temporary buildings which are occupied pending construction of a new building which is under construction.
- 5) In cases of natural disasters and emergencies.
- 6) As approved by the mayor.

Mr. Ewers further quoted FGC Section 82-38 stating that porta potties shall be:

- 1) Registered with the building department and validated with a permit which shall be affixed to the facilities. No permits shall be required in the case of natural disasters or for construction project sites which have building permits.
- 2) When the operator of a food establishment provides seating for its patrons no permit shall be issued except upon proof that the applicant has received approval form the Alaska Department of Environmental Conservation that the use of chemical toilets and porta potties meets the requirements of 18AAC 31.520 (toilet facilities).
- 3) Maintained as required by the Alaska Department of Environmental Conservation and the conditions, if any, set forth in the permits, including any durational of or use limitations.
- 4) May be required to be screened from public view as set forth and described in the permit.
- 5) In compliance with all accessibility requirements as set forth in the Code of Ordinances.

Mayor Cleworth stated that he is unclear as to the arrangements "Occupy Fairbanks" has made with the Borough. He stated that, in the past, individuals or organizations have rented the park from the Borough for events and activities and that the City has only recently become involved because of the porta potty issue. **Mayor Cleworth** indicated that this specific request for use of a porta potty does not fall under any of the City-approved uses. He stated that he was

uncomfortable approving the use of the porta potty without Council input. He asked Council Members to speak to the issue during Council Members' Comments.

Mr. Eberhart asked if the City Code defines a "special event."

Mr. Ewers replied that it does not. He explained that porta potty restrictions were reinstated in the City Code in 2008, but had been a part of the Code prior to that time.

Mr. Eberhart asked if, as the property owner, the Borough could demand the porta potty be removed. He inquired as to what led to the removal of the previous porta potty in the park.

Mayor Cleworth explained that a complaint about the porta potty was taken by the City of Fairbanks, triggering a non-compliance letter from the City Building Department to the Borough. He stated that the Borough then requested the unit be removed from the park.

Mr. Hilling, seconded by **Mr. Eberhart**, moved to GRANT the Mayor the discretion to allow the use of a porta potty by the "Occupy Fairbanks" protesters.

Mr. Eberhart stressed the importance of freedom of speech; he empathized with the protestors' request for an on-site restroom.

Mr. Eberhart, seconded by **Mr. Hilling**, moved to AMEND the motion to GRANT the Mayor the discretion to allow the use of a porta potty by adding the conditional language, "pursuant to Subsection 82-38(e)(2) 'in conjunction with special events."

Mr. Gatewood asked for clarification on Mr. Eberhart's proposed amendment.

Mr. Eberhart stated that the amendment would add a second reason by which to base the resolution instead of solely relying on the Mayor's discretion.

Mr. Matherly stated that he would not consider the protest a special event. He explained that his definition of a special event would be an activity that his family could attend and enjoy together.

In response to Mr. Roberts request, Mr. Ewers read aloud Subsection 82-38(e)(2).

A ROLL CALL VOTE WAS TAKEN ON THE MOTION TO AMEND THE MOTION TO GRANT THE MAYOR THE DISCRETION TO ALLOW THE USE OF A PORTA POTTY BY ADDING THE CONDITIONAL LANGUAGE, "PURSUANT TO SUBSECTION 82-38(e)(2) IN CONJUNCTION WITH SPECIAL EVENTS" AS FOLLOWS:

YEAS: Roberts, Hilling, Eberhart, Cleworth

NAYS: Matherly, Gatewood, Stiver

Mayor Cleworth declared the MOTION CARRIED.

Mr. Hilling, seconded by **Mr. Roberts**, moved to AMEND the motion to GRANT the Mayor the discretion to allow the use of a porta potty by adding the language, "until April 30, 2012."

Mr. Roberts asked why Mr. Hilling would like to place a time stipulation on the use of the porta potty.

Mr. Hilling replied that cold weather is a factor for the occupiers, and, by April 30, the weather will be more tolerable for the protesters. He added that the tent and the porta potty may be considered unsightly and a nuisance to those wishing to enjoy the park.

Mayor Cleworth indicated that some organizations rent the park for use as an event staging area in the summer.

Mr. Roberts stated that some people may think it more convenient to have a porta potty in the park rather than a nuisance.

A ROLL CALL VOTE WAS TAKEN ON THE MOTION TO AMEND THE MOTION TO GRANT THE MAYOR THE DISCRETION TO ALLOW THE USE OF A PORTA POTTY, AS AMENDED, BY ADDING THE LANGUAGE, "UNTIL APRIL 30, 2012" AS FOLLOWS:

YEAS: Hilling

NAYS: Stiver, Matherly, Gatewood, Eberhart, Roberts

Mayor Cleworth declared the MOTION FAILED.

Ms. Stiver stated that while our country was founded on the freedom of speech, she believes that protesters should manage themselves. She added that the occupiers should not receive special treatment.

Mr. Hilling stated that it is sometimes appropriate for the City Council to make exceptions to the City Code and it is everyone's right to appeal to the Mayor and Council. He spoke in support of allowing the porta potty to be used in the park.

Mr. Roberts stated that the decision is ultimately up to the Mayor, but that he supports the motion.

Mr. Eberhart reminded the Council that the issue at hand is only whether or not to allow the use of the porta potty.

Mayor Cleworth stressed the importance of being fair to all Fairbanks citizens.

Mr. Matherly spoke against allowing the use of the porta potty in the park.

Mr. Gatewood stated that his main problem with allowing use of the porta potty is that there have been no time limitations set for or by the occupiers.

A ROLL CALL VOTE WAS TAKEN ON THE MOTION TO GRANT THE MAYOR THE DISCRETION TO ALLOW THE USE OF A PORTA POTTY BY THE "OCCUPY FAIRBANKS" PROTESTERS, AS AMENDED, AS FOLLOWS:

YEAS: Hilling, Roberts, Eberhart

NAYS: Matherly, Stiver, Gatewood, Cleworth **Mayor Cleworth** declared the MOTION FAILED.

Mayor Cleworth stated that he will permit, at his discretion, the use of a porta potty by the protesters through April 30, 2012.

Mayor Cleworth commended Kate Wozniak and City of Fairbanks Firefighter Craig Bryan for helping save the life of a Fairbanks citizen while off duty at Planet Fitness on March 12, 2012.

Assistant Fire Chief, Ernie Misewicz, applauded both individuals and commented on what an asset emergency training is to the Fairbanks community.

UNFINISHED BUSINESS

a) Ordinance No. 5878 – An Ordinance to Amend Chapter 2, Article III, Division 8, Landscape Review and Beautification Commission and FGC Sections 10-436, 438, 439, and 441 of the Fairbanks Landscape Ordinance. Introduced by Mayor Cleworth. SECOND READING AND PUBLIC HEARING.

Mr. Matherly, seconded by Mr. Roberts, moved to ADOPT Ordinance No. 5878.

Mayor Cleworth called for Public Testimony and, hearing none, declared Public Testimony closed.

Mr. Roberts asked for an explanation as to why the ordinance had come about.

Mayor Cleworth stated that it had been a combined effort with the City Building Department to clean up City Code and repurpose the commission so that it may be used more effectively. He asked Clem Clooten, Building Official, to come forward.

Mr. Clooten stated that the Commission has been dormant for a number of years and that its current purpose as stated in City Code is no longer relevant. He explained that the Commission should be repurposed to revise and maintain the City's Landscape Manual and to sit as an appeals board if and when issues arise.

Mr. Eberhart asked if the Landscape Manual is currently complete or if revisions are needed.

Mr. Clooten replied that if revisions are needed, Ordinance No. 5878 would allow for the Commission to review and update the Landscape Manual, as necessary.

Mayor Cleworth added that the Commission would allow contractors the opportunity to appeal if their plans were rejected based on the Landscape Manual. He stated that landscape regulations should be revised because some are too stringent.

DISCUSSION ITEMS

a) Committee Reports

<u>Public Safety Commission</u> – Mr. Eberhart stated that Lt. Jewkes will continue the clean-up process of City Code in reference to violations and present his changes to the Commission for recommendation. He provided a brief summary of the last PSC meeting and spoke to the idea of cross-training police, fire and emergency personnel.

b) Fairbanks North Star Borough Dispatch Contracts

Mayor Cleworth explained that, although the contract had been reviewed and approved at a previous City Council Meeting, changes have been made that require another Council approval.

Mr. Gatewood, seconded by **Mr. Roberts**, moved to APPROVE the Intergovernmental Agreement for 9-1-1 Call Taking Services between the City of Fairbanks and the Fairbanks North Star Borough.

Mr. Eberhart addressed Sections 12.0 and 13.0 of the Agreement. He suggested that the language, "terminated by the parties" is inconsistent with the withdrawal language in Section 13.0.

Mr. Eberhart, seconded by **Mr. Gatewood**, moved to AMEND the Agreement by striking the words "terminated by the parties" in Section 12.0 and replacing them with "a party gives notice of withdrawal" and by adding the words "at any time" to Section 13.0 after "In the event that any party..."

Mr. Roberts asked if the amendment to the Agreement would affect the time-sensitivity of the contract.

Mayor Cleworth indicated that the minor changes should not significantly delay the contract.

Mr. Hilling asked for clarification as to whether or not both parties would be locked into the contract for five years.

Mr. Eberhart explained that the reason for his amendment was to make it more apparent in Section 13.0 that either party could withdraw at *any* time.

Mr. Hilling commented that Section 12.0 does not clarify that either party may withdraw during the initial five-year period.

A ROLL CALL VOTE WAS TAKEN ON THE MOTION TO AMEND THE AGREEMENT FOR 9-1-1 CALL TAKING SERVICES BY STRIKING THE WORDS "TERMINATED BY THE PARTIES" IN SECTION 12.0 AND REPLACING THEM WITH "A PARTY GIVES NOTICE OF WITHDRAWAL" AND BY ADDING THE WORDS "AT ANY TIME" TO SECTION 13.0 AFTER "IN THE EVENT THAT ANY PARTY..." AS FOLLOWS:

Agreement AMENDED.

COUNCIL MEMBERS' COMMENTS

Mr. Gatewood congratulated all the local high schools who participated in the State basketball tournament for their intensity and for their proud representation of the Fairbanks area.

Mr. Roberts stated that he enjoyed watching the Open North American Championship Sled Dog Race. He commended the City's Public Works Department for transforming 2nd Avenue into a dog sledding strip and thanked the Fairbanks Police Department for rerouting the traffic around the event.

Ms. Stiver apologized for missing the March 5, 2012, City Council Meeting due to illness. She discontinued her telephonic attendance at 8:40 P.M., stating that she would call back to attend the Executive Session.

Mr. Matherly chose not to make a comment.

Mr. Hilling thanked whoever was responsible for getting the City's mission statement posted on the City's website. He asked Mr. Lerman to come up with a plausible explanation as to *how* the creation of a DUI Task Force would directly reduce the number of DUI's issued in the City. Mr. Hilling asked Mr. Ewers if FGC Section 82-38(e)(6) gave the Mayor the sole authority to grant the use of a porta potty for any reason. He asked if the "Occupy Fairbanks" tent was legal. He expressed satisfaction that the Mayor had allowed the use of the porta potty only on a temporary basis. Mr. Hilling asked if it was still normal City procedure for the Police and Fire Departments to give a regular report to the City Council. He spoke to the value of regular reports from the Chief of Police.

Mr. Ewers, in response to Mr. Hilling's first question, stated that the Code delegates that authority to the Mayor, provided that all other State and City requirements for placement of a porta potty are met. Mr. Ewers replied that the legality of the protesters' camp was a Borough issue.

Mayor Cleworth led the Flag Salutation.

CITIZEN'S COMMENTS

<u>Tim Sovde, 302 Bonnifield Street, Fairbanks</u> – Mr. Sovde thanked the Public Works Department for keeping the street-flooding under control in his neighborhood during the winter break-up season.

<u>David Pruhs, 324 Brandt Street, Fairbanks</u> – Mr. Pruhs spoke to Frank Turney's role as grounds keeper of the Clay Street Cemetery. He gave a brief summary of Mr. Turney's history in maintaining the Cemetery and commended his work. He urged the City Council to keep Frank Turney's position at the Cemetery.

Mayor Cleworth asked Mr. Pruhs to address the funding the Commission has received to place new headstones on many of the old gravesites.

Mr. Pruhs briefed the Council on the new headstones purchased for the Cemetery with City Bed Tax Discretionary funds. He stated that the labor to install the headstones would be performed

by the Clay Street Cemetery Commission. He announced that two local mining companies, Fort Knox and Pogo Mine, have also pledged \$5,000 each towards the purchase of new headstones. Mr. Pruhs spoke highly of the members of the Clay Street Cemetery Commission and commented that his time spent serving on the Commission has been very fulfilling.

<u>Frank Turney</u>, 201 7th <u>Avenue</u>, <u>Fairbanks</u> – Mr. Turney thanked Mr. Pruhs for his kind words. He quoted the recent article in the Fairbanks Daily News Miner (FDNM) regarding his future employment as the grounds keeper at the Clay Street Cemetery. He clarified that the issue that has put his employment into question has nothing to do with the IRS as the article stated; rather, it was due to a PERS issue. He requested an apology from the City's Personnel Director and the FDNM for the misinformation.

<u>Victor Buberge, PO Box 58192, Fairbanks</u> – Mr. Buberge spoke on behalf of Frank Turney in regards to Mr. Turney's continued employment as the Clay Street Cemetery grounds keeper. He commented that the arrangement is likely the most cost-effective way for the City to keep the Cemetery maintained. Mr. Buberge spoke to the need for public restroom facilities in the downtown area. He thanked the Public Works Department for their hard work, but pointed out that there are some new potholes that need repaired due to the spring break-up. He specifically addressed a pothole on Illinois Street as a hazard to vehicles.

<u>Gene Salzman, 2807 Riverview Drive, Fairbanks</u> – Mr. Salzman vocalized his dissatisfaction with Public Works in regards to recent snow removal efforts in his neighborhood. He explained that the snow was plowed, but not removed.

<u>David Lerman, 126 2nd Avenue, Fairbanks</u> – Mr. Lerman stated his intent to run for candidacy in the 2012 Municipal Election. He spoke to his website, *Renovation Fairbanks*, as the nucleus of his campaign and invited the public to join the online discussion. He spoke to the "world-class" renovation at his own residence, Smith Apartments, and how renovation can reduce crime. He suggested that the City form a Renovation Task Force to develop an ordinance that would waive building permit fees for those dilapidated properties in need of renovation.

Marylee Bates, 1290 Saint Anton Drive, Fairbanks – Ms. Bates spoke in support of the Community Development Block Grant (CDBG) on behalf of Clearwater Ministries. She shared that there is a great need for an emergency shelter for runaways and homeless youth in the Fairbanks area. She provided statistics for the number of homeless youth in the Fairbanks North Star Borough School District and for the number of runaway youths reported in 2011 by the Fairbanks Police Department. She thanked the City Council for passing Resolution No. 4493 in November, 2011, which authorized the City of Fairbanks to participate in the CDBG Program. She spoke in support of Resolution No. 4518, which would authorize the City to accept the grant funding on behalf of Clearwater Ministries. She read excerpts from a letter written by Dolly Caswell, an Alaskan who speaks to the issues of human trafficking, the sexual exploitation of children, youth homelessness, and family violence.

Mr. Hilling asked to what time frame the statistics on homeless youth pertained and what ages the statistics included.

Ms. Bates replied that the statistics she listed were for the 2011-2012 school year and included students from Kindergarten through twelfth grade.

MAYOR'S COMMENTS AND REPORT

Mayor Cleworth expressed sadness for the recent passing of Judge Connelly and spoke to the many contributions that Judge Connelly made to the Fairbanks community over the years. Mayor Cleworth spoke to the article in the News Miner regarding the possible consolidation of City Emergency Services. He clarified that, while the idea was briefly considered, it is not the direction the City will take at this time. He commented that the Public Safety Commission will be looking into the concept more in-depth to see how other municipalities across the nation have been successful with the consolidation. He indicated that there would be many hurdles to overcome before implementation of the concept, and that it is only being explored and researched at this time. Mayor Cleworth announced the military parade in honor of returning soldiers that will take place on May 12, 2012 from Fort Wainwright, through downtown Fairbanks, and ending at Pioneer Park. He applauded the Police and Public Works Departments for their work in preparing for the parade. Mayor Cleworth shared that there is an upcoming Borough ordinance that, if adopted, could change the way property taxes are collected. He stated that there are two main parts to the ordinance: an extension of property foreclosure one year

longer than what is currently in place; and a property tax deferral for owners who qualify as low-income (as defined by the ordinance). He stated that the low-income deferral could be problematic. Mayor Cleworth stated that he will be meeting with General McLeod at Eielson Air Force Base (EAFB) along with the North Pole and Borough Mayors to discuss the relocation of the F-16's from EAFB to joint base Ft. Richardson/Elmendorf. He vocalized concern that standard procedures have not been followed in the process. Mayor Cleworth stated that this is the time of year for potholes; he asked that anyone who notices a hazardous pothole contact Public Works immediately. He commended Public Works for their quick response in repairing the roads. He spoke to the issue of Frank Turney's employment as the caretaker of the Clay Street Cemetery. He stated that PERS prefers businesses to hire employees vs. independent contractors because they benefit more from employees. He added that the City is doing everything in its power to fix the problem. Mayor Cleworth addressed Mr. Salzman's complaint about snow removal in the Riverview Drive area. He commented that some of the criticism may be justified.







I am writing to inform the council that the State of Alaska is requiring a modification of the terms of the Memorandum of Understanding between Clearwater Ministries, Inc., and the City of Fairbanks. The change is explained below. For your convenience, I have attached the following:

- 1. Resolution No. 4493, as Amended
- 2. MOU between the City and Clearwater Ministries
- 3. Letter of Guarantee from the Rescue Mission
- 4. E-mail from Judy Haymaker to Margarita Bell
- 5. Letter to Mayor/Council from Clearwater Ministries

The Council previously approved acceptance of a CDBG grant to be passed through to Clearwater Ministries, Inc., for renovation of its building to serve as an emergency shelter for homeless youth (Resolution No. 4493, as Amended)(attached). The City and Clearwater Ministries entered into a Memorandum of Understanding (MOU)(attached), and the Fairbanks Rescue Mission issued a letter of guarantee (attached).

The parties were under the assumption that there was a minimum period (5 years) during which the Clearwater building must be used as an emergency shelter for homeless youth. If this five year period was not met, the grant money would have to be repaid to the State of Alaska. This understanding is reflected in the "whereases" of Resolution No. 4493, as Amended, and the MOU, as well as the Rescue Mission's letter of guarantee.

The State of Alaska is now requiring a modification of the terms of the MOU between the City and Clearwater to clarify that Clearwater's building must be used as an emergency shelter for the "useful life" of the facility (see e-mail from Judy Haymaker, State grants administrator, to Margarita Bell, City grant administrator)(attached). Ms. Haymaker's e-mail does not specify exactly how long the "useful life" of the facility is — only that it

would be more than five years. Ms. Haymaker has told Ms. Bell that "useful life" is generally considered to be 20 years.

This is a significant change to a basic assumption made by the parties. I have spoken with the Mayor, and we agree that in light of this significant change, the Council (1) needed to be informed and (2) needed to reaffirm its approval of the grant acceptance.

The attached letter from Clearwater to the Mayor dated April 30, 2012, recognizes and accepts the change from a 5-year commitment to a commitment for the "useful life of the building." The Fairbanks Rescue Mission will also need to revise its letter of guarantee to reflect and accept this change. Our initial information is that the Rescue Mission would only want to extend beyond five years if required to do so by the Council, as it believes its present guarantee is sufficient to meet the minimum requirements.

RESOLUTION NO. 4493, AS AMENDED

A RESOLUTION AUTHORIZING THE CITY OF FAIRBANKS TO PARTICIPATE IN THE FFY2011 COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM

WHEREAS, a required public hearing was held by the City of Fairbanks on October 25, 2011 for the proposed use of CDBG funds, attached is a record of that meeting; and

WHEREAS, community members identified an emergency homeless shelter for youth as a priority; and

WHEREAS, the City of Fairbanks is eligible to apply for a grant in the amount of <u>up to</u> \$750,000 from the Alaska Department of Commerce, Community, and Economic Development, under the CDBG program on behalf of Clearwater Ministries, a non-profit organization, for the renovation of their facility to provide emergency shelter for homeless youth; and

WHEREAS, the City of Fairbanks and Clearwater Ministries agrees to cooperate in the submission of an application for CDBG funds and agree to cooperate in the implementation of the submitted CDBG project as approved by the Alaska Department of Commerce, Community, and Economic Development; and

WHEREAS, the City of Fairbanks and Clearwater Ministries will enter into a written agreement to participate in the CDBG program; and

WHEREAS, Clearwater Ministries understands that the City of Fairbanks will act as the applicant and will have the ultimate responsibility to assume all obligations under the terms of the grant including assuring compliance with all applicable laws and program regulations and performance of all work in accordance with the contract; and

WHEREAS, Clearwater Ministries understands that the City of Fairbanks and Alaska Department of Commerce, Community, and Economic Development will have access to all grant records and authority to monitor all activities; and

WHEREAS, that the building must serve as a homeless youth shelter for at least five years or all CDBG funds must be returned; in the event Clearwater Ministries was unable to make the payment(s), the City would face potential liability; and

WHEREAS, Clearwater Ministries understands that the grant requires a match of up to \$250,000 (25% minimum) and is responsible for providing the match.

NOW, THEREFORE, BE IT RESOLVED THAT the Mayor is hereby authorized to execute any and all documents required for granting and managing funds on behalf of this organization provided that Clearwater Ministries agrees to the following conditions which are designed to limit the City's liability for grant repayment in the event of any default of grant requirements.

- 1. The design and construction of the project building shall be managed by City Engineering staff to ensure compliance with the grant conditions and all provisions of law and building codes. All time expended by City staff for construction and grant management will be reimbursed, including benefits.
- 2. The Owner of the project real property shall execute a conditional promissory note, secured by a senior deed of trust naming the City as beneficiary for all sums, together with penalty, interest and costs, which may become due upon any default of the terms of the grant. Upon successful operation of the project in accord with the terms of the grant, the City will issue a deed of full reconveyance to the project property owner.
- 3. Clearwater Ministries will provide the City with a letter of guarantee from the Fairbanks Rescue Mission Inc. that the project real property will be used for purposes in accord with the terms of the grant if Clearwater Ministries defaults on grant performance standards. This letter of guarantee shall be in a form approved by the City Attorney.
- 4. <u>Clearwater Ministries agrees that it will not sell or lease the project premises or assign its responsibilities under the grant to others without City approval.</u>
- 5. Liability and casualty insurance in amounts and upon terms approved by the City Attorney must be maintained at all times with the City named as an additional insured. A copy of Clearwater's financial statements prepared by an independent accountant will be provided to the City annually.

The Mayor is also authorized to execute subsequent amendments to said grant agreement to provide for adjustments to the project within the scope of services or tasks, based upon the needs of the project.

MEMORANDUM OF UNDERSTANDING BETWEEN CITY OF FAIRBANKS AND CLEARWATER MINISTRIES, INC

WHEREAS, the City of Fairbanks is eligible to accept a grant in the amount of \$720,000 from the Alaska Department of Commerce, Community, and Economic Development, under the CDBG program on behalf of Clearwater Ministries, a non-profit organization, for the renovation of its facility so as to provide emergency shelter for homeless youth; and

WHEREAS, Clearwater Ministries agrees to cooperate in the implementation of the submitted CDBG project as approved by the Alaska Department of Commerce, Community, and Economic Development; and

WHEREAS, Clearwater Ministries understands that the City of Fairbanks will have the ultimate responsibility to assume all obligations under the terms of the grant including assuring compliance with all applicable laws and program regulations and performance of all work in accordance with the grant agreement; and

WHEREAS, Clearwater Ministries understands that the building must serve as a homeless youth shelter for at least five years or CDBG funds must be returned; and

WHEREAS, Clearwater Ministries understands that the grant requires a match of 25% and that it is responsible for providing the match:

NOW, THEREFORE, it is mutually agreed that:

- 1. Clearwater Ministries will execute a conditional promissory note, secured by a senior deed of trust naming the City as beneficiary for all sums, together with penalty, interest and costs, which may become due upon any default of the terms of the grant. Upon successful operation of the project in accord with the terms of the grant, the City will issue a deed of full re-conveyance.
- 2. Clearwater Ministries will provide a letter of guarantee from the Fairbanks Rescue Mission, Inc., in a form approved by the City Attorney, that the project real property will be used for purposes in accord with the terms of the grant should Clearwater Ministries default on any grant performance standard.
- 3. Clearwater Ministries agrees that it will not sell or lease the project premises or assign its responsibilities under the grant to others without City approval.
- 4. Clearwater Ministries will maintain at all times general liability and casualty insurance in the amount of \$1,000,000 and motor vehicle insurance coverage in the amount of \$1,000,000, with the City named as an additional insured.

- Clearwater Ministries will provide financial statements prepared by an independent accountant to the City annually beginning Fiscal Year 2013.
- 6. Clearwater Ministries agrees that the design and construction of the project building will be managed by the City Engineering staff to ensure compliance with the grant conditions and all provisions of law and all applicable building codes. Clearwater Ministries agrees that the cost (including benefits) of all time expended by City staff for construction and grant management will be reimbursed through grant funds.
- 7. Clearwater Ministries is responsible for the operation and maintenance of any facility improvements, equipment, or other items acquired under the grant.

Recent discussion about the City's CDBG award for the Emergency Youth Shelter Renovation (construction) project has developed regarding the length of years for the use of a facility. The MOU that was signed and completed by the City of Fairbanks and Clearwater Ministries, Inc for the Emergency Youth Shelter Renovation states "the building must serve as a homeless shelter for at least five years or CDBG funds must be returned;"

Per regulation 570.489(j) the minimum requirements for compliance is for a period of five years after closeout of the CDBG grant with the state. However, per our CDBG grant agreement we stipulate in Attachment C – Standard Provisions under Article 31. Public Purposes that the "Grantee agrees that the project to which this Grant Agreement relates shall be dedicated to public purposes for its useful life." By signing the grant agreement the City is agreeing that the facility will be used for a public purpose for the useful life of the facility, which would be more than the five years.

By reviewing both of these stipulations (the CDBG regulation found in 570.489(j), and Article 31 in the grant agreement), the City would need to assure that the facility was used for a public purpose for a period beyond the 5 years you have stipulated in the current MOU.
