APPROVAL OF MEETING MINUTES

a) Regular Meeting Minutes of October 6, 2021

Ms. Erickson noted a correction to be made under New Business, item b that should reference Ms. Richardson, not Ms. Erickson.

Mr. Erickson, seconded by Mr. Dalton, moved to APPROVE the meeting minutes, as corrected.

Chair Kilbourn took a voice vote on the motion to APPROVE the meeting minutes, and all members voted in favor.

a) 2022 Room Rental Tax Grant Application Status

c) Order to Quiring Monuments

Chair Kilbourn stated that she believed the markers to be in process, noting that 15 were purchased with grant funds, and one was purchased from donations received for the Baton child.

NEW BUSINESS

a) Fairbanks Genealogical Society Publication, "1903-1930 Births, Marriages and Deaths."

Chair Kilbourn shared that she had received an updated version of the publication, adding that it may be helpful in locating some of the markers they have had issues finding information on. She noted that while the publication lists the page number of the newspaper it was printed in, it does not list the name of the newspaper. She stated it will still be a bit of a search but hopefully helpful.

Ms. Erickson stated that she had the previous version and thought that comparing the two may be helpful in going forward.

b) Recognition of Victoria Dowling

Chair Kilbourn expressed her gratitude for the time Ms. Dowling has spent transcribing.

OPEN AGENDA

a) Public Works Director Update

Mr. Jacobson stated that signs had been made for the cemetery gates and would be installed by spring. He noted that he believed the new gate had been installed, although he had checked. **Mr. Jacobson** shared that the City Council has preliminarily approved \$55,000 for markers. He reported that he explained to the Council that it will take decades to have the markers replaced using only the small amount of funds received from the discretionary grant each year.
