I certify that I am aware that I must maintain a central radio dispatch office or will operate dispatch by cellular phone, keeping a daily log of all cellular calls and providing cellular phone numbers to the company and to the City Clerk's Office. I certify that the approved color scheme shall be applied to the exterior of each vehicle to be operated under this permit, unless the City has granted my company a color scheme waiver. I certify that I will maintain a written record of all dispatches of vehicles operated under this permit; a regularly-maintained listing of all drivers of vehicles operated under this vehicle for hire company permit, reflecting termination dates or withdrawals from driving positions; a record of the daily hours of use for each vehicle operated under this vehicle for hire company permit; and such other data as may be required by the Police Chief of City Clerk. I understand that I must submit the above-listed records to the City upon request and that I must preserve those records for a minimum of two years. I certify that I have read and understand Fairbanks General Code (FGC) Secs. 86.31 through 86-96. I certify that I have read the application and that I understand the requirements for permitting a vehicle for hire company.
