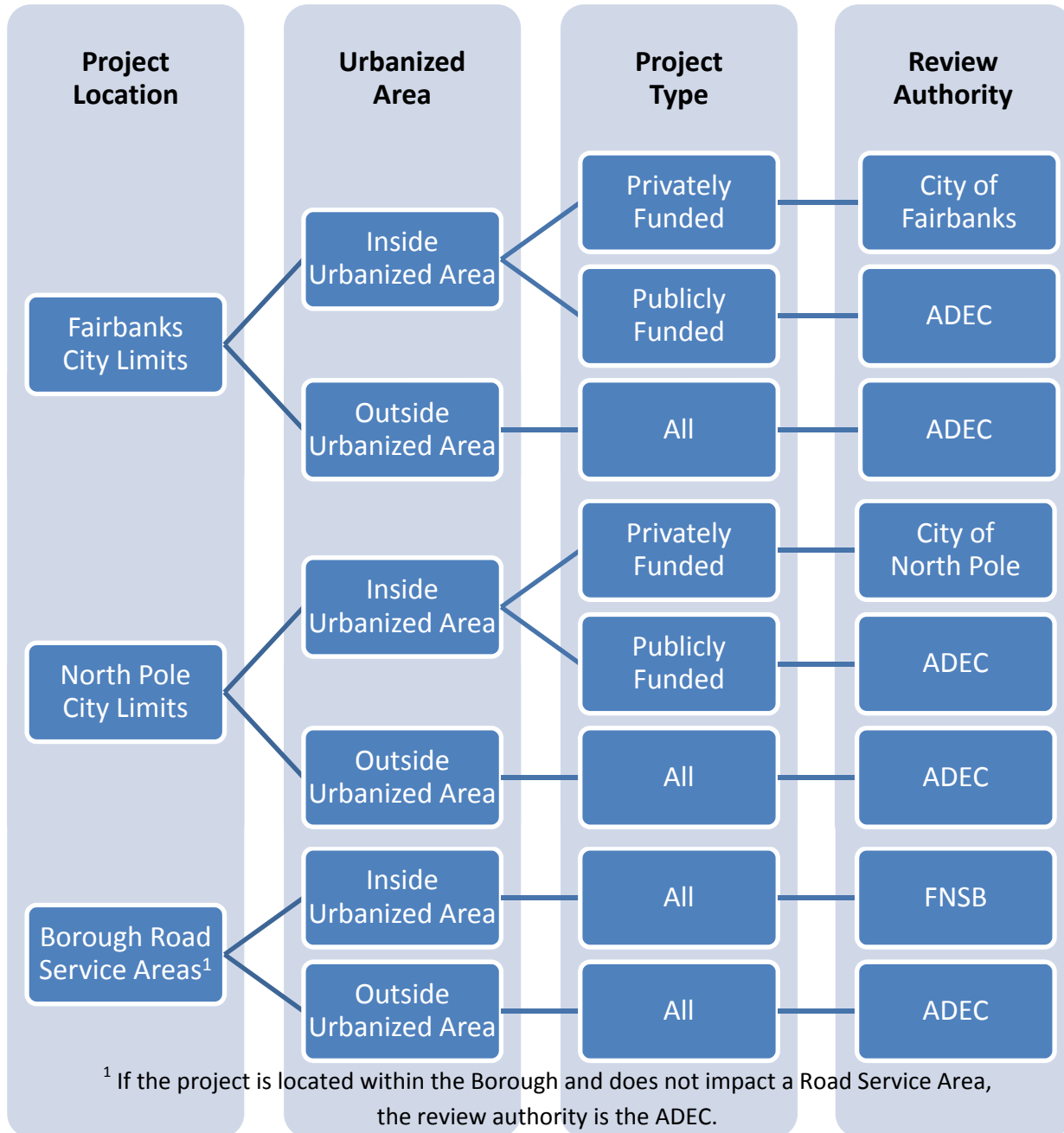


Fairbanks Urbanized Area Storm Water Management Agency Review & Project Submittal Requirements – January 2014

The City of Fairbanks, City of North Pole, Fairbanks North Star Borough (FNSB), and Alaska Department of Environmental Conservation (ADEC) have separate areas of jurisdiction and project review authority for storm water management in the Fairbanks Urbanized Area. This two-page handout is intended to help developers identify the appropriate regulatory agency and submittal requirements for their projects. The following chart outlines the separate areas of jurisdiction and project review authority for each agency. The second page includes a project submittal matrix and agency contact information.



The City of Fairbanks, City of North Pole, and FNSB have worked collaboratively to develop similar storm water management project submittal requirements for new development and redevelopment projects within the urbanized area. Below is a list of the key storm water management project submittals applicable to the urbanized area, as well as an agency submittal matrix.

- ✓ **Permanent Storm Water Control Plan (PSWCP)**
- ✓ **Erosion & Sediment Control Plan (ESCP)**
- ✓ **Storm Water Pollution Prevention Plan (SWPPP)**
- ✓ **ADEC Notice of Intent (NOI)**
