The deadline for submission has been extended to Wednesday, February 21, 2024 at 2:00 PM to account for the delay in this amendment to give adequate time for each bidder to submit.

### 6. Will the agency consider self-service online auctions in lieu of in person auctions?

No, at this time the city will continue to do onsite auctions with the for the vendor to include online bids managed by auctioneer.
