WHEREAS, the City has been notified by Alaska Department of Commerce, Community, and Economic Development that additional grant funds in the amount of \$127,000 are available for this project, since the bids for the project exceeded the amount of the original grant award,

SUBJECT:

Community Development Block Grant (CDBG) for Youth Shelter

The City of Fairbanks has been notified by the Alaska Department of Commerce, Community, and Economic Development (DCCED) that additional funds in the amount of \$127,000 are available for the emergency youth shelter project, since the bid for the project has exceeded the amount awarded.

The Council approved acceptance of the grant in the amount of \$720,000 with Resolution 4518 with the understanding of the following:

- Clearwater Ministries will provide the required matching funds.
- Clearwater Ministries will execute a conditional promissory note, secured by a senior deed of trust naming the City as beneficiary for all sums which may become due upon any default of the terms of the grant.
- Clearwater Ministries will provide a letter of guarantee from the Fairbanks Rescue Mission should the organization default on any grant performance standards.

The agreement with the Alaska Department of Commerce, Community, and Economic Development will remain the same. In the event that the facility cannot remain as an emergency shelter for homeless youth for its useful life, the building can be used for a program that benefit limited clientele or the City would pay the current fair market value of the property to the grantor.
