ORDINANCE NO. 5990

AN ORDINANCE TO AMEND FGC SECTION 2-61 REGARDING THE MAYOR'S COMPENSATION

WHEREAS, the mayor's compensation is addressed in two sections of the City Charter, Section 2.3 and Section 4.1.2, as well as in FGC Section 2-61; and

WHEREAS, the city code has been unclear regarding compensatory time for the mayor, and it has been used inconsistently in the past; and

WHEREAS, the mayor's duties and compensation are outlined in the Charter, which establishes the mayor's salary and also provides that "the mayor shall receive such additional benefits and perquisites as are approved and funded by the council through its budget;" and

WHEREAS, compensatory time has not been addressed by the council in its past budgets, which has led to confusion;

NOW, THEREFORE, BE IT ENACTED BY THE CITY COUNCIL OF THE CITY OF FAIRBANKS, ALASKA:

SECTION 1. FGC Section 2-61 is amended as follows [new text in **bold/underline** font; deleted text in strikethrough font]:

Sec. 2-61. Term; salary.

The mayor's term shall be deemed to run beginning with the certification of election results. The salary of the mayor, including any additional benefits and perquisites, shall be established in the budget. This elected position will not accrue compensatory time.

SECTION 2. The effective date of this ordinance will be the 10th day of October 2015.
